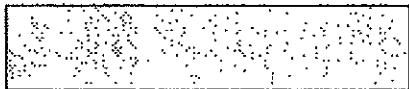

That the State Budget Officer be authorized to establish in account 014-09A-0534-08, Maine Deer Management Fund, the following position in accordance with Title 5, section 1583-A: one limited-period IF&W Resource Biologist position; and,

Be it further ordered,
that the State Controller increase allotment for the purpose of allotting a portion of the anticipated unencumbered balance forward in account 014-09A-0534-08, Maine Deer Management Fund, by \$104,258 in the Personal Services line category and by \$3,056 in the All Other line category; and,

Be it further ordered,
that the State Controller authorize the expenditure in accordance with the attached "Revision of the Work Program for Fiscal Year ending June 30, 2024", for which this shall be our sufficient warrant.

Statement of Fact

This financial order allots a portion of the anticipated unencumbered balance forward to fund one limited-period IF&W Resource Biologist position that will collaborate with regional wildlife biologists, the deer biologist, and land acquisition staff to prioritize deer habitat for potential acquisition by the Department, coordinate the management of department-owned wintering areas and associated summer habitat and provide technical assistance to private land owners on the management of deer wintering areas. Failure to approve this financial order will have a detrimental impact on the department's ability to effectively coordinate and manage the state's deer habitat. This position will start on July 1, 2023 and end on June 30, 2025.

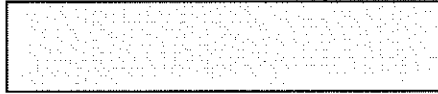

That the State Budget Officer be authorized to continue in account 014-02A-0352-01, Office of Professional and Occupational Regulation, the following position in accordance with Title 5, section 1583-A: one limited-period Public Service Executive II position; and,

Be it further ordered,
that the State Controller increase allotment in account 014-02A-0352-01, Office of Professional and Occupational Regulation, by \$169,134 in the Personal Services line category and by \$2,050 in the All Other line category for the purpose of funding one limited-period Public Service Executive II position; and,

Be it further ordered,
that the State Controller authorize the expenditure in accordance with the attached "Revision of the Work Program for Fiscal Year ending June 30, 2024", for which this shall be our sufficient warrant.

Statement of Fact

This financial order continues one limited-period Public Service Executive II position in the Office of Professional and Occupational Regulation through June 8, 2024 and allots a portion of the estimated unencumbered balance forward to fund this position for fiscal year 2023-24. This position was previously established with Financial Order 002572 F3. This position advises the agency director on emerging public policy issues, enhances the training and experience of current staff, and serves as a liaison between the director and other state officials with regulatory interests. Responsibilities include recommending public policy direction to the director as well as providing legal advice and guidance regarding interpretations of state and federal laws. Failure to allot these funds will result in the agency not being able to pay for this legal advisory position.
