


Economic Impact of Hunting + Fishing



- The most recent data from the US Fish and Wildlife shows that hunting, fishing, and wildlife watching contribute over 1.3 billion to Maine's economy.
- Maine has over 365,000 licensed anglers in the state that contribute over \$371 million to Maine's economy.
- Maine has over 229,000 licensed hunters in the state that contribute over \$230 million to Maine's economy.



Division of Wildlife



- We protect, conserve and enhance Maine's wildlife resources, including Maine's threatened and endangered species. Protect and enhance habitat for conservation and enhancement of
- Maine's wildlife resources.
- Work to develop rules for the effective management and wise use of Maine's wildlife.
- Oversee nearly 70 different Wildlife Management Areas (WMAs) that encompass 136,000 acres.
- Maine has over 229,000 licensed hunters in the State.








- Began a comprehensive reconstruction of the Fryeburg Shooting Range, which when complete will provide a modern, world-class target shooting facility that is open to the public.
- Began updating the State Wildlife Action Plan, which identifies the conservation needs for all of Maine's at-risk wildlife and their habitats across this state. This Plan is a collaboration with the other natural resource agencies and partners and will guide wildlife conservation efforts for the next 10 years.





Initiated a comprehensive survey and monitoring program to evaluate use of the Gulf of Maine by birds and bats to inform Offshore Wind Development. These efforts have resulted in some of the first information on these species in the Offshore environment.


Managed wildlife habitat and public access on approximately 136,000 acres of Wildlife Management Areas (WMAs) distributed across the state, including an additional 1,100 acres that were



Land Access

- Secured approx. \$1.5 million in grant funding for two fish passage projects.
- Assisted DOT with a \$9.3 million Wildlife Crossing Pilot Program proposal for two crossings in Caribou that will reduce wildlife-vehicle collisions and improve brook trout habitat.
- Partnered with the Governor's Office of Policy Innovation and the Future on statewide, regional, and municipal climate change planning efforts including participating in the successful \$69 million NOAA Resilient Maine grant proposal.
- Collaborated with private landowners, municipalities, and non-profit partners to integrate wildlife habitat conservation in over 700 forest management plans, over 30 municipal plans, and several land trust strategic conservation plans.
- Partnered to conserve an additional 7,400 acres.
- Awarded \$1 million from the National Coastal Wetlands Program to work with a partner land trust on a coastal restoration and resilience project in Trenton.

Division of Fisheries + Hatcheries



- We preserve and protect Maine's native fish and their habitat. • Responsible for management on over 6,000 lakes and ponds and over 30,000 miles of rivers and streams.
- Operate eight hatcheries and stock over 1,000,000 trout and salmon annually to provide opportunities to anglers of all abilities and to help maintain healthy wild populations.
- Work to ensure access to Maine's waters, including over 180 access sites. Create recreational angling opportunity and regulate commercial harvest. • Work to prevent the introduction and spread of invasive fish and fish
- diseases/pathogens.


Bureau of Warden Service



- Enforce and educate the public on hunting, fishing, trapping, boating, and recreational vehicle laws.
- Oversees all search and rescue operations in the state for all persons presumed lost, stranded, or drowned in the fields, forests, and inland waters of Maine.
- Multiple specialty teams which perform key roles including an aviation wing, dive team, airboats, K9, crash reconstruction, and resource protection.



Bureau of Warden Service: Accomplishments



- With 124 full-time officers and 8 deputies, the Maine Warden Service inspected more than 67,000 outdoor users in 2024.
- Responded to over 26,000 calls for service last year involving law enforcement and search and rescue. • Spent 16,500 hours on boating related activities inspecting watercraft and educating boaters. Focus was placed on safe boat operation, specifically imprudent
- boat operation, headway speed violations, awareness of aquatic invasive species, and boating under the influence.



Bureau of Warden Service: Landowner Relations



- Prioritizes landowner concerns to protect access for outdoor recreation and continued use of private lands for future generations.
- Two game warden corporals and two deputy wardens dedicate 100% of their time to supporting private landowners in Maine.
- Assist private landowners with concerns around property abuse, trespass, illegal dumping, and the education of user groups about landowner expectations.


Division of Licensing + Registration



- Oversees the sale and administration of approximately 480,000 licenses each year.
- Registers approximately 290,000 boats, snowmobiles, and ATVs annually.
- Generates over \$23 million in revenue annually.
- All licenses and permits are available online.
- In 2019, 43% of our customers purchased their license online. In 2020, that jumped to 61%. In 2024, 67% of licenses were purchased online.



Division of Licensing + Registration: Accomplishments



- As of January 1, 2025, all MDIFW agents will be using **MOSES to sell licenses and registrations.**
- Worked with the wildlife division to further refine the game registration system. The game registration system interfaces directly with MOSES to pull the hunter's personal info as well as their current license and permit information.




Division of Engineering: Accomplishments

- Oversaw various new construction projects including the new Maine Wildlife Park Nature Store and Admin building, Fryeburg shooting range, and hatchery reconstruction projects.







How to drive safely on privately owned forest roads

Many of Maine's dirt roads, frequently enjoyed by hunters each fall, are open thanks to private landowners and logging companies. These private entities built and maintain these roads, and generously share the roads and land with hunters, anglers, wildlife watchers, birders, and other outdoor enthusiasts. This gives outdoor enthusiasts access to thousands of acres of land, lakes and ponds, and miles of rivers. This access is an incredible gift, not a right. When hunting this fall, respect landowners and those around you:


Numbers Tell the Story



- Hunting and fishing license sales and nearly all registrations continue to grow
- Significant increase in the number of people completing hunter safety courses, up 30%
- A nearly 20% increase in the number of women hunting Increase in people applying and purchasing permits over past 5 years. Moose, deer, bear and turkey permits are all up. Increased hunter success, with the fall turkey, deer, moose, and






Fishing License Sales 6% Increase from 2018 to 2023

Hunting + Fishing License Sales: Females




