

Here is the OSR Expenditure/Balance History from the close of FY20 through the close of FY25

These are the standard caveats (it may not be complete a complete list):

- Balances are a snapshot – in this case the end of the fiscal year.
- For OSR's, picking the end of the fiscal year as a report date has far less meaning than it does for General Fund accounts
- A consistent balance doesn't, necessarily, mean that the funds aren't spent (due to timing issues)
- For any account of particular interest, OFPR could look up the current unencumbered cash balance and do other further research
- There may be unintended consequences of sweeping any particular account that only the Department in question would know.
