**Statement of Fact**

This financial order allots anticipated unencumbered balance forward to continue one limited-period Public Service Coordinator I position. This position will provide technical and policy support for the Agricultural Resource Development (ARD) program's new agricultural marketing program, and this position will work with the sustainability manager to involve Soil and Water Conservation Districts in cost-effective delivery of forestry and agricultural management practices, soil health, and drought mitigation practices to producers. This position will be the liaison between ARD, the Commissioner's Office, and other agencies to encourage regional approaches for soil conservation issues. The position began on January 8, 2018 and will end on January 3, 2020. This financial order covers the funding for fiscal year 2018-19. Failure to allot these funds will have a detrimental impact on the department by limiting its ability to facilitate this new program.





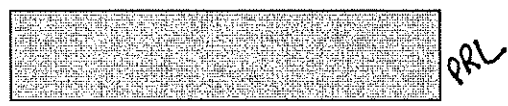

The goal of the initiative is to increase the literacy abilities of students in kindergarten through grade three in an effort to increase the number of students reading proficiently on the third grade reading assessment. This position will be funded with a transfer from All Other to Personal Services.
