The Joint Standing Committee on Judiciary met on March 26th and March 28th to consider the proposed Biennial Budget for the Department of the Attorney General, the Judicial Branch, the Maine Commission on Indigent Legal Services, the Maine Human Rights Commission, the Maine Indian Tribal-State Commission and Pine Tree Legal Assistance.

The Judiciary Committee members unanimously (with two or three members absent on some votes) agreed to support most initiatives included in the Budget. This memo explains the <u>non-unanimous</u> votes and the additional initiatives the Judiciary Committee supports, as well as providing comments on two initiatives.

## Maine Human Rights Commission

The Judiciary Committee divided on the following initiatives:

#1214 (page 31) Vote: 8-4, 1 absent; majority in support of initiative, minority supports only one additional investigator position

#1216 (page 32) Vote: 8-4, 1 absent; majority in support of initiative

#1217 (page 32) Vote: 10-2, 1 absent; majority in support of initiative

The majority of the Judiciary Committee supports capping the Attrition applicable to the Maine Human Rights Commission to a maximum of 1.6% (current attrition rate). As a small agency with few employees, the Commission has a hard time meeting the 5% attrition rate proposed in the Budget, as the 5% would eliminate the All Other funds if the Commission had no vacancies on which to save money.

The minority of the Judiciary Committee supports exempting the Commission completely from the application of the attrition rate.

Vote: 11-1, 1 absent

The majority of the Judiciary Committee supports capping the Statewide Cost Allocation Plan (STACAP) applicable to the Commission at 4%. The mediation and seminar Other Special Revenue accounts are straight pass-through of fees paid by participants to providers. In addition, approximately 40% of the personnel costs of the Commission are paid from federal funds — which are subject to STACAP — based on the partnership between the Commission and the federal EEOC and HUD.

The minority of the Judiciary Committee supports exempting the Commission completely from STACAP.

## Maine Indian Tribal-State Commission

The Budget includes no new initiatives for the Maine Indian Tribal-State Commission, but the Judiciary Committee voted anyway to unanimously support the baseline.

In addition, a majority of those in attendance voted to provide an additional \$20,000 for each year of the biennium, recognizing the increase in the Commission's activities as the Statemember vacancies are filled and the Commission takes on more responsibilities.

## Maine Commission on Indigent Legal Services

The Judiciary Committee unanimously supports the proposed budget as well as an additional initiative to fully fund the All Other account at the same level as the past fiscal year. This requires additional General Fund funding of \$2,746,980 in each year of the biennium. These funds are to be considered ongoing, and should be included in the baseline budget for the Commission going forward.

Notwithstanding any provision of In addition to the cost of living adjustment required in the Maine Revised Statutes, Title 4, effective July 1, 2019 and July 1, 2020, the State Court Administrator shall increase the salaries of the State's Chief Justices, Chief Judge, Deputy Chief Judge, Associate Justices, and Associate Judges, by 5% in total. The 2% costs above the 3% cost of living adjustment required in Maine Revised Statutes, Title 4, section 4, subsection 2 A, shall which must be provided in the Salary Plan program, General Fund account in the Department of Administrative and Financial Services in the amount up to \$258,544 for the fiscal year ending June 30, 2020 and in the amount up to \$522,592 for the fiscal year ending June 30, 2021.

## Comments

#2015 (page 49): Although the Judiciary Committee supports the payment of the increased Forensic Service examiner rates, the members are not pleased about the increase and do not believe this is an appropriate expense to be in the Judicial Branch's budget. (The Committee

also supports the additional psychological exam costs in #2006, which result from more exams being required, but has the same concern about this cost being in the Judicial Branch's budget when it should more appropriately be part of the DHHS budget, as the State Forensic Service is part of DHHS.)

#2026 (page 52) Senator Carpenter abstained from voting.

## Pine Tree Legal Assistance

The Budget includes no new initiatives for Pine Tree Legal Assistance, but the Judiciary Committee voted anyway to unanimously support the baseline.

In addition, the Judiciary Committee unanimously supports an additional \$150,000 for each year of the biennium for Pine Tree Legal Assistance to continue its project serving the legal needs of veterans receiving medical treatment through Togus VAMC or the local CBOCs (via Tele-Health technology). A Maine foundation helped launch the program in 2015 at a funding level that supported two attorneys; current funding only supports a part-time attorney and ends in 2019.

#### Justification:

The Attorney General is the chief legal officer for the state. All litigation involving the State must be prosecuted or defended under the direction of the Attorney General unless the Attorney General otherwise approves in writing. The Office (a) appears in all civil actions and proceedings in which the State is a party; (b) directs the investigation and prosecution of homicides and other major crimes, including major drug cases and frauds against the State; (c) renders legal services to State officers, boards and commissions in matters relating to their official duties; (d) issues written opinions upon questions of law submitted pursuant to statute; (e) administers and enforces the State's unfair trade practices and antitrust laws; (f) enforces proper application of endowments to public trusts and charities; and (g) consults with and advises the District Attorneys.

The Attorney General also serves as an ex-officio member on many State authorities and Commissions.

The Office of the Attorney General is organized by 5 M.R.S.A. Section 191 with the Attorney General as its chief executive. The Office includes the following divisions:

The Consumer Protection Division enforces state antitrust and consumer protection laws, the state merger statute and the Unfair Trade Practices Act. The Division also discharges the Attorney General's mandate to oversee charities and is responsible for the investigation and prosecution of the unauthorized practice of law. The Consumer Mediation Program uses trained volunteers to mediate consumer complaints, and the Lemon Law Arbitration Program administers the State's lemon law.

The Criminal Division has exclusive responsibility for the prosecution of homicide cases, handles numerous criminal appeals to the Supreme Judicial Court, advises the District Attorneys, and prosecutes major drug cases across the State; prosecutes white collar and financial crimes, welfare fraud, Medicaid fraud, computer crimes, tax crimes, and securities violations; and brings enforcement actions under the Maine Civil Rights Act.

The Investigation Division investigates fraud against the State and provides direct investigative services for other divisions in the Department. The Division is responsible for investigating police-involved fatalities, certain crimes against public officials, hate crimes, and financial exploitation of elders. The Division serves as a resource for other law enforcement agencies, participates in law enforcement training and conducts investigations for the Medical Board, the Osteopathic Board and the Tobacco and Substance Abuse programs.

Three divisions represent the offices within the Department of Health and Human Services (DHHS). The Child Protection Division represents the State in child protection matters. The Child Support Division represents the State in child support enforcement matters. The Health and Human Services Division represents all other offices within DHHS in complex litigation in state and federal courts, in contract and rule review, in administrative hearings and in providing routine legal advice. The Division provides legal advice regarding a variety of topics including MaineCare, adult protection, guardianship, mental health, physical health, rules, contracts, licensing, and public benefit programs. The Division also represents DHHS in enforcement actions designed to protect public health and safety.

The Professional and Financial Regulation Division represents the Department of Professional & Financial Regulation, which includes the Bureaus of Insurance, Financial Institutions and Consumer Credit Protection, the Office of Securities and numerous professional and occupational licensing boards. It also represents the Property Tax Review Board and liquor and lottery regulation within the Department of Administrative and Financial Services.

The Natural Resources Division provides comprehensive legal services to the State's environmental and natural

#### Justification:

This initiative provides funding for one Research Assistant MSEA-A position to perform advanced office and administrative work related to archiving, database management and backup constituent contact. This position's primary responsibility will be the identification and protection of the essential records of the Office of the Attorney General. The position will be the coordinator of all record retention efforts and will be tasked with updating internal policy, ensuring compliance with records management requirements, organizing paper and electronic storage and retrieval systems with appropriate labeling, as well as liaison with State Archives. This effort is of particular importance as Courts move to electronic filings. Additionally, this position will review, organize and update the various tracking databases and will provide backup coverage for constituent calls. The current staff is insufficient to meet the current demands related to these efforts.

#### Justification:

This initiative provides funding for one Attorney General Detective position in the Office of the Attorney General that will investigate selected major cases of elder financial exploitation. The position will also train other law enforcement personnel to investigate similar cases. Financial exploitation involves the use of deception, intimidation, undue influence, force or other unlawful means to obtain control over the property of an elder or dependent adult for another's profit or advantage. The US Department of Justice estimates that 1 in 9 people over the age of 60 will be abused or exploited each year. This position was recommended by the Maine Attorney General's Task Force on Financial Exploitation of the Elderly.

#### Justification:

Consumer contacts to the Consumer Protection Division have increased significantly over the years, from 6,874 in 2012 to more than 12,000 in 2017. As consumers become savvier about their rights and look to hold businesses accountable for the quality of the products they purchase, this Division will continue to receive an increasing number of complaints, which lead to investigations.

The Research Assistant Investigator position will find and interview witnesses, talk to consumers, locate assets, attend sales presentations, purchase products, subpoena phone records and examine computers - all as part of researching consumer complaints. Failure to create this position hinders the ability to investigate and prosecute businesses that engage in misleading and deceptive practices that harm consumers and violate the law. As consumer awareness increases, people will look to this Division to protect them based on the law. Increased complaints exceed the Division's existing resources, especially the need for investigations to identify and support cases that are appropriate for enforcement. The increased workload with no increase in staff hampers the ability to protect Maine consumers proactively and to enforce the consumer protection laws of the state. The Division will not be able to handle increases in complaints and investigations to the Division without additional staff.

#### Justification:

This initiative requests funding for one Secretary Legal position dedicated to the Consumer Protection Division. Funding comes from the Consumer AntiTrust account. The Consumer Division includes consumer complaints, tobacco enforcement, collections of monies due the State, antitrust, and legal efforts against inappropriate business transactions. Work has increased with no increase in support staff; currently this busy Division has just one secretary position covering all administrative efforts for the 13 staff members. The collections practice is very notification and form intensive requiring significant effort tracking, filing and ensuring timely responses and follow up. New state law requires that data breach notices be filed with this Division. This requires the maintenance of an organized database and prompt response to requests to the public as we receive frequent Freedom of Information Act requests for these documents. In addition, contacts to the Consumer Protection Division have increased significantly over the years, from 6,874 to more than 12,000 in 2017, which requires more follow up, tracking, written correspondence, and timely communications with consumers. Failure to fund this position will put at risk the Division's ability to respond, communicate, and serve thousands of consumers and will hinder the ability to take timely and effective action on collection efforts.

#### Justification:

Consumer contacts to the Consumer Protection Division have increased significantly in recent years. In 2012 the Division received 6,874 consumer contacts; in 2017, more than 12,000. As consumers become savvier about their rights and continue to hold businesses to legal standards as a result of the products they purchase this office will continue to see an increase in phone calls, emails, walk-ins and letters from consumers seeking assistance.

Specifically, the Assistant Complaint Examiner (ACE) position is responsible for: answering the consumer hotline which is staffed from 9-4 daily; responding to consumer emails; sorting and responding to incoming mail; assisting the 25 volunteer mediators; explaining to consumers how to complete the complaint forms for mediation; and gathering data as needed from the database for pending enforcement actions. All of these tasks can vary in time and effort depending on

the consumer and whether additional research is warranted. If the additional hours are not authorized, the Division may need to consider limiting the hours of the hotline, hampering timely responses to citizens and creating increased consumer frustration with the inability to bring more enforcement actions. Failure to fund this position will limit the Division's ability to respond, communicate, and serve thousands of consumers.

The Office of the Attorney General's Litigation Division's responsibilities include handling complex civil litigation involving the State or its officials in suits involving money damages, injunctive or declaratory relief and in suits challenging the constitutionality of Maine law. The Litigation Division has also increased its role in providing litigation consultation and guidance to attorneys in other Divisions in the Office on more complex litigation matters. The new position will handle the increased number of complex civil litigation matters, including civil rights claims, discrimination claims, employment claims, constitutional claims, freedom of access claims, election litigation, contract litigation, and electronic discovery issues. The current staff is insufficient to meet the increased demand within the Litigation Division.

## Justification:

This initiative provides funding for a Research Assistant - Paralegal position dedicated to Litigation. The Office of the Attorney General's Litigation Division's responsibilities include handling complex civil litigation involving the State or its officials in suits involving money damages, injunctive or declaratory relief, opinions of the justices, freedom of access suits, and in suits challenging the constitutionality of Maine law. The Litigation Division has also increased its role in providing litigation support and guidance to attorneys in other Divisions in the Office on more complex litigation matters as both the number and complexity of litigation matters has increased across the Office. These cases can be document intensive, including electronic records. The complexity of preserving, retrieving, organizing, producing and preparing

evidence for discovery and trial has evolved in recent years due to the rapid growth of electronic files. In addition, in recent years, there has been increased litigation requiring extensive historical research and a need to compile and organize this historical information. The current staff is insufficient to meet the demand within the Litigation Division. Due to the increased workload in the Litigation Division, the need for this position has been longstanding.

#### Justification:

The Office of the Attorney General's Professional and Financial Regulation Division's responsibilities include providing legal support to the more than 40 professional licensing boards and programs within and affiliated with the Department of Professional and Financial Regulation. This work includes investigating and prosecuting disciplinary complaints against licensed professionals, providing legal analysis and opinions on regulatory matters, performing agency rule review, defending agency decisions on appeal to the Superior Court, and enforcing agency orders in court. This Assistant Attorney General position is needed to address the increase in complaint activity and the increased complexity of the cases.

Failure to fund this position will negatively impact the division's ability to provide the level of legal services required for Maine's professional licensing boards to timely and effectively regulate their professions. A professional licensing board's ability to conduct thorough investigations and impose appropriate discipline requires its legal counsel to prosecute cases and defend decisions. When adequate legal services are not available, boards may be forced to compromise on investigative efforts and/or terms of settlement, which translates to less protection of the public's health and welfare.

## Justification:

This initiative provides funding for one Assistant Attorney General position in the Criminal Division of the Office of the Attorney General to prosecute financial crimes involving elder financial exploitation cases, homicides, and other major cases within the criminal division. Financial Crime, specifically elder exploitation, is on the rise and prosecution is time intensive. Additionally, if the Elder Abuse Attorney General Detective position is authorized more cases will be uncovered. There is currently one prosecutor in the Criminal Division assigned to these crimes, which is not sufficient to keep up with current or increasing caseloads.

There are only four full-time homicide prosecutors in the Criminal Division. The number and complexity of homicide cases is increasing at an alarming rate. The state is seeing an increase in the number of drug related homicides. Each case has complex cell phone, Facebook, Instagram and other social media information as well as thousands of pages of investigative material that must be reviewed, understood, and organized for presentation at trial. Despite the increase in the complexity and number of cases as well as the need to put two attorneys on each case, the number of attorneys assigned to homicide cases has not increased in years. Failure to fund this position puts at risk the ability to protect Maine's elderly and respond appropriately to violent crime.

#### Justification:

Historically, the eight District Attorneys' offices handle approximately 90,000 criminal and juvenile cases per year, as well as thousands of traffic and civil violations. They prosecute the majority of all criminal offenses occurring in their district, with the exception of murder. This caseload is carried statewide with a staff of 97 Assistant District Attorneys and 8 elected District Attorneys. When traffic infractions and civil violations are factored in, as well as probation revocations, appeals to the Law Court, and other cases, each Assistant District Attorney handles very high caseloads.

The District Attorneys' offices draft warrants, review police reports, screen criminal cases, prepare criminal complaints, motions, memoranda of law, legal briefs and other pleadings. They present felony cases to grand juries, argue motions, meet with police officers, witnesses and victims and try cases in District and Superior Courts. The District Attorney offices also provide training and continuing legal education to law enforcement agencies in their districts.

The Office of Child and Family Services is increasing staffing, which results in corresponding increases in child protection case filings. In addition, there has been an increase in the tasks performed by

support staff; however, there has not been a corresponding increase in support staff. Currently, the Portland office has 7 Child Protection Assistant Attorneys General (AAG), 2 Child Support AAGs and 1 general HHS AAG. The Portland office handles 586 active child protection cases and 255 active child support cases, as well as a significant number of mental health commitment hearings and other work for DHHS. Currently, the Bangor office has 6.5 Child Protection AAGs and 1.5 Child Support AAGs. The Bangor office handles 518 active child protection cases and 244 active child support cases. This type of litigation is expedited and high volume. #### Justification:

Since 1967, Pine Tree Legal Assistance has provided free individual legal services to low-income Maine residents with serious civil legal problems. It handles cases that are not eligible for court-appointed counsel through the Maine Indigent Legal Defense Commission. Legal help is provided through a statewide call center, a network of local field offices (Portland, Lewiston, Augusta, Bangor, Machias and Presque Isle) and several statewide projects (serving victims of sexual assault, veterans, Native Americans, low-income children, and homeowners at risk of foreclosure). In addition to enforcing legal protections on behalf of individual clients, a November 2016 report has detailed significant economic impact to the State from this work.

Pine Tree Legal Assistance is recognized on a national basis for the quality of its legal work and the efficiency with which it delivers services. Three program websites (www.ptla.org and www.kidslegal.org for Maine residents and www.statesidelegal.org for veterans and military families nationwide) provide access to user-friendly explanations of the law, court forms and other self-help tools. In CY 2017, Pine Tree handled more than 7,700 cases and its websites were used by more than 2.2 million people.

Unrestricted general funding has steadily declined, although it is essential in allowing Pine Tree to focus legal services on the needs of local residents throughout the State. Pine Tree's current State Appropriation of \$500,000/year is one of the largest single sources of general funding and currently represents almost a quarter of CY2018 general funds. The State Appropriation is also essential as a source of matching funds for other federal and foundation grants that can expand access to legal services around the State.

## PART LL

Sec. LL-1. 22 MRSA §3023-A, as enacted by PL 2013, c. 113, §2 is amended to read:

The Chief Medical Examiner may appoint persons who are physicians as medicolegal death investigators, who have statewide jurisdiction and serve at the pleasure of the Chief Medical Examiner, subject to the Chief Medical Examiner's control and rules adopted by the Chief Medical Examiner. Medicolegal death investigators must meet the certification and training requirements established by the Chief Medical Examiner and must be residents of this State. Medicolegal death investigators may be employees of the Office of the Chief Medical Examiner or serve on a fee-for-service basis as determined by the Chief Medical Examiner. A medicolegal death investigator before entering upon the duties of the office must be duly sworn to the faithful performance of the medicolegal death investigator's duty.

Training Program. The Chief Medical Examiner may implement a training program to enhance the technical and oversight expertise of the Office of the Chief Medical Examiner and Medicolegal Death Investigator I positions. Employees in the Medicolegal Death Investigator I classification who participate in the training and education program and who demonstrate that they have achieved competencies prescribed by the Chief Medical Examiner may progress immediately to the senior position in this classification series.

# PART LL SUMMARY

This Part gives the Chief Medical Examiner authority to progress immediately a Medicolegal Death Investigator I (MLDI I) to Medicolegal Death Investigator II provided the MLDI I demonstrates competencies and training for the higher classification.

## **PART NNN**

Sec. NNN-1. Judicial Salary adjustment. Notwithstanding any provision of the Maine Revised Statutes, Title 4, effective July 1, 2019 and July 1, 2020, the State Court Administrator shall increase the salaries of the State's Chief Justices, Chief Judge, Deputy Chief Judge, Associate Justices, and Associate Judges, by 5% in total. The 2% costs above the 3% cost-of-living adjustment required in Maine Revised Statutes, Title 4, section 4, subsection 2-A, shall be provided in the Salary Plan program, General Fund account in the Department of Administrative and Financial Services in the amount up to \$258,544 for the fiscal year ending June 30, 2020 and in the amount up to \$522,592 for the fiscal year ending June 30, 2021.

This Part provides for a raise of 5% for judges and justices of the state courts in fiscal years 2019-20 and 2020-21.
