This financial order provides funding in fiscal year 2019-20 to continue a limited-period position previously established by Financial Order 000125 F9 in fiscal year 2018-19. The position began on May 6, 2019 and will end on April 30, 2021. The position works implementing scientific and restoration projects focused on native diadromous or Sea-Run species in Maine. The primary responsibilities of this position are to oversee and implement a new adult salmon stocking program, monitor its efficacy in an adaptive framework and assist others in monitoring diadromous fish populations statewide by recruiting, training, and supporting citizen scientists to monitor selected species in their local rivers and streams. Failure to approve this order will have a negative impact on restoration of salmon and sea-run species of recreational, ecological, cultural, and commercial importance.
