Be it ordered,

that the State Controller increase allotment in account 014-16A-Z073-01, Uniform Building Codes and Standards Fund, by \$71,716 in the Personal Services line category and by \$1,285 in the All Other line category for the purpose of funding one Public Safety Inspector III position and related All Other; and,

Be it further ordered,

that the State Controller authorize the expenditure in accordance with the attached "Revision of the Work Program for Fiscal Year ending June 30, 2020", for which this shall be our sufficient warrant.

Statement of Fact

This order will establish one limited-period Public Safety Inspector III position in the Uniform Building Codes and Standards Fund starting August 19, 2019 and ending June 13, 2020. The existing resources are sufficient to fund this additional position. The revenue in this account is derived from a surcharge on building permits. This position is needed to plan and coordinate trainings for code enforcement officials. Responsibilities will include facilitating and providing specific training across the state to ensure that all code enforcement officials have access to the necessary trainings, specifically the 12 areas of training required for certification. In addition, this position will be undertaking the rule making process to adopt the codes and standards as required by statute and will field all technical questions pertaining to the Maine Uniform Building and Energy Code and. Failure to approve this financial order will result in the suspension of the code enforcement training program and the inability of the Maine Uniform Building and Energy Code Board to meet statutory obligations.
