Statement of Fact

This financial order provides allotment to purchase vaccines for children not covered by the federal Vaccines for Children program. A model uses demographic and dosage cost factors in predicting annual costs to the Maine Immunization Program. The demand for dosage is seasonal and additional funding to meet the demand for higher dosage for return to school and flu season is required. Revenue is derived from an assessment from health insurance payers in Maine and collected by the Maine Vaccine Board. Failure to approve this financial order will not allow essential vaccinations to be purchased at a critical point in the calendar year.
