Findings could provide information that would improve predictability for the fishery, in such ways as achieving a better understanding of the expected timing of molt, catch and volume of landings. Funding is received from lobster special registration plate fees. Failure to approve this financial order will have a detrimental impact on further development support for the lobster industry.

This technology is needed as paper logbooks are no longer cost effective due to the increase in staffing costs for entry, printing and mailing costs. Also, management needs to have data more timely. Failure to allot these funds will cause a detrimental impact on the ability to create an electronic program for harvesters to provide timely reporting and the department would be out of compliance with the ASMFC lobster reporting requirements.
