Justification:

The Aquaculture Program supports and regulates a growing industry farming marine species, on land and within the coastal waters of Maine. Aquaculture is an important contributor to Maine's marine resource economy, contributing over \$70M in direct revenue in 2018. DMR has invested heavily in this program, doubling its staff since 2012 to meet the demand of industry growth, but the department cannot continue to support the cost. Several accounts within the department support this program but are projected to have shortfalls themselves in the next two years.
