The purpose of this financial order is to provide funding to purchase a second Liquid Chromatography/Mass Spectrometry instrument for the Health and Environmental Testing Laboratory (HETL) to test operating under the influence (OUI) related toxicology samples for the presence of drugs. Over the last few years, there has been an increase in drug sample submissions as well as an increase in the number of drugs detected in each sample, including various opioids such as heroin metabolites, codeine and fentanyl. HETL performs toxicology testing for law enforcement agencies and the court system. Purchasing this additional laboratory instrument will speed up the processing time of samples reducing the backlog that causes cases to be halted. Funding for this equipment is from the Public Health Emergency Response grant. Funds are no longer needed in the All Other line category due to a decrease in the need for contracts.
