Amend the resolve by striking out everything after the title and inserting the following:

Sec. 1. Department of Health and Human Services to increase MaineCare rates. Resolved: That the Department of Health and Human Services shall amend its rule Chapter 101: MaineCare Benefits Manual, Chapter III, Section 45.03 to provide reimbursement for patients discharged from Southern Maine Health Care's psychiatric inpatient unit in the amount of \$10,166 per distinct discharge beginning on the effective date of this section. No later than 30 days following the effective date of this section, the department shall amend its rule pursuant to this section and submit the amended rule to the United States Department of Health and Human Services, Centers for Medicare and Medicaid Services.

Sec. 2. Department of Health and Human Services to seek available funds for uninsured patients. Resolved: That the Department of Health and Human Services shall seek and apply for available federal funds or funds from any other sources to pay the costs of providing inpatient psychiatric care to uninsured patients who are discharged from acute care hospitals.

Sec. 3. Report. Resolved: That, no later than January 15, 2022, the Department of Health and Human Services shall submit a report to the joint standing committee of the Legislature having jurisdiction over health and human services matters regarding the progress the department has made in developing a reimbursement rate to provide inpatient psychiatric care under its rule Chapter 101: MaineCare Benefits Manual, Chapter III, Section 45.03. The joint standing committee of the Legislature having jurisdiction over health and human services matters is authorized to report out legislation related to the report to the Second Regular Session of the 130th Legislature.

Sec. 4. Appropriations and allocations. Resolved: That the following appropriations and allocations are made.

Sec. 1. Department of Health and Human Services to increase MaineCare rates. Resolved: That the Department of Health and Human Services shall amend its rule Chapter 101: MaineCare Benefits Manual, Chapter III, Section 45.03 to provide reimbursement for patients discharged from Southern Maine Health Care's psychiatric inpatient unit in the amount of \$10,166 per distinct discharge for the period beginning with the effective date of this section and ending January 15, 2023. No later than 30 days following the effective date of this section, the department shall amend its rule pursuant to this section and submit the amended rule to the United States Department of Health and Human Services, Centers for Medicare and Medicaid Services.

Sec. 2. Department of Health and Human Services to seek available funds for uninsured patients. Resolved: That the Department of Health and Human Services shall seek and apply for available federal funds or funds from any other sources to pay the costs of providing inpatient psychiatric care to uninsured patients who are discharged from acute care hospitals.

Sec. 3. Report. Resolved: That, no later than January 15, 2022, the Department of Health and Human Services shall submit a report to the joint standing committee of the Legislature having jurisdiction over health and human services matters regarding the progress the department has made in developing a reimbursement rate to provide inpatient psychiatric care under its rule Chapter 101: MaineCare Benefits Manual, Chapter III, Section 45.03. The joint standing committee of the Legislature having jurisdiction over health and human services matters is authorized to report out legislation related to the report to the Second Regular Session of the 130th Legislature.

The amendment directs the Department of Health and Human Services to seek and apply for federal funds and funds from any other sources to pay the costs of providing psychiatric services to uninsured patients. The amendment also directs the Department of Health and Human Services to submit a report to the joint standing committee of the Legislature having jurisdiction over health and human services matters regarding the progress the department has made in developing a reimbursement rate to provide inpatient psychiatric care under its rule Chapter 101: MaineCare Benefits Manual, Chapter III, Section 45.03. The committee is authorized to report out legislation related to the report to the Second Regular Session of the 130th Legislature. This amendment includes a provision to repeal the resolve January 15, 2022.
