There are damaged tiles on walls and floors in all patient bathrooms. Flooding of the facility due to ground water leakage from the parking lot has occurred. Significant repairs are needed to stop the parking lot from flooding and damaging the building. Failure to allot these funds will result in the hospital being out of compliance with Centers for Medicare and Medicaid Services, necessary building repairs will not be completed, and utility invoices will not be paid.
