

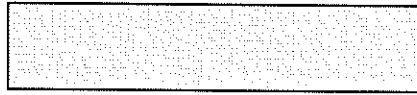

Statement of Fact

This financial order increases allotment for lobster trap tags. Fees have increased for printing lobster trap tags from \$.05 per tag to \$.12. The department issues three million lobster tags annually. Failure to allot these funds will have a detrimental impact on the department's ability to provide lobster tags to the lobster industry.
