Dear Mr. Gerard, Ms. Nixon, Senator Chipman, Representative Terry and members of the Taxation Committee:

Title 36 A §5219-VV directs the Department of Economic and Community Development to submit to the State Tax Assessor, the Office of Program Evaluation and Government Accountability, and the joint standing committee of the legislature with jurisdiction over tax matters a copy of the annual report submitted by an applicant certified under the Major Food Processing and Manufacturing Facility Expansion program. Certified applicants are required to submit their annual report to DECD by March 1st.

At this time, Penobscot McCrum, LLC is the only applicant certified under the Major Food Processing and Manufacturing Facility Expansion program and submitted their report to DECD on March 4, 2021.

The following information is required to be provided in that report:

- Number of full-time employees based in the State of Maine as of December 31, 2020;
- Incremental amount of qualified investment made during CY2020;

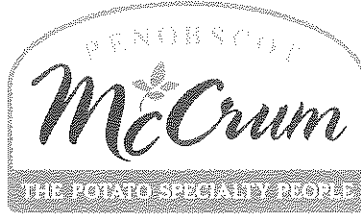

Per your request I am sending you this letter and supporting documents to serve as Penobscot McCrum LLC's annual report for the Major Food Processing and Manufacturing Facility Expansion Program. As of December 31st, 2020 Penobscot McCrum and its related companies had 207 employees based in the State of Maine, which is a net increase of 34 employees above our base employment number of 173, and 38 of those employees work in new positions at the food manufacturing facility in Washburn, Maine. The amount of incremental qualified investment as of December 31st, 2020 was \$36,447,446 for the building/land improvements and \$37,407,272 for equipment. The total incremental qualified investment for both the building/land improvements and equipment was \$73,854,718. Please contact me with any questions or concerns that you have.
