Additionally, the impact of COVID-19, cyber-attacks and catastrophes have created globally volatile insurance markets with premiums increasing at historically high rates. Failure to allot these funds can result in the agency's inability to pay settlement claims quickly or meet costs of premiums.

According to Title 22, Part 3, chapter 252, §1319-D, a blood sample taken from a child by a health care provider or laboratory to test for blood lead level must be sent to the Maine Health and Environmental Testing Laboratory (HETL) or a department approved facility for analysis. Currently, HETL has only one working blood lead machine. The new machine is needed in anticipation of an increased volume of blood samples that will be sent to HETL by health care providers. Magellan Diagnostics is recalling lead tests due to a significant risk of falsely low results throughout the United States. With only one working blood lead machine, HETL will not be able to process the anticipated amount of samples expected to be received. The reduction in the All Other expenditure line category will not cause a shortfall in the account as funds will be managed within existing resources.
