**Statement of Fact**

This financial order establishes two limited-period Regional Education Representative positions that will serve as school nursing experts beginning on January 10, 2022 and ending on January 13, 2023. These positions will provide general COVID-19 related technical assistance in all regions of the State including answering questions related to federal and state guidance and/or requirements; personal protective equipment use and procurement; providing technical assistance in setting up school located vaccine clinics for influenza and COVID-19; COVID-19 school testing partnerships and plans; pooled testing resources; and other COVID-19 specific assistance to the School Nurse Consultant as needed. The positions will supplement and assist the School Nurse Consultant in all school health services work in all regions of the State as needed due to the increased workload caused by COVID-19. These positions will be funded by the American Rescue Plan - Elementary and Secondary School Emergency Relief Fund grant (CFDA #84.425U) received through American Rescue Plan (ARP) Act.
