The Salmon for Maine's Rivers program is expected to stimulate recovery and provide the public an opportunity to experience the scale and grandeur of a biologically relevant number of adult Atlantic salmon in the wild. Failure to approve this order will result in the Department's inability to complete this supplemental environmental project.
