Public Law Chapter 432, An Act to Amend the Laws Governing the Substance Use Disorders Services Commission and approved by the Governor on June 20, 2019. It states that the purpose of the commission is to serve as advocate; review and evaluate; inform the public. The commission shall serve as an advocate and resource for the State on substance use disorder intervention, prevention, treatment and recovery. The commission shall promote and assess activities designed to meet and remediate challenges of substance use disorder in the State. With the support of the department, the commission shall review and evaluate on a continuing basis state and federal policies and programs relating to substance use disorder. In cooperation with the department, the commission shall keep the public informed by collecting and disseminating information, by conducting or commissioning studies and publishing the results of those studies, by issuing publications and reports and by providing public forums, including conferences and workshops. The commission, based on its activities pursuant to this subsection, shall make recommendations relating to substance use disorder to the department and the Governor.

During FY 2021-22, the primary achievement for the Commission was simply to have itself officially seated and appointed by the Governor, President of the Senate, and Speaker of the House of Representatives. The first official meeting of the Commission did not occur until July 2022. The delays in final appointment resulted from the backlog caused by Covid 19, but in the interim, the Acting Commission gathered monthly reports from the Office of Behavioral Health, Center for Disease Prevention, and from the Director of Opioid Response.

In May, pending final appointment, the Commission determined to replicate the "Report Card on OBH" that was done in 2010. Since 2010, the landscape and profile of substance use disorders has dramatically changed and continues to change. When the organizing statute for the Commission was signed June 20, 2019, the acting Commission had been reorganized into the four pillars of prevention, intervention/harm reduction, treatment, and recovery. This is consistent with other State substance use-related initiatives such as the Governor's Opioid Strategic Plan. It should be noted that when this Report Card was last done in 2010, two of those pillars, Intervention/Harm Reduction, and Recovery, did not exist. Furthermore, these

pillars give the false impression of silos, when in fact the boundaries between these pillars are loose and permeable, often interdependent upon each other,

The Report Card process itself has involved developing benchmarks within the four pillars related to the original Report Card's four evaluation criteria: Leadership, Structure and Sustainability; Resources; Legislative Activities; and Measurement and Accountability.

The Commission dedicated portions of its monthly agenda to serve as Work Sessions for the Report Card Project. By the end of the calendar year, the Commission had developed draft outcomes to serve as benchmarks for evaluation. Committees led by the Commission members will spend the first quarter of 2023 engaging members of OBH and other stakeholders to ensure wider diversity and inclusion in developing the final benchmarks for evaluation. In March, the Commission will consolidate the entire Report Card for evaluation during April. In May, the results of the Report Card should be available. It will be the first official product of the Commission since it was appointed.

The goal will be to use the Report Card and its recommendations in our 2023 Annual Report to the Governor, Health and Humans Services Committee, the Commissioner of DHHS and the Director of OBH.
