#### JOINT RESOLUTION HONORING THE LIFE OF JUDITH HEUMANN

WHEREAS, Judith "Judy" Heumann, widely regarded as the mother of the disability rights movement, died in Washington, D.C. on March 4, 2023; and

WHEREAS, Ms. Heumann contracted polio in 1949, when she was 18 months old, and lived her life in a wheelchair; and

WHEREAS, Ms. Heumann's parents refused to institutionalize her, instead fighting discriminatory policies and securing her a place in public school classrooms; and

WHEREAS, as a young woman, Ms. Heumann continued that fight, earning a bachelor of arts degree from Long Island University, and after winning a discrimination suit against the New York Board of Education, becoming the first teacher in the state to use a wheelchair; and

WHEREAS, Ms. Heumann put herself at the forefront of major disability rights demonstrations, advocating for the rights of persons with disabilities, and became an organizer, cofounding the protest group Disabled in Action; and

WHEREAS, Ms. Heumann worked to create support for the federal Rehabilitation Act of 1973 and later was a leader in the effort to force the Carter administration to implement Section 504 of that Act, which specifies that no government agency or private business that accepts federal funds may discriminate against someone on the basis of disability; and

WHEREAS, Section 504 became the model for the federal Americans with Disabilities Act of 1990, and Ms. Heumann was a leader in the effort to pass that legislation; and

WHEREAS, Ms. Heumann founded national and international disability advocacy organizations and served her country as an Assistant Secretary of Education in the Clinton administration, overseeing the nation's federal education programs for students with disabilities; and

WHEREAS, during the Obama administration, Ms. Heumann worked in the State Department, advocating for civil rights across the world, and 181 countries passed disability civil rights modeled after the federal Americans with Disabilities Act of 1990 between 2000 and 2015; and

WHEREAS, she coauthored her memoir, "Being Heumann: An Unrepentant Memoir of a Disability Rights Activist," and its young adult version, "Rolling Warrior: The Incredible, Sometimes Awkward, True Story of a Rebel Girl on Wheels Who Helped Spark a Revolution," and was featured in the Oscar-nominated documentary film "Crip Camp: A Disability Revolution"; now, therefore, be it

RESOLVED: That We, the members of the One Hundred and Thirty-first Legislature now assembled in the First Special Session, take this occasion to recognize the life of Judith Heumann, whose life's work helped to improve the lives of millions of Americans and who led a reimagining of what it means to be disabled in this country and across the world.

**READ.**

The SPEAKER: The Chair recognizes the Representative from Biddeford, Representative Sheehan.

Representative **SHEEHAN**: Thank you, Madam Speaker. Madam Speaker and dear colleagues, I rise today to share my gratitude for the life and work of Judy Heumann, who died on March 24th after spending her life fighting for the rights of disabled people to participate fully in the lives of their communities and in the advancement of American democracy. In doing so, she helped build a better world for us all. Days after her death, I watched along as her synagogue and friends convened for her memorial services. The words of her rabbis resonated deeply with me. Rabbi Sara Krinsky was transformed by Judy's work, observing that, quote, it is not at all hyperbolic to say that each of us would simply not be the same rabbis we are today without Judy in our lives. What we say in sacred spaces, what we think, what we believe, how we move through the world, how we construct the worlds that we all move through from the pulpit and at home, all of it is influenced by her spirit, her courage and her love.

Although I did not know Judy, her words of encouragement and admonition have shaped the way that I do my work, in my business decisions and here in the State House. But Judy's legacy lives on most powerfully in the work of self-advocates around the country and here in Maine. In remembering the genesis of the Disability Rights Movement in America, Bob Williams remembered how his and Judy's families instilled in them, quote, the sense that the justice we seek will only come about through our own making, our own taking and our own hard work. We grew up during an era of extreme exclusion, segregation and degradation. There was no way around it or to escape all the discriminatory and often hideous harm those times unleashed. But because of our parents, our families and

the civil rights and social justice movements going on around us, we increasingly realized we were not the problem. We were the people who had the drive, the change needed to solve it. Madam Speaker, speaking up for us is a statewide network of self-advocates. Members from Aroostook County all the way down through York have come to the State House today with advocates from Disability Rights Maine to connect with their Representatives. Colleagues, please join me in welcoming them, listening to their visions of the way life should be and working together to fulfill that promise. Thank you.

The SPEAKER: The Chair recognizes the Representative from Bar Harbor, Representative Williams.

Representative **WILLIAMS**: Thank you, Madam Speaker. I'll be brief. I went to law school because Judy Heumann recommended to me that I go to law school. I was in San Francisco, I was a disability rights activist, I am the mother of a son who is hearing impaired and the daughter of a blind father. And I thought activism was as far as I could go and she said oh, you should go to law school. And I did and I was 48 when I graduated from law school but it's one of the best things that ever happened to me, thanks to Judy Heumann. Thank you.

Representative **THORNE**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. I put this sentiment in to recognize Game Warden Brad Richard not for doing his job, but for going above and beyond, in my estimation. There are many that are convinced, myself included, that things would've turned out a lot differently for these two ladies had it not been for the professionalism, dedication and perseverance of Game Warden Brad Richard.

On February 21st, two intellectually challenged women, Kimberly Pushard and Angela Bussell, took off from Topsham headed for the mall. As we say when we go hunting in Maine, they got turned around. They lost their way a little bit. They ended up in someplace where they didn't know where they were and didn't know what to do. For days, they stayed in a Jeep, in the snow, in the cold, up an old, snowy, abandoned road near Nicatous Lake in Hancock County, over 150 miles from where they started. Temperatures on Saturday night after their vehicle ran out of fuel days earlier were 15 below. The Jeep had run out of gas after getting stuck in the snow and they stayed with the vehicle. Warden Brad Richard was on a patrol on his snowmobile and he noticed an obscure snowed-over set of vehicle tracks. Just on gut instinct, he went up the road for a considerable distance until he found the Jeep, covered in snow. He didn't know what he would find. He knocked on the Jeep and the door opened. He said, Kimberly and Angela? And she said, how'd you know our name? He said, many people have been looking for days for you. Warden Richard said, I'm going to get help, I need to go get some help, to which Kimberly said, would you please hurry up? She may or may not have said please. There was a Mountain Dew that was frozen solid in the front seat of the vehicle where the women were. Angela had frostbite to her knees where she had evidently knelt down in the snow, got them wet and gone back in the vehicle. They're doing fine today but had Warden Richard given up, gone home, it was cold, taken a left turn instead of following his gut, we would've had a significantly different outcome on this.

Maine is a great little big State and by that, Madam Speaker, I'll give you an example. I grew up in Presque Isle, graduated in 1982, haven't lived there since. But on Friday, I got no less than three text messages and two phone calls letting me know that the Speaker of the House was parked in front of the Northeastland Hotel. We're all also well aware of the grapevine telegraph, where if something happens in Maine and somebody from Florida calls us here in Maine to let us know that it's happened in Maine. All kinds of people were looking for these two women. The professionalism, dedication and resilience of Game Warden Brad Richard made a difference in their lives. They are alive today and I am convinced of that because Game Warden Brad Richard took his dedication seriously and we are fortunate to have professional men and women of the Maine Warden Service looking out for us on a daily basis. On Friday, I went to the Inland Fisheries and Wildlife, the Maine Game Warden awards banquet where they had Game Warden of the Year, Warden Pilot Jeff Spencer, Legendary Warden of the Year Pat Dorian, and when I put this sentiment in, I was told that, you know what, this kind of thing happens all the time, every day; police departments, sheriff's departments, state police, fire fighters, Maine Warden Service; every day, this type of thing happens. And I just wanted to point it out today so that we can take the time and recognize those who are dedicated to saving lives and protecting Maine citizens. Thank you, Madam Speaker.

He grew up in Wilton, Maine. His mother worked at the Bass shoe shop, his father was the Chief of Police in Wilton and they grew up in a house with no running water, with really humble beginnings. Later on, he attended Husson University where later on he became a member on the Board of Directors of Husson and helped them through difficult times, through the sales of land and allowing them to become the university that they are today.

Through his accounting degree, he saved 70 companies in the State of Maine, created jobs for a number of different people and through those achievements became a philanthropist and helped with Helping Hands in Windham, the Barbara Bush Foundation in Portland and also Opportunity Farms where victimized boys could have a safe place to go. And I was working on this, trying to figure out what I was going to say today, the overwhelming thing I got was Dick Dyke left this earth a better place than when he came and that's all something that we should aspire to be. And his brother Bruce and wife Judy are here today and his nephew Warren and Monique Dyke, and I just want to thank them for coming out today and memorializing Dick Dyke and through all the good things. And if you guys are interested, there's a book that was written about Mr. Dyke, Just a Man from Wilton. I recommend you pick it up and read it, it's a great story about his life. More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Chair recognizes the Representative from Alfred, Representative Sampson.

Representative **SAMPSON**: Thank you, Madam Speaker. So, I oppose this motion. Essentially, the cost of this initiative is nearly \$4 million over the next two years. There are no clear goals or objectives for this project. So, I would encourage you to follow my light. Thank you.

The SPEAKER: The Chair recognizes the Representative from Dexter, Representative Foster.

Representative **FOSTER**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. I also rise in opposition to this pending motion. At \$1,840,000 a year, which is a fairly large expenditure for a few leaders and then for 50 members of this group, most of which will probably be young adults, likely just out of either high school or college, that's a rather large amount.

When we consider that many nonprofits are already filling this bill, if you will, along with some businesses who, for instance, promote solar net energy billing and take their message door to door and so on and so forth, the bill calls for \$1.5 million per year for 50 members of this group and \$340,000 for the leadership. That's \$30,000 a year per member. In my travels, every business I go to, every employer that I visit and most especially when I hear from my school district, they are looking for these types of people. So, I would suggest that rather than provide them a stipend or a part-time job for \$30,000 a year that these 50 people could be better used in our struggling businesses and our schools and others that are really hurting for employees. Thank you, Madam Speaker.

This bill merely allocates additional funds to the program. Currently, Corps members will be working on home energy efficiency projects in Washington County. These communities desperately need these Corps members. However, the continuing service budget didn't allocate an adequate amount of funds for the Corps and the program risks running out of these monies. This bill looks at expanding the Corps by fully funding it and I believe that every person in this State should have the opportunity to serve as they see fit. That's my entire focus in the Legislature; giving Mainers the chance to serve their community, and that is the purpose of this bill. Thank you.

Every one of us represent municipalities that have to do legal notices for public transactions and those get very costly. Madam Speaker, many of us do not have the newspaper infrastructure within our communities that actually even have a subscriber readership of any value. So, this bill would have suggested that a public website put out by the town would count as their public notice. The minority options of the Committee was to add that they must do a press release to a newspaper of general circulation. But, Madam Speaker, this had broad support from the Maine Town and City Clerks Association, the Maine Municipal Association, the Town of Belgrade, the Maine Rural Waters Association; all these agencies that really have to do legal notices just to conduct their regular business when we have a better option with their local municipal websites and the requirement that they do a press release to a paper. So, Madam Speaker, I oppose the pending motion and I encourage you to vote no.

The **SPEAKER**: The Chair recognizes the Representative from Pittsfield, Representative Collamore.

Representative **COLLAMORE**: Thank you, Madam Speaker. I rise today in opposition to the pending motion. LD 422 would help municipalities save valuable tax dollars by allowing them to post public hearings and notices via virtual means and in the free local newspapers, which have greater readership in local communities they serve than the major newspapers that are hard to purchase in small communities if you try to pick up a paper past 8 a.m. I know, I've tried.

Having served on the Pittsfield Town Council as the Finance Committee Chair for two years, I know firsthand just how difficult it is for small communities to make any changes to items like housing zoning rules because it is outside of the budget to post such a large notice in the major newspapers. The cost for the local newspaper is much less expensive, with virtual

postings being free, and would allow municipalities to be more nimble.

In this virtual world we live in, in a Chamber that has gone paperless, understanding that municipalities have strong virtual footprints and when we, ourselves, have allowed reports to be transmitted virtually instead of requiring expensive printing of the reports, we should recognize the importance of allowing towns to make the move to virtual and local postings. I know for sure this would help my municipality make very needed updates to their charter in areas concerning zoning for housing, for example.

Please keep in mind, our small towns want to allow changes needed to address items like the housing crisis but oftentimes the cost associated with posting in the major newspapers prevents these quick changes due to the tight budgets of the towns. Madam Speaker, I ask that you follow my light, vote against the pending motion, and support LD 422 to help our small towns address the important issues facing our State. Thank you.

Representative **THORNE**: Thank you, Madam Speaker. I rise in opposition of the pending motion on the floor. My day job when I'm not legislating, I sell advertising in the North Woods Sporting Journal, which is a statewide hunting and fishing magazine. And I think what I'll do is I will introduce legislation where these announcements have to be taken out in such a publication because I make 35% commission on all ads that I sell for \$15 a column inch in the Sporting Journal. So, I urge you to vote against the pending legislation.

Representative **MORRIS**: Thank you, Madam Speaker. I rise in opposition to the pending motion. This bill is about aligning standards between party candidates and unenrolled candidates. Currently, party candidates have their registered political party listed on the ballot under their name. Currently, unenrolled candidates are allowed to use up to three words to describe their party designation. This bill would repeal that provision and require that the ballot reflect their registration status. Those of you that have been here for four years, as I have, may remember previous discussions around allowing nicknames on the ballot and the discussion in that always centered around the idea of electioneering. One particular objection was that words such as the greatest or the people's hero could be requested as a nickname, yet under the current law either of those designations could be listed as a party designation on the ballot. So, by enacting this bill, we are preventing candidates from using the ballot as an electioneering instrument. We do not allow candidates to campaign within 250 feet of a polling place. We should also not permit having slogans printed on the ballot as a political designation. Party candidates can only have their name and the political party on the ballot. There's ample opportunity during the campaign to print slogans on signs, palm cards and mailers to promote our candidacy, without having the message printed on the ballot as well.

Furthermore, there is a process by which people with similar philosophical beliefs can go about creating a new party. I know that both political parties work hard to invest a lot of time, money and energy into registering new voters and growing their numbers. Allowing others to just have a name printed on the ballot seems like an end-run around this process.

The bill as amended would allow for the phrase Independent or Unenrolled to be printed on the ballot, so, I think it still reflects what those third-party candidates want without allowing them to have what I consider to be an unfair advantage in an election process. So, for those reasons, I would --

Representative **SUPICA**: Point of Order.

**ORDER**

On motion of Speaker TALBOT ROSS of Portland, the following Joint Order: (H.P. 1158)

WHEREAS, the Constitution of Maine, Article VI, Section 3 provides for the Justices of the Supreme Judicial Court to render their opinion on important questions of law and upon solemn occasions; and

WHEREAS, it appears to the 131st Legislature that the following are important questions of law and that this is a solemn occasion; and

WHEREAS, the Constitution of Maine, Article IV, Part Third, Section 18 provides the ability of electors to propose to the Legislature any bill, resolve or resolution and further provides the procedures to be followed by the initiators, including filing the petition for a direct initiative of legislation, addressed to the Legislature, with the Secretary of State within a specified number of days after the convening of a regular session; and

WHEREAS, the Constitution of Maine, Article IV, Part Third, Section 18, Subsection 2 provides in 2 different places that the Legislature must be given the opportunity to act on the measure: "The measure thus proposed, *unless enacted without change by the Legislature at the session at which it is presented*, shall be submitted to the electors together with any ... recommendation of the Legislature" [emphasis added]; and further that "[i]f the measure initiated *is enacted by the Legislature without change*, it shall not go to a referendum vote..." [emphasis added]; and

WHEREAS, for the Legislature to exercise its right under the Constitution of Maine to act on a measure, the measure must be before the Legislature in the form of a legislative document; and

WHEREAS, 4 measures proposed by electors were presented to the Secretary of State; and

WHEREAS, the Secretary of State transmitted 2 of the measures to the Legislature on February 16, 2023 to be produced by the Office of the Revisor of Statutes as legislative documents for consideration by the Legislature and 2 were transmitted to the Legislature on March 22, 2023 to be produced by the Office of the Revisor of Statutes as legislative documents for consideration by the Legislature; and

WHEREAS, before the Legislature was presented with any of the measures produced as legislative documents, the First Regular Session of the 131st Legislature, due to unforeseen circumstances, adjourned on March 30, 2023; and

WHEREAS, prior to its adjournment, the First Regular Session of the 131st Legislature passed a joint order carrying over to a subsequent session of the 131st Legislature "...all matters not finally disposed of at the time of adjournment...in the possession of the Legislature, including working papers and drafts in the possession of nonpartisan staff offices..." [See Senate Paper 594]; and

WHEREAS, among the working papers and drafts in the possession of the nonpartisan staff office the Office of the Revisor of Statutes were the 4 measures, having not yet been prepared as legislative documents; and

WHEREAS, the 131st Legislature convened in special session 6 days after adjournment, on April 5, 2023; and

WHEREAS, on April 10, 2023, 2 of the measures, as prepared by the Office of the Revisor of Statutes, were transmitted to the Clerk of the House, given Legislative Document numbers, L.D. 1610 and L.D. 1611, printed and presented to the Legislature; and

WHEREAS, on April 11, 2023, the Secretary of State issued 4 proclamations of the Governor proclaiming that an election be held for all 4 measures, overlooking the right of the Legislature to consider these measures as provided by the Constitution of Maine, Article IV, Part Third, Section 18, Subsection 2; and

WHEREAS, the issuance of these proclamations casts doubt on the ability of the Legislature to legitimately act on the direct initiatives of legislation now before it, including the right of the Legislature to enact the measures without change and prevent the measures from going to referendum vote, as is the Legislature's right under the Constitution of Maine; and

WHEREAS, there are now questions before the Legislature regarding the ability of the Legislature to act on these 4 legislative documents and the consequences of any actions taken to enact these 4 legislative documents; and

WHEREAS, it is important that the Legislature be informed as to the questions raised in this order; now, therefore, be it

ORDERED, the Senate concurring, that, in accordance with the provisions of the Constitution of Maine, the House of Representatives and the Senate respectfully request the Justices of the Supreme Judicial Court to give their opinion to the House of Representatives and the Senate on the following questions of law:

Question 1. Is the mere transmittal of a measure by the Secretary of State to the Legislature's bill production office for preparation as a legislative document sufficient to constitute "presented to the Legislature," thus eliminating the right of the Legislature to act on the measure as specified in the Constitution of Maine, Article IV, Part Third, Section 18, Subsection 2?

Question 2. If the answer to Question 1 is in the affirmative, is the 131st Legislature, now assembled in the First Special Session, precluded from acting on such a measure?

Question 3. If the answer to Question 2 is in the negative and the Legislature enacts such a measure without change, is the bill thus enacted by the Legislature considered a competing measure as described in the Constitution of Maine, Article IV, Part Third, Section 18, Subsection 2?

**READ.**
