Abuse**

1 **Be it enacted by the People of the State of Maine as follows:**

2 **Sec. 1. 24 MRSA §2504**, as enacted by PL 1977, c. 492, §3, is amended to read:

3 **§2504. Professional societies**

4 Every state professional society shall establish a professional competence committee  
5 of its members pursuant to written bylaws approved by the society's governing board. The  
6 committee shall receive, investigate and determine the accuracy of any report made to the  
7 society of any member physician's acts amounting to gross or repeated medical  
8 malpractice, ~~habitual drunkenness, addiction to the use of drugs~~ use of alcohol or drugs  
9 that may indicate a substance use disorder or professional incompetence.

10 **Sec. 2. 24 MRSA §2505, first ¶**, as amended by PL 2007, c. 380, §1, is further  
11 amended to read:

12 Any professional competence committee within this State and any physician licensed  
13 to practice or otherwise lawfully practicing within this State shall, and any other person  
14 may, report the relevant facts to the appropriate board relating to the acts of any physician  
15 in this State if, in the opinion of the committee, physician or other person, the committee  
16 or individual has reasonable knowledge of acts of the physician amounting to gross or  
17 repeated medical malpractice, ~~habitual drunkenness, addiction to the use of drugs~~ use of  
18 alcohol or drugs that may indicate a substance use disorder, professional incompetence,  
19 unprofessional conduct or sexual misconduct identified by board rule. The failure of any  
20 such professional competence committee or any such physician to report as required is a  
21 civil violation for which a fine of not more than \$1,000 may be adjudged.

14 **SUMMARY**

15 This bill amends provisions of the Maine Health Security Act regarding the reporting  
16 of physicians with possible drug or alcohol problems to licensing authorities and  
17 provisions of the health care practitioner licensing laws dealing with grounds for  
18 discipline. Currently, substance use by a practitioner that is foreseeably likely to result in  
19 endangering patients is grounds for discipline; this bill instead provides that substance use  
20 that may result in endangering patients is grounds for discipline. This bill also updates  
21 terminology used to reference drug or alcohol problems.
