1 **Be it enacted by the People of the State of Maine as follows:**

6 **Sec. 2. 13 MRSA §732, sub-§4**, as amended by PL 2007, c. 620, Pt. D, §1, is  
7 further amended to read:

8 **4. Dentists, denturists, independent practice dental hygienists and any related**  
9 **licensed dental hygiene professionals.** For the purposes of this chapter, a denturist ~~or~~  
10 licensed under Title 32, chapter 16, an independent practice dental hygienist licensed  
11 under Title 32, chapter 16 141 or any related licensed dental hygiene professional may  
12 organize with a dentist who is licensed under Title 32, chapter 16 and may become a  
13 shareholder of a dental practice incorporated under the corporation laws. At no time may  
14 one or more denturists ~~or~~, independent practice dental hygienists or any related licensed  
15 dental hygiene professionals in sum have an equal or greater ownership interest in a  
16 dental practice than the dentist or dentists have in that practice.

1 **STATE BOARD OF DENTAL HYGIENISTS**

2 **§19121. Appointment; term; removal**

3 The State Board of Dental Hygienists, as established by Title 5, section 12004-A,  
4 subsection 10-A, consists of 5 members who are appointed by the Governor. A full-term  
5 appointment is for 5 years. Appointment of members must comply with Title 10, section  
6 8009. Members of the board may be removed from office for cause by the Governor.

7 **§19122. Qualifications**

8 A member of the board must be a citizen of the United States and a resident of this  
9 State for at least 3 consecutive years prior to appointment and shall file with the Secretary  
10 of State an oath of office before beginning service. The board is composed of:

11 **1. Registered dental hygienists.** Two dental hygienists, each of whom:

12 A. Is a graduate of a state-approved educational program in dental hygiene; and

13 B. Holds a current state license to practice dental hygiene.

14 One dental hygienist must be active in an approved educational program in dental  
15 hygiene. One dental hygienist must be active in dental hygiene service;

16 **2. Public health dental hygienist.** One public health dental hygienist with public  
17 health supervision status as described in section 19149 who:

18 A. Is a graduate of a state-approved educational program in public health dental  
19 hygiene; and

20 B. Holds a current state license to practice public health dental hygiene;

21 **3. Independent practice dental hygienist.** One independent practice dental  
22 hygienist who:

23 A. Is a graduate of a state-approved educational program in independent practice  
24 dental hygiene; and

25 B. Holds a current state license as an independent practice dental hygienist; and

26 **4. Public member.** One public member. A person may not qualify for appointment  
27 as a public member of the board if that person or a member of that person's immediate  
28 family is:

29 A. A member of another state licensing board;

30 B. On the board of a health care agency; or

31 C. Engaged for compensation in the provision of health services or the provision of  
32 health research, instruction or insurance.

33 **§19123. Powers and duties**

34 The board shall hold annual meetings at which it shall elect from its members a chair  
35 and a secretary. It may hold such other meetings during the year as it determines

1 necessary to transact its business. Special meetings must be called by the secretary on the  
2 request of 2 members. Three members of the board constitute a quorum at a meeting.

3 The board shall perform an initial review of all complaints initiated pursuant to  
4 section 19124 involving dental hygienists and independent practice dental hygienists.  
5 Upon completion of the board's review of a complaint, the secretary of the board shall  
6 dispose of the complaint in accordance with those dispositions authorized by section  
7 19124.

8 The board shall perform an initial review of all applications for licensure as a dental  
9 hygienist pursuant to section 19143 and an independent practice dental hygienist pursuant  
10 to section 19165, all submissions relating to continuing education of a dental hygienist  
11 pursuant to section 19146 and an independent practice dental hygienist pursuant to  
12 section 19168 and all submissions relating to public health supervision status of a dental  
13 hygienist and an independent practice dental hygienist as defined by board rule. Upon  
14 completion of its review of an application or submission, the board shall dispose of the  
15 application or submission, including issuance, renewal, denial or nonrenewal of a dental  
16 hygienist and an independent practice dental hygienist license.

17 The board:

18 **1. Bylaws.** May adopt bylaws and rules for the transaction of the business of the  
19 board and the government and management of its affairs, not inconsistent with the laws  
20 of this State and of the United States, as it considers expedient;

21 **2. Seal.** May adopt a seal, which must be placed in the care of the executive  
22 director;

23 **3. Curricula.** May prescribe curricula and standards for educational programs  
24 preparing individuals for licensure under this chapter;

25 **4. Surveys.** May provide for surveys of the programs described in subsection 3 as it  
26 determines necessary;

27 **5. Approval.** May approve such dental hygiene educational programs within the  
28 State as meet the requirements of this chapter and of the board;

29 **6. Denial.** May place dental hygiene educational programs on probation or warn, or  
30 deny, condition, withdraw or discontinue approval of, dental hygiene educational  
31 programs for failure to meet approved curricula or other standards as established by this  
32 chapter or pursuant to law;

33 **7. Licenses.** May examine, license and renew the licenses of qualified applicants;

34 **8. Prosecution.** May cause the prosecution and enjoinder of individuals violating  
35 this chapter and incur necessary expenses for those activities;

36 **9. Records.** May keep a record of all its proceedings;



1           **10. Report.** May make an annual report to the Commissioner of Professional and  
2 Financial Regulation for each fiscal year showing its receipts and disbursements and  
3 giving a full account of its activities during the previous 12-month period;

4           **11. Budget.** Shall submit to the Commissioner of Professional and Financial  
5 Regulation its budgetary requirements in the same manner as is provided in Title 5,  
6 section 1665, and the commissioner shall in turn transmit these requirements to the  
7 Bureau of the Budget without any revision, alteration or change unless alterations are  
8 mutually agreed upon by the Department of Professional and Financial Regulation and  
9 the board or the board's designee. The budget submitted by the board to the commissioner  
10 must be sufficient to enable the board to comply with this chapter;

11           **12. Executive and assistant director.** May appoint and employ qualified  
12 individuals, not members of the board, to serve as executive director and assistant  
13 executive director to the board, fix their compensation and define their duties;

14           **13. Other employees.** May employ other individuals as may be necessary to carry  
15 out the work of the board;

16           **14. Funds.** May set aside and budget funds for, make contracts for and procure  
17 goods or services the board determines necessary to accomplish its duties under this  
18 chapter;

19           **15. Accept federal funds.** Notwithstanding section 19128, may accept for the State  
20 any federal funds appropriated under a federal law relating to the authorized programs of  
21 the board. The board may undertake the necessary duties and tasks to implement federal  
22 law with respect to the authorized programs of the board; and

23           **16. Rulemaking.** May establish rules to implement the provisions of this chapter.  
24 Rules adopted pursuant to this subsection are routine technical rules as defined in Title 5,  
25 chapter 375, subchapter 2-A.

26           **§19124. Disciplinary actions**

27           **1. Disciplinary proceedings and sanctions.** Regarding noncompliance with or  
28 violation of this chapter or of rules adopted by the board, the board shall investigate a  
29 complaint on its own motion or upon receipt of a written complaint filed with the board.

30 The board shall notify the licensee of the content of a complaint filed against the licensee  
31 as soon as possible, but no later than 60 days from receipt of this information. The  
32 licensee shall respond within 30 days. If the licensee's response to the complaint satisfies  
33 the board that the complaint does not merit further investigation or action, the matter may  
34 be dismissed, with notice of the dismissal to the complainant, if any.

35 If, in the opinion of the board, the factual basis of the complaint is or may be true and the  
36 complaint is of sufficient gravity to warrant further action, the board may request an  
37 informal conference with the licensee. The board shall provide the licensee with adequate  
38 notice of the conference and of the issues to be discussed. The conference must be  
39 conducted in executive session of the board, pursuant to Title 1, section 405, unless

1 otherwise requested by the licensee. Statements made at the conference may not be  
2 introduced at a subsequent formal hearing unless all parties consent.

3 If the board finds that the factual basis of the complaint is true and is of sufficient gravity  
4 to warrant further action, it may take any of the following actions it considers  
5 appropriate:

6 A. With the consent of the licensee, enter into a consent agreement that takes any  
7 action authorized by Title 10, section 8003, subsection 5 or Title 10, section 8003-D.  
8 A consent agreement may be used to terminate a complaint investigation if entered  
9 into by the board, the licensee and the Attorney General's office;

10 B. In consideration for acceptance of a voluntary surrender of the license, if a  
11 consent agreement is signed by the board, the licensee and the Attorney General's  
12 office under paragraph A, negotiate stipulations, including terms and conditions for  
13 reinstatement, that ensure protection of the public health and safety and that serve to  
14 rehabilitate or educate the licensee;

15 C. If the board concludes that denial of initial licensure or modification or  
16 nonrenewal of an existing license is in order, refer the complaint to a dental hygienist  
17 adjudicatory panel, convened pursuant to section 19129, for the purpose of holding  
18 an adjudicatory hearing in accordance with the provisions of Title 5, chapter 375,  
19 subchapter 4; and

20 D. If the board concludes that suspension or revocation of the license is in order, file  
21 a complaint in the District Court in accordance with Title 4, chapter 5.

22 Notwithstanding Title 10, section 8003, subsection 5, any nonconsensual revocation of a  
23 license by a dental hygienist adjudicatory panel pursuant to Title 10, section 8003 may be  
24 imposed only after a hearing conforming to the requirements of Title 5, chapter 375,  
25 subchapter 4 and is subject to judicial review exclusively in the Superior Court in  
26 accordance with Title 5, chapter 375, subchapter 7. The board retains the authority to  
27 take any other action pursuant to this section and Title 10, section 8003 regarding the  
28 disposition of any complaint that does not involve an adjudicatory hearing.

29 **2. Grounds for discipline.** The board may suspend or revoke a license pursuant to  
30 Title 5, section 10004. The following are grounds for an action to refuse to issue, modify,  
31 suspend, revoke or refuse to renew the license of a person licensed under this chapter:

32 A. The practice of fraud or deceit in obtaining a license under this chapter or in  
33 connection with service rendered within the scope of the license issued;

34 B. Habitual substance abuse that has resulted or is foreseeably likely to result in the  
35 licensee's performing services in a manner that endangers the health or safety of  
36 patients;

37 C. A professional diagnosis of a mental or physical condition that has resulted or  
38 may result in the licensee's performing services in a manner that endangers the health  
39 or safety of patients;

40 D. Aiding or abetting the practice of a dental hygienist profession by an individual  
41 who is not licensed under this chapter and who claims to be legally licensed;

1 E. Incompetence in the practice for which the licensee is licensed. A licensee is  
2 considered incompetent in the practice if the licensee has:

3 (1) Engaged in conduct that evidences a lack of ability or fitness to perform the  
4 duties owed by the licensee to a client or patient or the general public; or

5 (2) Engaged in conduct that evidences a lack of knowledge or inability to apply  
6 principles or skills to carry out the practice for which the licensee is licensed;

7 F. Unprofessional conduct. A licensee is considered to have engaged in  
8 unprofessional conduct if the licensee violates a standard of professional behavior  
9 that has been established in the practice for which the licensee is licensed;

10 G. Subject to the limitations of Title 5, chapter 341, conviction of a crime that  
11 involves dishonesty or false statement or that relates directly to the practice for which  
12 the licensee is licensed or conviction of a crime for which incarceration for one year  
13 or more may be imposed;

14 H. A violation of this chapter or a rule adopted by the board; and

15 I. Engaging in false, misleading or deceptive advertising.

16 **§19125. Liaison; limitations**

17 The Commissioner of Professional and Financial Regulation shall act as a liaison  
18 between the board and the Governor. The commissioner may not exercise or interfere  
19 with the exercise of discretionary, regulatory or licensing authority granted by statute to  
20 the board. The commissioner may require the board to be accessible to the public for  
21 complaints and questions during regular business hours and to provide any information  
22 the commissioner requires in order to ensure that the board is operating administratively  
23 within the requirements of this chapter.

24 **§19126. Qualifications of executive director**

25 The executive director appointed pursuant to section 19123, subsection 12 must meet  
26 all the qualifications for dental hygienist board members required in section 19122.

27 **§19127. Compensation**

28 Eligible members of the board are entitled to compensation in accordance with the  
29 provisions of Title 5, chapter 379.

30 **§19128. Disposition of funds**

31 All money received by the board under this chapter must be paid to the Treasurer of  
32 State. The Treasurer of State shall place the money to the credit of the State Board of  
33 Dental Hygienists Fund, which is established as a nonlapsing, dedicated fund. All  
34 amounts paid into this fund must be held subject to the order of the board to be used only  
35 for the expenses incurred in the performance of the purposes of this chapter and the duties  
36 imposed by it as well as the promotion of dental hygiene education and standards of  
37 dental hygiene care in this State.

1           **§19129. Dental hygienist adjudicatory panels**

2           Dental hygienist adjudicatory panels may be convened in accordance with this  
3 section.

4           **1. Purpose of panel.** The purpose of a dental hygienist adjudicatory panel, referred  
5 to in this section as "a panel," is to conduct adjudicatory hearings independent of the  
6 board after the board conducts the initial investigation of a complaint against a licensee  
7 and refers the complaint to a panel.

8           **2. Establishment of a pool of panel members.** The board shall establish a pool of  
9 potential panel members. The board may not select a person for the pool who has been  
10 found in violation of the dental hygienist practices laws or rules within the preceding 10  
11 years. After selection by the board, each member of the pool is subject to review and  
12 appointment by the Governor. The pool must be composed of at least 5 independent  
13 practice dental hygienists and 5 dental hygienists licensed under this chapter and 5 public  
14 members, but if the board finds that it is beneficial to the administration of the pool, the  
15 pool may be composed of no fewer than 3 from each category. A pool member may not  
16 be a member of the board.

17           **3. Convening of a panel.** The board may convene a panel for a case that cannot be  
18 resolved using a consent agreement. The board shall request a member of its staff to  
19 draw names from the pool in accordance with subsection 4. A member of the board may  
20 not have a role in the drawing or selection of individuals serving on a panel. For each  
21 case, a separate panel must be created and then dissolved once it has issued its decision.

22           **4. Appointments for a panel.** A panel consists of 4 members appointed from the  
23 pool under subsection 2:

24           A. One member must be a public member;

25           B. One member must be an independent practice dental hygienist;

26           C. One member must be a dental hygienist; and

27           D. One member must be either an independent practice dental hygienist or a dental  
28 hygienist. A dental hygienist must be named to the first panel convened. For  
29 subsequent panels, the seat must alternate between a dental hygienist and an  
30 independent practice dental hygienist, unless the defendant is either an independent  
31 practice dental hygienist or a dental hygienist, in which case the member filling this  
32 seat must be of the defendant's profession.

33           **5. Vacancy.** In the event of a vacancy on a panel, the board shall appoint a  
34 replacement member from the pool under subsection 2.

35           **6. Terms; vacancy.** Members of the pool under subsection 2 serve 5-year terms.  
36 Members may be reappointed. In the event of a vacancy in the pool, the board shall  
37 select a replacement member in the same manner as the original selection subject to the  
38 provisions of subsection 2.



1           **§19144. License; biennial fee**

2           The board shall issue a license to practice as a dental hygienist in this State to a  
3 person who has met the licensure requirements. The license must be exhibited publicly at  
4 the person's place of employment. The license authorizes practice as a dental hygienist in  
5 this State for the year in which it is issued until the expiration date that appears on the  
6 license. On or before January 1st of each odd-numbered year, the dental hygienist shall  
7 pay to the board a license renewal fee of not more than \$175 to be determined by the  
8 board. Dental hygienists who have not paid the renewal fee on or before January 1st must  
9 be reinstated upon payment of a late fee of not more than \$50 to be determined by the  
10 board if paid before February 1st of the year in which license renewal is due. Failure to be  
11 properly licensed by February 1st results in automatic suspension of a license to practice  
12 dental hygiene. Reinstatement may be made, if approved by the board, by payment to the  
13 secretary of the board of a fee determined by the board of not more than \$175. A new  
14 applicant who has paid the application fee shall pay the biennial licensure fee if the  
15 applicant applies in an odd-numbered year or half the biennial licensure fee if the  
16 applicant applies in an even-numbered year.

17           The board may issue temporary licenses to dental hygienists who present credentials  
18 satisfactory to the board. The board may charge a fee of up to \$25 for a temporary  
19 license.

20           **§19145. Fee for duplicate license**

21           An applicant for a duplicate license granted upon proof of loss of the original shall  
22 pay a fee of \$15.

23           **§19146. Continuing education**

24           As a condition of renewal of a license to practice, a dental hygienist must submit  
25 evidence of successful completion of 30 hours of continuing education consisting of  
26 board-approved courses, including cardiopulmonary resuscitation courses, in the 2 years  
27 preceding the application for renewal. The board and the dental hygienist shall follow and  
28 are bound by the provisions of section 1084-A in the implementation of this section.

29           **§19147. Mental or physical examination**

30           For the purposes of this section, by application for and acceptance of a license to  
31 practice, a licensed dental hygienist is considered to have given consent to a mental or  
32 physical examination when directed by the board. The board may direct a dental hygienist  
33 to submit to an examination whenever the board determines the dental hygienist may be  
34 suffering from a mental illness that may be interfering with the competent practice of  
35 dental hygiene or from the use of intoxicants or drugs to an extent that they are  
36 preventing the dental hygienist from practicing dental hygiene competently and with  
37 safety to patients. A dental hygienist examined pursuant to an order of the board may not  
38 prevent the testimony of the examining individual or prevent the acceptance into evidence  
39 of the report of an examining individual. Failure to comply with an order of the board to  
40 submit to a mental or physical examination results in the immediate suspension of the

1 license of the dental hygienist by order of the District Court until the dental hygienist  
2 submits to the examination.

3 **§19148. Licensure requirements for graduates of accredited programs**

4 In order to be licensed as a dental hygienist under this subchapter, a person who is a  
5 graduate of a dental hygiene program approved by the American Dental Association  
6 Commission on Dental Accreditation or its successor organization must meet one of the  
7 following 2 sets of requirements:

8 **1. Standard licensure.** For standard licensure, the applicant must:

9 A. Have received, at least, an associate degree from a dental hygiene program  
10 accredited by the American Dental Association Commission on Dental Accreditation  
11 or its successor organization and have provided a notarized statement from the dean  
12 of the school affirming that the applicant has met all applicable degree requirements;

13 B. Have completed with a passing grade the National Board Dental Hygiene  
14 Examination or the successor to that examination;

15 C. Have completed with a passing grade the North East Regional Board Dental  
16 Hygiene Examination or the successor to that examination;

17 D. Have completed with a passing grade the jurisprudence examination given by the  
18 board; and

19 E. For any applicant who has completed the North East Regional Board Dental  
20 Hygiene Examination or the successor to that examination more than one year prior  
21 to application for licensure in the State, have successfully completed a personal  
22 interview before the board; and

23 **2. Licensure by endorsement.** For licensure by endorsement, the applicant must:

24 A. Have graduated from an accredited dental hygiene program;

25 B. If the candidate graduated subsequent to 1964, have completed with a passing  
26 grade the National Board Dental Hygiene Examination or the successor to that  
27 examination if such an examination was required;

28 C. Have furnished proof, satisfactory to the board, that the candidate has been duly  
29 licensed to practice dental hygiene in another state after full compliance with its laws;

30 D. If the candidate graduated subsequent to 1970, have completed with a passing  
31 grade the North East Regional Board Dental Hygiene Examination or the successor to  
32 that examination if such an examination was required, except that the board may at its  
33 discretion waive the North East Regional Board Dental Hygiene Examination or the  
34 successor to that examination if all other requirements of this subsection have been  
35 met;

36 E. Have engaged in active clinical practice for a minimum of 3 years prior to  
37 application;

38 F. Have completed with a passing grade the jurisprudence examination given by the  
39 board; and





1           A person practicing independent practice dental hygiene as an employee of another  
2 shall cause that person's name to be conspicuously displayed at the entrance of the place  
3 where the practice is conducted.

4           **§19162. Qualifications for licensure**

5           To qualify for licensure under this subchapter as an independent practice dental  
6 hygienist, a person must:

7           **1. Eighteen years of age.** Be 18 years of age or older;

8           **2. Licensure as dental hygienist.** Possess a valid license to practice dental hygiene  
9 issued by the board pursuant to subchapter 4 or qualify for licensure as an independent  
10 practice dental hygienist by endorsement pursuant to section 19164; and

11           **3. Education and experience.** Meet the educational and experience requirements  
12 described in section 19163.

13           **§19163. Education and experience**

14           An applicant for licensure under this subchapter as an independent practice dental  
15 hygienist must:

16           **1. Bachelor's degree and 2,000 hours' experience.** Possess a bachelor's degree in  
17 dental hygiene from a dental hygiene program accredited by the American Dental  
18 Association Commission on Dental Accreditation, or its successor organization, and  
19 document 2,000 work hours of clinical practice in a private dental practice or nonprofit  
20 dental clinic under direct or general supervision of a dentist during the 4 years preceding  
21 application; or

22           **2. Associate degree and 5,000 hours' experience.** Possess an associate degree in  
23 dental hygiene from a dental hygiene program accredited by the American Dental  
24 Association Commission on Dental Accreditation, or its successor organization, and  
25 document 5,000 work hours of clinical practice in a private dental practice or nonprofit  
26 dental clinic under direct or general supervision of a dentist during the 6 years preceding  
27 application.

28           **§19164. Licensure by endorsement**

29           A person eligible for licensure as a dental hygienist by endorsement pursuant to  
30 section 19148, subsection 2 or section 19150 is also eligible for licensure under this  
31 subchapter as an independent practice dental hygienist by endorsement if the applicant  
32 meets the educational and experience requirements set forth in section 19163.

33           **§19165. Application**

34           An applicant for licensure as an independent practice dental hygienist shall apply to  
35 the board on forms provided by the board. The applicant shall include as part of the  
36 application such information and documentation as the board may require to act on the

1 application. The application must be accompanied by the application fee set under section  
2 19167.

3 **§19166. License; biennial renewal; discontinuation of dental hygienist license**

4 The board shall issue a license to practice as an independent practice dental hygienist  
5 to a person who has met the requirements for licensure set forth in this subchapter and has  
6 paid the application fee under section 19167. There is an initial license fee for  
7 independent practice dental hygienists licensed by endorsement. The license must be  
8 exhibited publicly at the person's place of business or employment. The initial date of  
9 expiration of the license is the original expiration date of the person's dental hygienist  
10 license issued by the board pursuant to subchapter 1 or, for independent practice dental  
11 hygienists licensed by endorsement, January 1st of the first odd-numbered year following  
12 initial licensure. On or before January 1st of each odd-numbered year, the independent  
13 practice dental hygienist shall pay to the board a license renewal fee. Independent  
14 practice dental hygienists who have not paid the renewal fee on or before January 1st  
15 must be reinstated upon payment of a late fee before February 1st of the year in which  
16 license renewal is due. Failure to be properly licensed by February 1st results in  
17 automatic suspension of a license to practice as an independent practice dental hygienist.  
18 Reinstatement of the independent practice dental hygienist license may be made, if  
19 approved by the board, by payment of a reinstatement fee to the board.

20 A dental hygienist license issued by the board pursuant to subchapter 3 automatically  
21 expires upon issuance under this subchapter of an independent practice dental hygienist  
22 license to the same person.

23 **§19167. Fees**

24 The board may establish by rule fees for purposes authorized under this subchapter in  
25 amounts that are reasonable and necessary for their respective purposes, except that the  
26 fee for any one purpose may not exceed \$275. Rules adopted pursuant to this section are  
27 routine technical rules as defined in Title 5, chapter 375, subchapter 2-A.

28 **§19168. Continuing education**

29 As a condition of renewal under this subchapter of a license to practice, an  
30 independent practice dental hygienist must submit evidence of successful completion of  
31 30 hours of continuing education consisting of board-approved courses in the 2 years  
32 preceding the application for renewal. The board and the independent practice dental  
33 hygienist shall follow and are bound by the provisions of section 1084-A in the  
34 implementation of this section.

35 Continuing education completed pursuant to section 19146 may be recognized for  
36 purposes of this section in connection with the first renewal of an independent practice  
37 dental hygienist license.

38 The board may refuse to issue a license under this subchapter to a person who has not  
39 completed continuing education required by section 19146 or may issue the license on  
40 terms and conditions set by the board.

1           **§19169. Scope of practice**

2           **1. Independent practice.** An independent practice dental hygienist licensed under  
3 this subchapter may perform only the following duties without supervision by a dentist:

- 4           A. Interview patients and record complete medical and dental histories;
- 5           B. Take and record the vital signs of blood pressure, pulse and temperature;
- 6           C. Perform oral inspections, if the independent practice dental hygienist records all  
7 conditions that should be called to the attention of a dentist;
- 8           D. Perform complete periodontal and dental restorative charting;
- 9           E. Perform all procedures necessary for a complete prophylaxis, including root  
10 planing;
- 11           F. Apply fluoride to control caries;
- 12           G. Apply desensitizing agents to teeth;
- 13           H. Apply topical anesthetics;
- 14           I. Apply sealants;
- 15           J. Smooth and polish amalgam restorations, limited to slow speed application only;
- 16           K. Cement pontics and facings outside the mouth;
- 17           L. Take impressions for athletic mouth guards and custom fluoride trays;
- 18           M. Place and remove rubber dams;
- 19           N. Place temporary restorations in compliance with the protocol adopted by the  
20 board; and
- 21           O. Apply topical antimicrobials, excluding antibiotics, including fluoride, for the  
22 purposes of bacterial reduction, caries control and desensitization in the oral cavity.  
23 The independent practice dental hygienist shall follow current manufacturer's  
24 instructions in the use of these medicaments.

25 For the purposes of this subsection, "topical" includes superficial and intraoral  
26 application.

27           **2. Practice under supervision.** An independent practice dental hygienist licensed  
28 under this subchapter may perform duties under the supervision of a dentist as set forth in  
29 the rules of the board pursuant to section 19141.

30           **§19170. Responsibilities**

31           An independent practice dental hygienist licensed under this subchapter has the duties  
32 and responsibilities set out in this section with respect to each patient seen in an  
33 independent capacity pursuant to section 19169, subsection 1.

34           **1. Acknowledgment.** Prior to an initial patient visit, an independent practice dental  
35 hygienist licensed under this subchapter shall obtain from the patient or the parent or  
36 guardian of a minor patient written acknowledgment of the patient's or parent's or

1 guardian's understanding that the independent practice dental hygienist is not a dentist  
2 and that the service to be rendered does not constitute restorative care or treatment.

3 **2. Referral plan.** An independent practice dental hygienist licensed under this  
4 subchapter shall provide to a patient or the parent or guardian of a minor patient a written  
5 plan for referral to a dentist for any necessary dental care. The referral plan must identify  
6 all conditions that should be called to the attention of the dentist.

7 **§19171. Mental or physical examination**

8 For the purposes of this section, by application for and acceptance of a license to  
9 practice under this subchapter, an independent practice dental hygienist is considered to  
10 have given consent to a mental or physical examination when directed by the board. The  
11 board may direct an independent practice dental hygienist to submit to an examination  
12 whenever the board determines the independent practice dental hygienist may be  
13 suffering from a mental illness that may be interfering with the competent independent  
14 practice of dental hygiene or from the use of intoxicants or drugs to an extent that they  
15 are preventing the independent practice dental hygienist from practicing dental hygiene  
16 competently and with safety to patients. An independent practice dental hygienist  
17 examined pursuant to an order of the board may not prevent the testimony of the  
18 examining individual or prevent the acceptance into evidence of the report of an  
19 examining individual. Failure to comply with an order of the board to submit to a mental  
20 or physical examination results in the immediate suspension of the license to practice  
21 independent dental hygiene by order of the District Court until the independent practice  
22 dental hygienist submits to the examination.

23 **§19172. Use of former employers' lists**

24 An independent practice dental hygienist may not use or attempt to use in any manner  
25 whatsoever any prophylactic lists, call lists, records, reprints or copies of those lists,  
26 records or reprints, or information gathered from these materials, of the names of patients  
27 whom the independent practice dental hygienist might have served in the office of a prior  
28 employer, unless these names appear on the bona fide call or prophylactic list of the  
29 present employer and were caused to so appear through the independent practice of  
30 dentistry, denturism or independent practice dental hygiene as provided for in this chapter  
31 and chapter 16. A dentist, denturist or independent practice dental hygienist who employs  
32 an independent practice dental hygienist may not aid or abet or encourage that  
33 independent practice dental hygienist to make use of a so-called prophylactic call list or  
34 to call by telephone or to use written letters transmitted through the mails to solicit  
35 patronage from patients formerly served in the office of a dentist, denturist or  
36 independent practice dental hygienist that formerly employed the independent practice  
37 dental hygienist.

38 **Sec. 22. Maine Revised Statutes headnote amended; revision clause.** In
