An Act To Implement Certain Recommendations of the Criminal Law Advisory Commission Relative to the Maine Bail Code, the Maine Juvenile Code and the Maine Criminal Code and Related Statutes

1	Be it enacted by the People of the State of Maine as follows:
2 3	Sec. 1. 15 MRSA §393, sub-§1, as amended by PL 2009, c. 651, §1, is further amended to read:
4 5 6	<b>1. Possession prohibited.</b> A person may not own, possess or have under that person's control a firearm, unless that person has obtained a permit under this section, if that person:
7 8	A-1. Has been convicted of committing or found not criminally responsible by reason of insanity of committing:
9 10	(1) A crime in this State that is punishable by imprisonment for a term of one year or more;
11 12	(2) A crime under the laws of the United States that is punishable by imprisonment for a term exceeding one year;
13 14 15 16 17	(3) A crime under the laws of any other state that, in accordance with the laws of that jurisdiction, is punishable by a term of imprisonment exceeding one year. This subparagraph does not include a crime under the laws of another state that is classified by the laws of that state as a misdemeanor and is punishable by a term of imprisonment of 2 years or less;
18 19 20 21	(4) A crime under the laws of any other state that, in accordance with the laws of that jurisdiction, does not come within subparagraph (3) but is elementally substantially similar to a crime in this State that is punishable by a term of imprisonment for one year or more; or

The condition of release alleged to be violated relates to new criminal conduct for a crime classified as Class C or above or for a Class D or Class E crime involving domestic violence, sexual assault pursuant to Title 17-A, chapter 11 or sexual exploitation of minors pursuant to Title 17-A, chapter 12;

  12 that there does not exist a substantial probability that the juvenile will be competent in the
  13 foreseeable future, the Juvenile Court shall promptly hold a hearing to determine whether

 otherwise provided in this subchapter.

- Authority to disclose. A provider of electronic communication service may
   disclose portable electronic device content information to a government entity only
   pursuant to a warrant issued by a duly authorized judge or justice, judge or justice of the
   peace or as otherwise provided in this subchapter.

### 1 §648. Warrant needed for acquisition of location information

Except as provided in this subchapter, a government entity may not obtain location
 information without a valid warrant issued by a duly authorized judge or justice, judge or
 justice of the peace using procedures established pursuant to Title 15, section 55.

A judge or justice, judge or justice of the peace may issue a warrant for the location information of an electronic device pursuant to this section for a period of time necessary to achieve the objective of the authorization, but in any case the warrant is not valid for more than 10 days after the issuance. A judge or justice, judge or justice of the peace may grant an extension of a warrant upon a finding of continuing probable cause and a finding that the extension is necessary to achieve the objective of the authorization. An extension may not exceed 30 days.

13 9-A. "Criminal justice agency" means a governmental agency of the State or any 14 subunit of a governmental agency of the State at any governmental level that performs the 15 administration of criminal justice pursuant to statute. "Criminal justice agency" includes 16 the Department of the Attorney General and district attorneys' offices. As used in this 17 subsection, "administration of criminal justice" means activities relating to the 18 investigation of all or specific crimes and the prosecution of offenders.

Sec. 8. 17-A MRSA §1348-A, sub-§4, as enacted by PL 2009, c. 336, §15, is

4. For purposes of a deferred disposition, a person is deemed to have been convicted
when the court imposes the sentence. <u>Notwithstanding Title 15, section 1003, subsection</u>
9, prior to sentence imposition, preconviction bail applies to the person.

24 Sec. 9. 30-A MRSA §1606, sub-§2, as amended by PL 2001, c. 171, §9, is 25 further amended to read:

26 2. Sentence prorated. Inmates participating in a public works-related project or an 27 improvement of property owned by a charitable organization under this section may have their sentences to the jail prorated at the rate of up to one day removed from the sentences 28 29 for every 16 hours of participation in the project, except that inmates committed to the 30 custody of the sheriff for nonpayment of fines under Title 17-A, section 1304 must have their sentences prorated at the rate of \$5 removed from the fines for every one hour of 31 32 participation in the project that is applicable to the individual inmate pursuant to Title 33 17-A, section 1304, subsection 3, paragraph A, subparagraph (1).

#### SUMMARY

This bill implements the following Criminal Law Advisory Commissionrecommendations.

- 1 1. In regard to the prohibition on the possession of firearms for certain persons, it 2 adds an exception to the prohibition for a person under a deferred disposition until 3 sentence imposition.
- 2. In the laws concerning limitations on the authority of a bail commissioner to set bail for an alleged violation of a condition of release, it imposes the same limitations on the setting of post-conviction bail as previously imposed on the setting of preconviction bail for that alleged violation.
  - 3. It makes a technical correction to the laws concerning competency of a juvenile.

4. It adds a justice of the peace to those judicial officers authorized to issue a warrant
to obtain portable electronic device content information and to obtain location
information and, as to the latter, grant an extension of the warrant.

5. In the laws concerning computer crimes in the Maine Criminal Code, it adds a
definition for "criminal justice agency."

6. In the laws concerning deferred disposition in the Maine Criminal Code, it
clarifies that preconviction bail applies to a person on a deferred disposition until
sentence imposition notwithstanding the definition of "preconviction" for purposes of the
Maine Bail Code.

18 7. It replaces an outdated directive to reflect recent changes made to the Maine
 19 Revised Statutes, Title 17-A, section 1304 regarding the proration of sentences for
 20 inmates committed to the custody of a sheriff for nonpayment of fines.
