16 17	'Emergency preamble. Whereas, acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and
18 19	Whereas, current law does not protect from disclosure neuropsychological and psychological testing materials; and
20 21 22	Whereas, disclosure of neuropsychological and psychological testing materials and distribution to even just one person who is the subject of testing or to many persons who may be the subjects of the testing will compromise and invalidate such testing; and
23 24 25	Whereas, maintaining the integrity of the testing materials is critical to test results and to the functioning of the system of neuropsychological and psychological testing in this State and requires the immediate action of the Legislature; and

2	<u>1. Definitions.</u> As used in this section, unless the context otherwise indicates, the
3	following terms have the following meanings.
4	A. "Neuropsychological evaluation" means a testing method through which a
5	neuropsychologist or a psychologist can acquire data about a person's cognitive.
6	behavioral and emotional functioning for purposes of diagnosing or confirming a
7	diagnosis of cognitive deficit or abnormalities in the central nervous system.
8	B. "Neuropsychological or psychological test data" means raw and scaled scores, a
9	person's responses to test questions or stimuli, a neuropsychologist's or psychologist's
10	notes and recordings concerning the person's statements and behavior during a
11	neuropsychological evaluation or psychological evaluation and those portions of
12	neuropsychological or psychological test materials that include the person's
13	responses.
14	C. "Neuropsychological or psychological test materials" means manuals,

25	A. Except as provided in paragraph B, neuropsychological or psychological test
26	materials and neuropsychological or psychological test data, the disclosure of which
27	would compromise the objectivity or fairness of the evaluation methods or process,
28	may not be disclosed to anyone, including the person who is the subject of the test,
29	and are not subject to disclosure in any administrative, judicial or legislative

COMMITTEE AMENDMENT " " to H.P. 820, L.D. 1155

SUMMARY

This amendment, which replaces the bill, retains all of the provisions of the bill and adds an emergency preamble and emergency clause. The amendment adds a definition of "psychological evaluation" and adds protection of psychological test materials and test data. The amendment changes the title to reflect the addition of protections for psychological test materials and data.
