, and "We , owners of shares of common (preferred) stock company represented by certificate No. , owners of bonds No. of , Series company, owners of debentures No. of company, owners of a Series of certain promissory note dated , etc., signed by company, owners of (describe any other security) issued by company hereby agree that our ownership in the above-mentioned property shall be as joint tenants with rights of survivorship as such, and not as tenants in common, in accordance with the Revised Statutes of Maine, Title 33, sections 901 and 902.".
