

§657. Responsibilities of courts

The courts are responsible for: [PL 2011, c. 214, §2 (NEW); PL 2011, c. 214, §6 (AFF).]

1. Complete information. Maintaining bench warrants with information that is as complete as possible and that maximizes the likelihood that the bench warrants will be successfully executed; [PL 2011, c. 214, §2 (NEW); PL 2011, c. 214, §6 (AFF).]

2. Single transmission. Transmitting only one set of data for each instance of a bench warrant's issuance and maintaining an audit record of each transmission; and [PL 2011, c. 214, §2 (NEW); PL 2011, c. 214, §6 (AFF).]

3. Recall notice. Immediately transmitting an electronic notice of recall to the Maine State Police when a bench warrant is recalled.
