Senator **HILL:** Thank you Mr. President. I just would like to address my peers here in the Senate and tell them that the Appropriations Committee came together last week and reviewed the many bond bills that we will now be taking up. We unanimously voted them all out of committee. We're very excited about them. They are much needed. I know that each sponsor will speak in more detail to them. I want to just say that, with regard to the armory bill, I'm very thankful to Senator Tuttle for having brought this bond forward. It's \$14 million. It will go to repair and maintenance of armory property and facilities to stay in compliance with State and federal requirements. I think it's a very worthwhile cause and it goes to infrastructure. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Tuttle.

Senator **TUTTLE:** Thank you Mr. President. Members of the Senate, the Senate President called me when the decision was made on the Appropriations Committee and I told him I'd been working on this issue for 30 years. Every now and then you do something that you think is the right thing and I told him that I really felt very strongly and with my heart that it was the right thing to do. The bill, as you know, authorizes a General Fund bond issue for \$14 million to provide funds for repair and maintenance. I chaired the committee in the other Body a few years back. That was 1996. I went to Stephens Avenue, where I was stationed with the 133<sup>rd</sup> Engineers. It was a number of years later and I still had my name on my old locker from 1981. I said, "Maybe it's time that we get into repairing the armories." I think we're finally doing this. The part of the bond that I particularly was interested in was having a training facility in Maine, with 6,000 acres. When I trained I trained at Gagetown, New Brunswick with a lot of the folks. At the time they were spraying Agent Orange, Agent Black, all kinds of toxic chemicals and never told the soldiers about that. I've lost a lot of buddies in their late 40's and early 50's because of it. In this bond we do have something where we can have the facilities for our soldiers in the state of Maine. It's something I think is a long time overdue. I'm going to be very active in communicating with the general public on how important this issue is and I thank this Body for your support on this most important issue. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Mason.

Senator **MASON:** Thank you Mr. President. Men and women of the Senate, I just wanted to stand and say thank you to the Senator from York, Senator Tuttle, for putting this bill forward. This is very, very needed. As a member of the Veterans and Legal Affairs Committee, we were able to take a tour of the

Gardiner Armory, which is right up the road here, and the building is literally falling down around itself. This is a place that we send our men and women, our soldiers, to be prepared for war. They shouldn't have to get ready and come home to a building that really isn't much better than their circumstances are over in the desert in the Middle East. I am very excited about this. Hopefully the voters will approve it in November. I just wanted to stand and voice my support for it and thank the Senator from York, the Chairman of our committee, for bringing this forward and I'm happy to be a co-sponsor of it. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Washington, Senator Burns.

Senator **BURNS:** Thank you Mr. President. Ladies and gentlemen of the Senate, I just want to reiterate what I just heard a moment ago. I, too, want to thank the Senator from York. When I recently saw some of the pictures of the deplorable conditions that our Guard Armories are in I was personally ashamed as a Maine Legislator. I think it's far past time that we did something. We shouldn't stop here. We should continue until those facilities are brought up to spec, to the position that they should be in, in respect for our men and women who serve in the military. I'm disappointed that we're not getting to talk about other issues that I think were in the bond packages here. Senator **CUSHING:** Point of Order. Is the current discussion germane to the issue before us?

Men and women of the Senate, I have to share with you that I'm particularly excited about this bond because over the course of the last few years the representative and the President of the Community College System have testified before us and they are doing, in my opinion, a wonderful job for people of all ages throughout the state of Maine. They are basically bursting at the seams, which is very exciting. This bond will allow them to start to accommodate many more of Maine's citizen. I think for \$15.5 million we're going to see a huge return on improvements and new construction to infrastructure. This will occur throughout all of the campuses based on a formula that the Community College System had come up with. I think you'll find it's a very fair disbursement of funds and hopefully the public will also vote to pass this. I want to thank Senator Cain for bringing this bond forward. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Cain.

Senator **CAIN:** Thank you Mr. President. Men and women of the Senate, my remarks that I'll make now almost could apply to three of the five bond bills that come before us today that deal with our higher education institutions. This particular bill focuses on the Maine Community College System. The funds will go to all the campuses in the Maine Community College System and have direct impact on the quality of education being able to be offered there. Some of the money is for renovations of old buildings, some for residents' hall space, some for energy efficiency; all with the goal of keeping our Community Colleges accessible, affordable, and be able to live up to the economic driver expectations that we have of them every single day. Community

Senator **LACHOWICZ:** Thank you Mr. President. Men and women of the Senate, I wish to thank my colleague, Senator Cain, for bringing this forward. Kennebec Valley Community College is located right up the road from Waterville. I've taught a class there. It's quite the economic driver in Central Maine. Most of our CMP workers train there because they have a nice lineman program. I can't thank her enough because it is such a training program for many of our young people I've worked with and I can't wait to see what the Kennebec Valley Community College, with their new President, will be doing with the money. **THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Hill.

Senator **HILL:** Thank you Mr. President. Men and women of the Senate, I rise again regarding a bond that I also am very pleased to have come before us. It was very interesting last week when we had some testimony from Ryan Low, who you know is the liaison for the University System. Something he said really struck me. He was describing how many of the facilities are well behind on repair and maintenance just because we have not been able to fund them with an adequate amount of money to look into all of these. What he actually said was, "We no longer pick the projects. In fact, the projects are now picking us." As property owners, you understand that's not the best way to do it. I'm hoping this will be a beginning of them reversing situations so that they start picking the projects. At any rate, this bond for \$15.5 million would, again, be distributed on a formula basis to all six campuses. I think it's a very worthwhile cause. We have a system we're proud of, so let's keep it up. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Cain.

Senator **CAIN:** Thank you Mr. President. Men and women of the Senate, similar to the prior bill, which we just passed, this money reaches all seven campuses of the University of Maine System. The specific focus of this bill, the specific focus of these investments, relate to science, technology, engineering, and math. When you focus on the various projects that will be upgraded at all seven campuses, you will see they will impact future nurses, scientists, science teachers; making sure our labs are safe for our students as they learn and innovate technology and education for tomorrow. They are upgrading, updating, and making sure they are maximizing every dollar that will be invested in all seven campuses of the University of Maine System to maximize the return on investments that we make and maximize the return on investments that students are making in themselves as they head to our universities across the state. I, again, ask for your support and thank you for your support of science, technology, engineering, and math, STEM education. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Somerset, Senator Thomas.

Senator **THOMAS:** Thank you Mr. President. Ladies and gentlemen of the Senate, I would like to be able to vote for this bond issue. I cannot because I've become convinced, like so many of my constituents, that the University of Maine has become too much about money and too little about education. We're sending students to campuses of this institution and they take courses and then when they go to another campus they don't get credit for those courses that they've already taken. They are forced to spend time and money to retake those courses when they shouldn't. I'm told there are 1,118 employees of the University System who make over \$100,000 a year. I believe that's too many. I believe that we need to change the culture at the University of Maine and they need to refocus on education and get their focus off money before I can support issues like this. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Valentino.

Senator **VALENTINO**: Thank you Mr. President. Members of the Senate, this past session the Workforce Committee heard how important STEM is to business and economic growth. I'm excited that this bond improves STEM and laboratory facilities across almost all of our public college and university campuses. For example, at the University of Orono 10,000 square feet of classroom and laboratory space that has not been updated since 1972 will now be modernized. These improvements will help students develop skills that are in demand. They will attract new students to Maine colleges and they will help our businesses and our economy grow with the talent they need. The \$35 million for higher education in particular is a significant investment in Maine's people and will help Maine's current and future workers get the skills they need to succeed in today economy. I urge you to support this bond.

**THE PRESIDENT**: The Chair recognizes the Senator from Aroostook, Senator Jackson.

Senator **JACKSON**: Thank you Mr. President. Ladies and gentlemen of the Senate, I guess I disagree with some of the comments that we made. I don't know how many people at any of the universities make \$100,000 a year. I know that someday I'd like to make \$100,000 a year. I don't begrudge anyone that does. I think the opportunity for people to do that probably comes from education. I know that at the university that I'm closest to, the University at Fort Kent, the nursing program is continually flooded with people that want to get in. They want an opportunity to get a better education and make that \$100,000 a year, hopefully. They can't get it because there isn't enough space available for that. A bond like this, I'm very hopeful, can help a place like the University of Maine expand so they can educate more people so more people can reach up and get that good career that many of us are struggling to find.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Millett.

Senator **MILLETT**: Thank you Mr. President. Members of the Senate, as Chair of the Education Committee for the Senate, I have the opportunity to meet with and discuss educational issues with the Chancellor and trustees of the University System and am most confident that we have excellent leadership in these institutions and that they are listening to the people and to our legislative priorities and that they will use the funds very wisely in the pursuit of what is in the best interest of our students who are seeking to better themselves and better the state of Maine. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Lincoln, Senator Johnson.

Senator **JOHNSON**: Thank you Mr. President. Ladies and gentlemen, for me, this is a very important investment in Maine's future. **THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Hill.

Senator **HILL:** Thank you Mr. President. Ladies and gentlemen of the Senate, we're down to our final bond bill today and it's certainly another exciting one. It's \$100 million for transportation. It will cover multi-modal facilities and statewide bridges and roads. I want to thank Senator Flood very much for bringing this bond package forward. I also want to share with you that, as Senator of District 1, at least for the next year before we flip our numbers, I have the privilege of representing the towns along the Piscataqua River. Of course, if you want to get from New Hampshire to Maine in any fast time, and certainly from Massachusetts into Maine, you have to go over either one of our three bridges down there. We've recently had one totally rebuilt and had an opening about a week ago. The Memorial Bridge. That was extremely exciting. It was on time. It's a beautiful looking bridge. It keeps our communities and our states connected. Now we're moving onto the Sarah Mildred Long Bridge, which originally they thought would only require repairs but now we realize that, too, has to be replaced. There is

considerable dollars involved in that. Of course, we need to move on to the I-95 bridge. These are all gateway bridges. I realize that if we're going to get people and products into Maine we need these bridges. If we're going to get them into your district we need these bridges. It's so important to have this transportation bond because those bridges, alone, are taking up a considerable amount and yet we have a whole state, a huge state in terms of infrastructure, and many people to take care of. I want to know that we can get this bond through and I'm sure hoping that the people of the state of Maine agree with us and vote it through as well so that we can continue to improve our system and take care of as many parts of the state as possible. I hope this is the beginning to many, many more bonds for transportation. Thank you. I hope you will support this fully.

**THE PRESIDENT:** The Chair recognizes the Senator from Kennebec, Senator Flood.

Senator **FLOOD:** Thank you very much Mr. President. Ladies and gentlemen of the Senate, I am pleased to sponsor this bill and I did want to take the time to thank the leaders in this building, including the Executive and his staff, for negotiating a good package, including this bill. Clearly, it is a good package, given the support of the bills that have come before us today. I did want to say what I thought was particularly strong about this bill was the fact that the Commissioner of the Department of Transportation had keyed up quite a few priorities in this bill so that it made it very clear as to where the priorities were for the department. I think that showed a very organized effort on their behalf. I did also want to thank the Senators from York, Senator Hill and Senator Collins, for being co-sponsors on this bill. I certainly support it and I appreciate the opportunity to speak on it. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Cain.

Senator **CAIN:** Thank you Mr. President. Men and women of the Senate, I rise to support the final bill in this quintet of bond bills that we've had today. The final one that literally paves the way not just to the close of our special session but paves the way to jobs and work that people in Maine will actually see and feel as they hit fewer potholes, as they hear fewer creaks as they cross the bridges, and as they see more activity on our waterways. I do have to say, Mr. President, that it is also my hope that this bill, in its size and scope and bipartisan support, will pave the way to discussions of future investments in other areas so that businesses across our state can grow to use these roads and bridges, to move materials and goods across the state, and people across Maine can travel to work safely every single day. It is my hope, Mr. President, that, as a Legislature and working with the Chief Executive and the other Body, we will be able to build on this support in the next session to expand our support in our investments to other areas; some mentioned earlier, including R and D and others. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Collins.

Senator **COLLINS:** Thank you Mr. President. Ladies and gentlemen of the Senate, I have been lucky enough to be a member of the Transportation Committee my full tenure here in



the Legislature. Right now it's been eleven years that I've been on the committee. I just have to say that we all realize how vitally important the transportation bond is to maintaining Maine's infrastructure, roads, bridges, and highways. Equally important are the people that these projects employ. It's kind of dual facet. It maintains our infrastructure, but also employs the hardworking men and women here in Maine on these projects, regardless of where they are located. The project could be in Madawaska, it could be in Kittery, it could be in Eastport, or it could be in Farmington. They are all equally important to the people who use those roads and bridges across the state of Maine. I encourage the membership and the members of the Senate to vote in the positive for this bond. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Knox, Senator Mazurek.

Senator **MAZUREK:** Thank you Mr. President. I just wanted to voice my support for the transportation bond bill. Over the years the people of Maine, at the polls, have shown that they are very supportive of transportation. Every year, every time we have it on the bond they seem to come out in good numbers and support it. I think it's vitally important that, in this world of competition, if we're going to be competitive we've better have the means and the mode so that our industries and our people can be competitive. One of the things that we can provide them is a good infrastructure so that our goods and ideas can get from place to place as quickly and as efficiently as possible. I am fully supportive of this and my only wish is that we had more money to put into infrastructure because it is certainly needed. I hope you all support this with the same enthusiasm that I do. Thank you.

This being a Bond Authorization Act, in accordance with the provisions of Section 14 of Article IX of the Constitution, having received the affirmative vote of 32 Members of the Senate, with no Senators having voted in the negative, and 32 being more than two-thirds of the Members present and voting, was **PASSED TO BE ENACTED** and having been signed by the President, was presented by the Secretary to the Governor for his approval.
