**JOINT RESOLUTION  
TO RECOGNIZE JANUARY 24 TO JANUARY 30, 2016 AS  
HUMAN TRAFFICKING AWARENESS WEEK**

**WHEREAS**, human trafficking is a form of modern-day slavery that violates basic human rights, denies victims personal freedom and knows no geographical boundaries; and

**WHEREAS**, human trafficking is the crime of recruiting, harboring, transporting, providing or obtaining a person for compelled labor or commercial sexual exploitation through the use of force, fraud or coercion, including but not limited to involuntary servitude, sex trafficking, debt bondage, domestic servitude and forced child labor, and can, but does not necessarily, include the physical transportation of a victim from one location to another; and

**WHEREAS**, human trafficking is recognized as the fastest-growing criminal enterprise in the world and the International Labour Organization estimates annual profits of \$150,000,000,000 from forced labor internationally; and

**WHEREAS**, the International Labour Organization estimated in 2012 that 26% of persons trafficked were children and the National Center for Missing and Exploited Children estimated in 2014 that one out of every 6 endangered runaways in the United States reported to them were likely child sex-trafficking victims; and

**WHEREAS**, victims of human trafficking suffer severe emotional, psychological and physical damage at the hands of their traffickers, who instill fear in their victims in order to keep them enslaved, resulting in complex post-traumatic stress disorder and increased rates of disease, drug addiction and other lifelong effects of trauma, and these experiences require years of trauma-informed health care and mental health services as part of a victim's recovery upon intervention; and

**WHEREAS**, human trafficking exists in the State and many state, federal and local agencies and organizations are working to prevent human trafficking, to intervene when human trafficking is discovered and to provide restorative care to victims; and

**WHEREAS**, no one person, organization, agency or community can eliminate human trafficking, but we can work together to educate our entire population about how we can all prevent human trafficking and support survivors of human trafficking and their communities; and

**WHEREAS**, the State is committed to protecting the vulnerable and ending human trafficking through prevention, prosecution, education and awareness; now, therefore, be it

**RESOLVED:** That We, the Members of the One Hundred and Twenty-seventh Legislature now assembled in the Second Regular Session, on behalf of the people we represent, take this opportunity to recognize January 24 to January 30, 2016 as Human Trafficking Awareness Week.

**READ.**

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Volk.

Senator **VOLK:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I just wish to speak very briefly and call your attention to the fact that next week, January 24<sup>th</sup> to January 30<sup>th</sup>, is Human Trafficking Awareness Week and January has actually been Human Trafficking Awareness Month. I would welcome you reading this Joint Resolution. I'm not going to take up your time reading it this morning, but this continues to be a challenging issue in Maine, particularly one of the things that we know we've heard so much about our drug crisis and our addiction crisis and so many of these people actually fall victim because of their addictions and they are taken advantage of and very, very often human trafficking, particularly sex trafficking, goes hand-in-hand with drug trafficking and so we know that this is continuing to be an issue in Maine and something that the top members of our government, including ourselves, are all very concerned with and so I just urge you to continue to educate your constituents about this issue and about making sure that they know what some of the warning signs are and that they don't hesitate to report those to the police. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Gerzofsky.

Senator **GERZOFSKY:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I rise today in total support of this issue that we're talking about. I often say there's nothing really new under the dome. We hear some of the same issues year after year after year. I remember very clearly when this issue first came in front of the Criminal Justice and Public Safety Committee. We had, at the time, Senator Lisa Marrache who brought that bill in front of us to talk about it. We had people come in from the Council of State Governments to explain to us. I was a little bit of a skeptic, as I am on a lot of bills that come into Criminal Justice, because it was a term I really wasn't familiar with. I had heard it at some forums around the country, but I really wasn't that familiar with it. I knew all about what prostitution meant. I knew all about what trafficking meant, but not the term. We held hearings and then we set up a task force. It just happens to be that the Senate Chair of that task force is my seatmate, Senator Diamond. We have history in this Body on the subject and, as I heard the previous speaker mention, Senator Volk, it affects us here in Maine. This is a very, very important Resolution. This is a very important subject. The people that we are trying to protect are sitting in front of us today. At the time we had a hard time understanding how Maine could possibly be a destination. It wasn't, but it was certainly a go-through state. It was certainly a place where this kind of trafficking was going on

and, through the task force's work and through the committee's work and through the good Senator's work, over the years we've made this a very serious topic in the state of Maine because it should be and it really is. It's time that we do these things. I hand a lot of credit to Senator Volk for bringing this forward and making it really stick and making it really rise to the level that it deserves. These kinds of actions cannot be done in Maine. We protect our people far better than that and, like we do often, we led a lot of states in taking this subject seriously, putting some stiff sentences with it, putting a task force together to look at what it really means, and it wasn't done yesterday, it's been done over the course of time. I believe the task force first came in in the 123<sup>rd</sup> Legislature. We're in the 127<sup>th</sup> now. We're still trying to make this a top priority for the state of Maine. Very similar, Mr. President, to what we did with drugs earlier this week, to bring it forward and let the people of Maine know that it is here and that we are going to do something about it. Thank you very much for allowing me the time to speak, but this is very important for us to get behind. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Haskell.

Senator **HASKELL:** Thank you very much, Mr. President. Colleagues of the Senate, I rise to speak briefly, obviously in support. I think it's important and interesting that it comes up on this day, which is Women's Day in the Maine Legislature. This is not an issue which impacts only young women, it also impacts young men, but by in large the huge number of these are young women and this is one of those places where you begin to apply the "my child" test. There but for the grace of God go any one of us, understanding how these things happen. I think that what the good Senator brings forward to us is an opportunity to raise our awareness about this matter, to begin to understand the implications of substance abuse disorders, as well as many other issues, which are intertwined and I commend the presentation of this Joint Resolution and am in full support. Thank you for your time, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Diamond.

Senator **DIAMOND:** Thank you, Mr. President. Ladies and gentlemen of the Senate, just briefly. I really support this Resolution and thank the good Senator for bringing it forward today. As you heard, in 2006 there was a task force and we took that very, very seriously and we really got into information that was new to all of us, both international and national information. We found out how extensive trafficking is and what struck me the most, and I think others as well, was the realization in discovering that children, little children, were involved in trafficking as well. Sometimes we tend to think it may be just older teens, which is horrible, or adults, which is horrible as well, but when we got into the fact that there were children involved, young children involved, in this it really kind of brought, certainly me, us to attention on this whole issue and I think, of the task force, maybe the most important recommendation that came out of that was that trafficking victims would be treated as victims and have victims' rights. That really was a step forward because until then that really hadn't been the case. There had been an assumption made which is totally erroneous. A great Resolution. Thank you for putting this forward. As Senator Gerzofsky said, this has been

around, but I think it's nice that it is still and maybe rising to a higher level today. Thank you, Mr. President, for the opportunity to speak.

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Mason.

Senator **MASON:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I just wanted to extend my thank you to the Senator from Cumberland, Senator Volk, for sponsoring this Resolution. I know this has been a subject matter that she has really taken on over the past few years and I appreciate her involvement. I wanted to also bring up and make note of the people who go into harm's way to save the victims of human trafficking. I have a friend that is living in Thailand right now and she is doing just that every single day and saves men and women who are captured, essentially, in the sex trade. She risks her life every day to do what she does, so there's a lot of good people out there that are doing a lot of great work around the world, not just in our country but everywhere. I just wanted to bring attention to that. Thank you, Mr. President.

The land is chosen in a proper way and it is a wonderful program that we should all be in support of today by pushing our green light. Thank you very much, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Lincoln, Senator Johnson.

Senator **JOHNSON:** Thank you, Mr. President. I rise today to also thank actually all of the Senate and the other Body for moving this forward and finding a way to live up to our promise to people like the Priors in Bremen who were approved for a working waterfront project a year ago this past November and now will be able to fulfil that promise and I thank you for your assistance.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Gratwick.

Senator **GRATWICK:** Thank you, Mr. President. Ladies and gentlemen of the Senate, a program like this really rests on the specifics. In Bangor we now have a city forest, as well as land trust lands, that are nearly 1,200 acres. That is two square miles of wild land. I'm delighted to tell people that you can go downtown Bangor and have a wonderful meal. You can do many things in Bangor. You can also get lost in the wilderness within the city limits of Bangor. You can see bear, moose, and many other things. This is a remarkable thing. This is what makes Maine special and I think this is significantly due to this bonding. Thank you very much, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Aroostook, Senator Edgcomb.

Senator **EDGEComb**: Thank you, Mr. President. Ladies and gentlemen of the Senate, I'm not blaming anybody but I am disappointed that less than 1% of Land for Maine's Future money is spent in Aroostook County. I just felt I had to make that statement and hopefully those that serve on that committee will take that into consideration the next time and support projects. Thank you.

**THE PRESIDENT:** The pending question before the Senate is Final Passage. A Roll Call has been ordered. Is the Senate ready for the question?
