The following Joint Resolution: H.P. 1373

**JOINT RESOLUTION MEMORIALIZING THE PRESIDENT OF THE UNITED STATES AND THE CONGRESS OF THE UNITED STATES TO RATIFY THE UNITED NATIONS CONVENTION ON THE RIGHTS OF THE CHILD**

WE, your Memorialists, the Members of the One Hundred and Nineteenth Legislature of the State of Maine, now assembled, in the First Regular Session, most respectfully present and petition the President of the United States and the United States Congress, as follows:

WHEREAS, children's rights require special protection and continuous improvement all over the world, as well as calling for the development and education of children in conditions of peace and security; and

WHEREAS, the United Nations has proclaimed that the period of childhood is entitled to special care and assistance; and

WHEREAS, the child should grow up in a family environment with happiness, love and understanding; and

WHEREAS, the child should be fully prepared to live the life of an individual in society; and

WHEREAS, the child should be brought up with dignity in a spirit of peace, tolerance, freedom, equality and solidarity; and

WHEREAS, in all countries of the world, there are children living in exceptionally difficult conditions; and

WHEREAS, it is important to have international cooperation in order to improve the living conditions of children in every country, in particular in the developing countries; and

WHEREAS, the United Nations Convention on the Rights of the Child has broken all records as the most widely ratified human rights treaty in history; and

WHEREAS, the convention is the most rapidly and widely adopted human rights treaty in history with 191 States Parties; and

WHEREAS, only 2 countries have not ratified this agreement, Somalia and the United States; and

WHEREAS, the uniqueness of the treaty is that it is the first legally binding international instrument to incorporate the full range of children's human rights, which include civil and political rights as well as their economic, social and cultural rights, thus giving all rights equal emphasis; now, therefore, be it

**RESOLVED:** That We, your Memorialists, request the President of the United States and the United States Congress to ratify the United Nations Convention on the Rights of the Child; and be it further

**RESOLVED:** That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Honorable William J. Clinton, President of the United States; the President of the United States Senate; the Speaker of the House of Representatives of the United States; the United Nations Secretary-General Kofi Annan; each Member of the Maine Congressional Delegation; the Speaker of the House or the equivalent officer in the 49 other states; and the President of the Senate or the equivalent officer in the 49 other states.

### JOINT RESOLUTION MEMORIALIZING THE PRESIDENT OF THE UNITED STATES AND THE UNITED STATES CONGRESS TO SUPPORT A WORLD WAR II MEMORIAL

WE, your Memorialists, the Members of the One Hundred and Nineteenth Legislature of the State of Maine now assembled in the First Regular Session, most respectfully present and petition the President of the United States and the United States Congress, as follows:

WHEREAS, in 1987, United States Representative Marcy Kaptur, at the suggestion of World War II veteran Roger Durbin, introduced legislation to establish a memorial to honor all who served in the Armed Forces of the United States during World War II and the entire nation's contribution to the war effort. The legislation failed, but the interest in having a memorial gained patriotic support and subsequent legislation prevailed; and

WHEREAS, federal Public Law 103-32 authorizing a World War II Memorial in the District of Columbia or its environs was signed into law on May 25, 1993; and

WHEREAS, the Memorial Advisory Board was created to advise the American Battle Monuments Commission in site selection and design and to promote donations to support the memorial construction; and

WHEREAS, a memorial design by Freidrich St. Florian at the site of the historic Rainbow Pool on the National Mall was approved; and

WHEREAS, former Senator Bob Dole and Frederick W. Smith, CEO, Federal Express, were named as National Co-chairmen of the World War II Memorial Campaign; and

WHEREAS, news of the World War II Memorial is currently being spread throughout the country, to every city, town, church, synagogue, mosque, business, civic group, veterans' organization and every other organization that comprises a part of our American culture; now, therefore, be it

RESOLVED: That We, your Memorialists, request the President of the United States and the United States Congress to offer support in obtaining the necessary financial resources to help the World War II Memorial take its rightful place in history; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Honorable William J. **THE PRESIDENT:** The Chair is pleased to recognize in the rear of the Chamber Pete Pedersen, 1999 Maine Teacher of the Year. He is a math teacher at Vinalhaven High School. Pete is also a tenth generation Maine islander, originally from Peaks Island in Portland. He is the guest of the Senator from Knox, Senator Pingree. Would he please rise and receive the greetings of the Senate.

**THE PRESIDENT:** The Chair recognizes the Senator from Knox, Senator Pingree.

Senator **PINGREE:** Thank you Mr. President. Women and men of the Senate, this is truly a day for recognizing some of our heroes and I'm not sure I can do it as eloquently as my colleagues but I just wanted to add a little bit about one of my heroes and a truly wonderful teacher, Pete Pedersen from Vinalhaven. He is here today because we are recognizing the 23 nominees for Maine's Teacher of the Year 2000 and he will be speaking this afternoon to that group who, one of them, will join him in this great honor.

I just want to say a little bit about this recognition. Pete has been a math teacher on Vinalhaven for 23 years and I have to say that being a teacher on an island is not easy, just like being a teacher in many of Maine's small towns. When you live on an island and you teach school you can't commute home to the next town at the end of the day. In fact, you're stuck there every day and when you go to the store or when you go to the gas station or you go down to buy lobsters at the wharf, everybody has something to say to you about how you teach school, how you corrected their son's or daughter's last paper, and about how they think that you could do it. I think all of the teachers who dedicate themselves to teaching on islands have our great respect and appreciation. Pete is certainly one. Pete is not only known as a wonderful teacher but he is known as a real outstanding member of our community. He is involved in a tremendous number of community activities. Cooks breakfast at the church every Sunday morning, has a card party at his house every Friday night for some of the senior women who love to spend time with him, and is also the keeper of seven or eight stray cats who he takes care of and is known for giving them good care.

For Pete to receive this honor as Teacher of the Year is an honor that is truly well deserved. Not only is he an excellent math teacher, he has also led the math team for many years. And since 1991 they have been the winners of the math competition in their region in the state of Maine and since 1993 have been nationally recognized. He's brought the team to places as far afield as Hawaii, Alaska, Florida, Louisiana and Ohio. He often makes sure that the kids make enough money to take a trip while they're gone and for these kids who have grown up on an island of 1,200 people and many of whom never traveled as far as Boston, this has been a truly wonderful experience. I just have to

say in closing that Pete truly is a wonderful teacher, one of those rare teachers who has an excellent rapport with his students, who is trusted by them as a personal friend as well as a great teacher. In the math team and what he's done with them, he's truly shown kids that there are possibilities that they never imagined possible and opened their eyes to places that they never thought they could visit. So I thank you all for recognizing him today. I thank Pete for his great work on behalf of our island communities and know that we all appreciate him very much.

Senator **HARRIMAN:** Thank you very much, Mr. President. Good morning ladies and gentlemen of the Senate. I present to you today Senate Amendment "A" that will eliminate the exemption for smoking in hotel lounges, Class A lounges, Class A restaurants, and lounges and taverns. I do so because yesterday we learned through an overwhelming vote in this body as well as in the other that workplace safety includes second hand tobacco smoke. The message we sent through that vote was that this is one of our most menacing workplace problems. If we care enough about the workers who are working in Class A restaurants than I say to you we ought to care about the people who are working in hotels, lounges, bars, and taverns. This Amendment will affirm to those people who work in these environments that we care just as much about them as we do about people who work in restaurants. So I hope that you will join me in supporting the pending motion so that we can improve the workplace for everyone who works in this industry. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Arostook, Senator Paradis.

Senator **PARADIS:** Thank you Mr. President. Men and women of the Senate, I dealt with this issue yesterday, but happy to repeat it today. We have been doing the smoking ban in incremental stages. This is what we have accomplished this year and we would like to keep the Bill as it is. We are very well aware of the issues of smoking in this state and the tremendous cost to

the taxpayers of taking care of people who are very ill at this time with cancer. It's a huge cost to the State of Maine and so I urge defeat of this motion to leave the Bill as it stands. Thank you.

The Chair ordered a Division.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Harriman.

Senator **HARRIMAN:** Thank you very much Mr. President. Ladies and gentlemen of the Senate, I offer to you Senate Amendment "B" to LD 1349. As it is obvious from our last vote that this is really not an issue about workplace safety but rather, as my good friend from Aroostook, Senator Paradis, has indicated that this is something we're going to do incrementally. That we're going to address this problem in the workplace a little bit at a time and I presume that means that at some future date we'll be back to address the issues that the Amendment I had before you that Failed tried to address today. With that vote, Mr. President, it now is clear that what we are doing is we are creating an environment where many of the people who are in your district and in fact in mine, who operate facilities are going to be put at a disadvantage. Let me explain to you why. Currently if you are a Class A restaurant you pay an \$800 license fee and the legislation that passed here yesterday would prohibit smoking in that environment. If you are licensed as a lounge, you pay a \$2,100 fee for this license and as of the vote that we've taken today you will be able to smoke. You can also have another license that is a restaurant/lounge. That fee is \$1,500. There are 184 of these licenses around the state who are both a restaurant and a lounge. As a result of the vote that has been taken, those businesses will now have to make a choice. Let me just share with you one example of the facilities in my district and I know there are

many in yours as well. One of them is named Joshua's Tavern. The other is known as Benzoni's Brick Oven Pizza. Both operate a small family business on Main Street in Brunswick. Now that this legislation has passed, they are going to have to make a choice. If they want to operate as a lounge where they can allow smoking, they will have to say no to all of their Bowden College student clientele who are under age 21 because they are not allowed in lounges. If they say well we're going to operate as a restaurant, not as a lounge therefore no smoking will be allowed, their smoking customers will now have an open invitation to go to one of their competitors down the street, creating an unlevel and unfair playing field. What's ironic, at least to me and hopefully to you as well, is that both restaurants and lounges serve food. A so-called limited menu is allowed in taverns and lounges which enables them to serve alcohol as well as food and by your vote enables them to allow smoking, which is unfair. What I propose in Amendment "B" is that anyone who holds a license as of March 1, 1999 who holds a license as a restaurant/lounge maintains the exemption that you have created for lounges and taverns and lets the customers and the small business owners decide how to operate their own business. If as my good friend from Aroostook, Senator Paradis, indicates we will incrementally come back and address taverns and lounges, then we can address this issue as well. But in the meantime let's keep it fair for all of the businesses who are serving alcohol and a limited menu. This Amendment does that and I hope you will join me in supporting it. I thank you very much, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Aroostook, Senator Paradis.

Senator **PARADIS:** Thank you, Mr. President and men and women of the Senate. None of us can presume what the 120<sup>th</sup> Legislature is going to be doing, what Bills they will be proposing. I urge you to defeat this Amendment. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Douglass.

Senator **DOUGLASS:** Mr. President, reading this Amendment it is clear that it establishes a grandfather clause to certain restaurants that have certain types of licenses as of a certain date. That would create an unequal playing field, in fact, because what would happen is then you're creating an incentive against new business. Small business is the life blood of our economy in Maine. Restaurants are part of that economy. We must do what we can to make sure that the playing field is level. This establishes a grandfather clause for those businesses in a certain category and that is not the way we should be doing business. I will vote against it.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Harriman.

Senator **HARRIMAN:** Thank you very much Mr. President. Ladies and gentlemen of the Senate, it is the small business person that I'm standing up for today. I'm standing up for the Siatrias family and the Kyle family and many others who have invested their hard earned money, they put their net worth on the line to borrow money to operate a business within the scope of the law that in this case involved putting in expensive ventilation equipment to comply with the law to meet the needs of their customers. Without this Amendment, we're going to put these businesses, and their capital at risk, for the investments they made under our laws, and we're going to invite their customers to go somewhere else. It seems to me that this Amendment says to them

we respect the fact that you've made this investment. We respect the fact that your competitors are going to be allowed to have customers who are allowed to smoke while yours can't. This gives them an opportunity to continue to run their business without an unfair competitive disadvantage as we move forward, apparently in future Sessions, to rid all workplaces of tobacco smoke. Thank you, Mr. President.

Senator **AMERO**: Thank you, Mr. President. As many of you may remember, we did discuss a Joint Resolution memorializing Congress to pass one particular Prescription Drug Act. It is one of several Prescription Drug Acts being considered by the United States Congress. This particular act happens to be sponsored by Congressman Allen of Maine. However we are not privy as a Maine Senate to the details of that particular act nor are we privy to the details of the other Prescription Drug Acts that are being considered in the US Senate and the US Congress. I feel that as the Maine Senate we have plenty of our own Bills to consider and until we examine all or unless we want to examine all of the Bills of this type that are before the US Congress, that we should not be urging Congress to vote for one particular act. So I have proposed an Amendment which would eliminate any reference to a particular act but would put the Maine Legislature on record as encouraging the US Congress and US Senate to act on an issue which is very important to all of us and an issue that is, in a very bi-partisan manner, being addressed in our own state. That is that we find more readily affordable and accessible means of providing prescription drugs for our elderly. So with that I would move Adoption of this Senate Amendment. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Knox, Senator Pingree.

Senator **PINGREE**: Thank you Mr. President. Men and women of the Senate, I rise to differ with my colleague from Cumberland, Senator Amero. I think that all of us are actually privy to the details of this piece of legislation. It's available on Congressman Allen's website. I know I've procured a copy of the Bill and read it myself and feel very confident that it's the kind of Bill that would help senior citizens in Maine a great deal. There are, as far as I understand, only two Bills in front of Congress right now, there are not several Bills in front of Congress. One would change the Medicare rules to make sure that Medicare covered all prescription drugs, which I would be strongly in favor of. I'm just afraid that it won't pass during this legislative session of Congress because there are so many other demands on the budget this time that I think the price tag of that may be too great.

This Bill, as I just passed out on a fact sheet to explain a little bit better to you, has been brought about because there has been widespread price discrimination throughout the country for seniors buying prescription drugs. All of us have heard many times the stories of seniors who have to choose between paying their oil bills, buying food, or paying the cost of prescription drugs. Price discrimination is a serious problem with older Americans and this Bill would help to counter it. It would allow pharmacies to purchase prescription drugs for Medicare beneficiaries at lower prices and would be a direct benefit to seniors. It has many co-sponsors and I think it's something that all of us can feel very comfortable standing behind. I do want to draw your attention to this Amendment. It strikes out not only reference to this piece of legislation but it strikes out two other paragraphs which I think convey the feelings that certainly I have experienced as one who's been an active participant in this issue throughout the state. One of the paragraphs that would be gone says whereas older Americans who are often on fixed and limited incomes pay on the average nearly double the price for prescription drugs that the favored customers of the pharmaceutical companies pay and whereas now there is before Congress legislation that would address this inequity by protecting the elderly from drug price discrimination and making prescription drugs available to Medicare beneficiaries at substantially reduced prices. Both of them are paragraphs which I feel very comfortable supporting as I do this Resolution. I'm well aware that Joint Resolutions to Congress do not necessarily change their minds, do not necessarily bring about the action that we hope, but I think that this is a symbolic act for us. It says that we stand behind lowering the prices of prescription drugs for seniors and it is one more way that we can help to influence Congressional policy as a legislature in Maine. I hope that you will all support the Joint Resolution and vote against this Amendment, which I believe takes away the intent of the Joint Resolution and does not allow us the opportunity to give a strong message to Congress that we believe seniors should be able to afford the cost of prescription drugs. When the votes are taken, I request the Yeas and Nays.

On motion by Senator **PINGREE** of Knox, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

**THE PRESIDENT:** The Chair recognizes the Senator from Oxford, Senator Bennett.

Senator **BENNETT**: Thank you Mr. President. Fellow members of the Senate, as if we don't have enough Bills of our own to deal with, we're now debating Bills before the US Congress. In my opinion, if we're going to be doing that, if we're going to get into the thick of debates on Capitol Hill in Washington DC, we ought to do it right. Therefore, I move that this Resolution be Referred to the Joint Standing Committee on Health and Human Services where it can be properly debated instead of taking up our precious time on the floor of the Senate. Have some consideration of it. Consider the way it should be worded and then we can bring it back. Thank you.

Senator **BENNETT** of Oxford moved to **REFER** to the Committee on **HEALTH AND HUMAN SERVICES**.

**THE PRESIDENT**: The Chair recognizes the Senator from Knox, Senator Pingree.

Senator **PINGREE**: Thank you, Mr. President. I heard what the good Senator from Oxford, Senator Bennett, said and I feel sort of along with his same argument that Committees are busy this Session. We have a tremendous number of Bills. Joint Resolutions to Congress are just what they are. What you see is what you get. I hope people will be in support of this and can support it on its merits based on the facts that I've given you. I certainly feel very comfortable sending my message to Congress as is and don't want to burden the Committee who has already dealt with many of these issues and is dealing with them in their own way. I don't want to burden them with further workloads. I hope you vote against the pending motion to Refer to Committee, vote against the Amendment and vote for the Joint Resolution so we can give Congress a strong message that we support lower cost prescription drugs for senior citizens.

**THE PRESIDENT**: The Chair recognizes the Senator from Oxford, Senator Bennett.

Senator **BENNETT**: Thank you Mr. President. Fellow members of the Senate, we cannot have it both ways, either this is an important measure and deserves inspection and evaluation through the legislative process or it's not. In my view, if it is as has been suggested, an important contribution to the Federal debate, then we ought not just to take the word of one member of this Body or of several members of this Body. We ought to have the legislative process as its been devised and worked so well for so many decades work. So therefore I ask for the Yeas and Nays.

On motion by Senator **BENNETT** of Oxford, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

**THE PRESIDENT**: The Chair recognizes the Senator from Kennebec, Senator Carey.

Senator **CAREY**: Thank you, Mr. President. I would like to pose a question if I might.

**THE PRESIDENT**: The Senator may pose his question.

Senator **CAREY**: Thank you, Mr. President. I just listened to the Majority Leader and am I to assume that we will not be having any more new Bills coming in?

**THE PRESIDENT**: The Chair would answer that that is not in the control of any member of this Body.

The pending question before the Senate is the motion by the Senator from Oxford, Senator Bennett, to **REFER** this Joint Resolution to the Committee on **HEALTH AND HUMAN SERVICES**. Is the Senate ready for the question?

Senator **SMALL**: Thank you Mr. President. Men and women of the Senate, I just wanted to rise today to let you know why I will be voting against this. A number of the reasons were already stated by my good colleagues in the back row here but I find this troubling. In the years that I've been here I don't recall only having an opportunity to see one Bill that is presented and then having an up or down vote on that one Bill. It's my understanding that there are a number of initiatives that deal with this very serious and very crucial problem going on before Congress. If we are indeed going to start legislating our will to Congress or presenting our legislative will, I think it's only fair that we have an opportunity to review all the Bills that Congress is looking at because, indeed, we may be short changing our senior citizens.

This may not be the best Bill. This Bill may not go as far as other Bills. This Bill may be more costly than other Bills. I, for one, would like to see what all the Bills are that are being considered before I cast my vote for any one Bill. I just don't think it makes any sort of sense to only vote for one Bill. I understand that it does come from our home Congressman and I think it's a good thing that he is down there fighting for this. But, if he does not have the best Bill I'm not going to lend my support for his legislation over something else that may in fact serve my residents and my constituents better. So for that reason, until we have an opportunity to see what all the competing measures are and have a fact sheet on all the measures, not just one, I simply cannot support one piece of legislation over another. That's why I will be voting Nay. Thank you.

Senator **AMERO:** Thank you Mr. President. Ladies and gentlemen of the Senate, I am concerned about the way the votes are going so far on this particular issue because I don't think that this is a partisan issue. I don't think there's a person in this Chamber that doesn't care about finding a more affordable way of providing prescription drugs to all of our citizens but particularly to our senior citizens. That's why I brought forward this Amendment because it is a bi-partisan approach to asking Congress to solve the problem. Remember that a special commission has been working now for well over a year on addressing Medicare issues and how to better provide access to prescription drugs for our senior citizens. They've been working on it for well over a year. They've come up with a Divided Report. It's not an easy subject. There may be a very good approach that all of our Congressmen and Senators in Washington working together may come up with. A solution that they all can support. That's why I ask you to consider seriously sending a message to Congress that we in Maine care about this issue and we want you to work together the way we're working together here in the state of Maine to do the best we can to reduce the cost of prescription drugs. So I would urge your support of this Amendment. Thank you, Mr. President.
