**JOINT RESOLUTION COMMEMORATING MARCH 25TH
AS GREEK INDEPENDENCE DAY**

WHEREAS, March 25, 2001 marks the 180th anniversary of Greece's liberation from Turkish rule; and

WHEREAS, former President Clinton, during a visit to Greece on November 20, 1999, referred to modern Greece as a "beacon of democracy, a regional leader for stability, prosperity and freedom, helping to complete the democratic revolution that ancient Greece began..."; and

WHEREAS, Greece is only one of 3 nations in the world, beyond the former British Empire, that have been allied with our nation in every major international conflict in the last 100 years; and

WHEREAS, America's founders drew heavily upon the political experience and philosophy of ancient Greece in forming our representational democracy and these and other ideals have forged a close bond between our 2 modern nations; and

WHEREAS, the State of Maine would like to join its thousands of residents of Greek ancestry who are justly proud of their Greek heritage to recognize Greek Independence Day as a gesture of goodwill and recognition of the close bond between our 2 nations and their people; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twentieth Legislature of the State of Maine now assembled in the First Regular Session, on behalf of the people of the State of Maine, commemorate March 25th as Greek Independence Day as we all celebrate Greek and American democracy; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Ambassador of Greece to the United States in Washington, D.C. and to the Consulate General of Greece in Boston, Massachusetts, as a symbol of our recognition of Greek Independence Day.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Douglass.

Senator **DOUGLASS:** Men and women of the Senate. This bill is about allowing large retailers to use liquor as a loss leader; liquor as a loss leader with a discount of as much as 33%. That's not sound public policy. This bill, if you adopt it, also will have the effect of encouraging ma and pa grocery stores to go down to Wal-Mart, buy their 30 pack of beer for \$9.99 and then resell it at that cost in their own stores. Why would they do that? And it's breaking the law. Because they are not able to sell liquor at the loss that the large retailers are able to. This bill is about sound public policy for Maine. It's about protecting ma and pa stores that sell liquor and about keeping our retailers out of the business of using liquor as a loss leader. I hope you will join me in voting for the recede and concur motion.

THE PRESIDENT: The Chair recognizes the Senator from Franklin, Senator Woodcock.

Senator **WOODCOCK:** Thank you, Mr. President. Good morning to the men and women of the Senate. The loss leader principle is a principle that is a retail principle. The discussion this morning focuses upon what is sound public policy, as mentioned by the Honorable Senator from Androscoggin. For my means, sound public policy is the non-intervention of government in the retail sector. The ill-wind that blows over this state at times, across the plains of retail, is government intervention. The more we refrain from intervening in retail sales, the better off we will be as a mechanism of regulation in this state. I would urge a vote opposing the recede and concur motion. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Martin.

Senator **MARTIN:** Mr. President, members of the Senate, let me first begin by indicating to you that I have a business which has a liquor license. I view that liquor license, in part, as a responsibility so that minors do not buy liquor. But what I fear with this legislation is the ability of minors to get more because it will be cheaper. Remember, this is used as a loss leader and if you use liquor as a loss leader or use cigarettes as a loss leader then you provide an opportunity for minors to get more of it. If you don't think that's going to happen, I encourage you to come to small

stores and see what's going to happen. It is not a question of whether or not we participate in free enterprise. It's whether or not the state has a responsibility in trying to limit the amount of liquor sales. It's really very simple from my point of view. So if you want to have minors acquire more, than I would suggest you vote against the motion to recede and concur. If you want to try to limit, then you ought to do just that, and that is to vote to recede and concur. It is not a matter of free enterprise, liquor is not and should not be a question of free enterprise. It's a question of whether or not the state is going to have any responsibility in attempting to control the amount of what goes into the hands of teenagers.

Senator **BROMLEY:** Thank you, Mr. President. I represent the communities of Cape Elizabeth and South Portland, who are, under this budget, going to be hit very hard to the tune of over \$800,000 in GPA reductions. This amendment would restore that, not only for my community, but for other communities that

were also harmed in the GPA funding. It would simply transfer this money from the Maine Learning Technology Endowment Fund. It would be in the spirit of the committee's work by moving education money to education. I urge its passage. Thank you.

Senator **CATHCART** of Penobscot moved Senate Amendment "B" (S-26) to Committee Amendment "A" (H-55) be **INDEFINITELY POSTPONED**.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Cathcart.

Senator **CATHCART:** Thank you, Mr. President. Men and women of the Senate. I urge you to vote with me for the indefinite postponement of this amendment. The Appropriations Committee included an additional \$3 million in our committee report for a cushion for General Purpose Aide to our schools. This was above what the Governor had recommended and while I'm one of those whose schools do not all gain funds through this amendment, I just don't see how we can afford to give more and hold everybody harmless. I think that this just goes beyond what we can afford to do. It will also set up a false sense for next year with many of our schools thinking that we are going to continue to hold everyone harmless and give them more money than we really have to give. For that reason, I urge to indefinitely postpone. Thank you, Mr. President.

The Chair ordered a Division. 28 Senators having voted in the affirmative and 7 Senators having voted in the negative, the motion by Senator **CATHCART** of Penobscot to **INDEFINITELY POSTPONE** Senate Amendment "B" (S-26) to Committee Amendment "A" (H-55) **PREVAILED**.

On motion by Senator **GAGNON** of Kennebec, Senate Amendment "K" (S-36) to Committee Amendment "A" (H-55) **READ**.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Gagnon.

Senator **GAGNON:** Thank you, Mr. President. Men and women of the Senate. In the spirit of bi-partisanship, I wish to present this amendment and ask for your support. By adopting this amendment we can demonstrate that it is possible for all of us, regardless of party, to work together in the best interests of the people of the Maine. At a time when a slowing economy threatens to take money out of the pockets of Maine's working families, we can say no to tax increases and live within our means. At a time when Maine school districts are struggling to maintain one of the best school systems in the country, we can stand together and provide a cushion for the most pressured rural communities. At a time when Maine families struggle to find affordable, quality childcare, we can provide care to 1,000 more Maine children. At a time when many retirees must struggle with spiraling costs of prescription drug prices on a fixed income, we can make certain military retirees benefit from the pension tax cut adopted last year. At a time when Maine seniors and their families struggle with long term care, we can make certain high quality care remains available. At a time when Mainers in my district and your districts are paying far more in property taxes than they can afford, we can provide millions of dollars of property tax relief. And at a time when others seek simple solutions to

complex issues, we can make certain that the many concerns raised by closing the state's liquor stores are properly addressed. It is important to make clear that this amendment preserves the Learning Technology Endowment Fund. It simply moves those funds into the Rainy Day Fund. The interest from the endowment will still be available to fill Governor King's vision of making Maine kids the most computer literate in the world. I'm proud of this amendment and the spirit of compromise and bi-partisanship that produced it. I'm proud of this Maine Senate who began this session grappling with a 17 - 17 - 1 split in this chamber. We resolved that issue by placing the interest of the people of Maine ahead of any partisan self-interest. Today we are grappling with creating a state budget for the next two years, a document that, more than any other, reflects our priorities. The people of this great state can be reassured that we are again resolving this issue by placing their interests ahead of any partisan self-interests. Mr. President, I encourage you and all members of the Senate to vote in favor of the amendment. Thank you.

Senator **GOLDTHWAIT** of Hancock moved Senate Amendment "K" (S-36) to Committee Amendment "A" (H-55) be **INDEFINITELY POSTPONED**.

THE PRESIDENT: The Chair recognizes the Senator from Hancock, Senator Goldthwait.

Senator **GOLDTHWAIT:** Thank you, Mr. President, ladies and gentlemen of the Senate. This amendment sounds wonderful and I wouldn't be surprised if many of you chose to support it. Unfortunately, I cannot comment intelligently on the amendment because it was handed to me about 20 minutes ago. I had been under the mistaken impression that I was the chairman of the Appropriations Committee, but that does not seem to be the case because some other Appropriations Committee spent the day meeting and working on writing a budget for the State of Maine. I'm not sure who was involved. I'm not sure where those meetings took place. I was certainly not present and knew nothing about it until about an hour ago, which is well beyond the time when we normally adjourn. I was then called in and told that there was such an amendment that, essentially, rewrote the entire budget that I had just been working on for two months. I was offered a one-page summary of that amendment and requested a copy of the entire amendment. I have gone through it quite quickly. There are some things in there, as I said, that are quite appealing, but clearly I cannot go for this amendment. I'd like to tell you why. Up until about two hours ago, this was the legislature the way the legislature should be. We worked on a process in my committee of which I am extremely proud of. We spent a great deal of time building a team in the room below this one. I think we did that very successfully. We treated each other civilly. We treated each other fairly. We had some discussions early on, there are members down there who had served on the Appropriations Committee well before I did, and there was some talk and some joking about when do we turn the mic off. Eventually we came to ignore the microphones. We did all of our business on the mic. Radio Free Appropriations. Anybody was welcomed to listen in. I am very, very proud of the work those 12 people did. We had plenty of disagreements and we worked very hard to overcome them. After putting in that time, in a spirit which many people commented was a step up in terms of openness, friendliness, civility. No rooms full of people sweating all day long. No meetings lasting until mid-night. We produced a unanimous

committee report. That does not happen very often in the Appropriations room. The issues are too big and the divisions are too large between the ideologies of the two separate parties. Most of the time we fail to reach that point, we produce two reports, both of them have merit, both of them have flaws. This time we managed to overcome that. We produced a document that none of the members liked, assuming that on that basis it must be about perfect. There are things in there that we all thought were good things and things in there that none of us would have put in had we been writing our own budget. We took that document, we brought it out. We were a week late and I apologize for that, especially to the school districts, because it's important for them to know what their GPA funding is on time. We brought the document out a week late. We took it to the floor of the other body. We worked very hard to generate support. I have to say that last night, listening to the debate on that budget and on the amendment in the other body, was one of the high points of my service here. It was lead by the good Representative from Livermore, Representative Berry, a person who I have come to cherish as an honorable and decent man, who worked very hard, as I did, for the last two months on this budget. But equally important to me, it was supported, worked and advocated by members of the other body who have served on that committee and it was a wonderful moment to sit in the back of the other body and listen to those good soldiers fight for the document they had put together. I have never been more proud to be a legislator. Tonight I have never been more ashamed to be a member of this body. This document was taken out of our hands. There had been agreements made somewhere in rooms non-accessible to the public. I can't tell you who participated in that process. But I did not. If I did not, that means my constituents did not. It is not important that I was cut out of the process, it is important that my constituents and all of your constituents were cut out of the process. Clearly there are a lot of people in the room tonight, members of the public, who have a great concern about one aspect of the budget. They are here exercising their right to at least listen in and to do their best to influence the process. They have every right to do that and I respect them for being here tonight and for hanging in this long. But I wonder what must they think. To be standing around in the halls for hours. Nobody having any idea what the delay was. Rumors coming and going all evening. Now we have a budget that nobody knows what's in it. Maybe you all do, but I don't know what's in it. I'm being asked to support that? I don't think so. This budget may do a lot of good things for the State of Maine, but it is to be noted for what it does not do. What it does not do is show one shred of respect for the people of this state. This is not what I was sent here to do. People talk about the back rooms and the smoke filled rooms and I always say "that doesn't happen, that happens in the federal government or somewhere else. I don't see that happening in Maine." I am a sadder and wiser woman tonight. I'm not sure what to do about the Part II Budget. We've already heard it. It sounds like I should simply move it up to the Senate since that's where the budgets are written. This amendment is a betrayal of the men and women that were sent to the Appropriations Committee to do that job, which they did honorably and in public. It is a betrayal of the other body, who had an elegant debate on the issues, raised the amendments, had the discussions, cast their votes and cast a very strong vote of support, not only for the budget that was before you, but also a support of the process of the Appropriations Committee. But worst of all, this amendment is a betrayal of the people of the State of Maine. I urge you to

support this motion for indefinite postponement. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Somerset, Senator Mills.

Senator **MILLS:** Mr. President, I will be joining the good Senator from Hancock in her motion. I, too, feel that the process does not respect the work of the committee. Secondly, the amendment that is before you avoids or evades a number of issues that will, as necessity, have to be addressed in Part II by this chamber, by the Appropriations Committee and by the Administration. Many of the anticipated problems were dealt with in the Committee amendment. Problems about revenue, raising of revenue, about meeting obligations, about cutting programs and cutting expenses. Many of those difficult issues that we confronted in the committee are being evaded by this document and merely, I say, postponed. That will be something that we will have to deal with before June. For that reason I will be joining and supporting the current motion.

THE PRESIDENT: The Chair recognizes President Pro Tem Bennett of Oxford.

President Pro Tem **BENNETT:** Thank you, Mr. President, fellow members of the Senate. I respectfully disagree with the comments raised by the Senator from Hancock, Senator Goldthwait, and I would ask you to vote against the pending motion to indefinitely postpone this amendment. I guess we couldn't have a starker difference. I, in my view, believe that this amendment represents the best of the legislative process. The whole idea of people working together to try to overcome differences. The process is open. The process is here and now. Every single member of this chamber has a chance to speak on this floor and to express, as the good Senator did, his or her feelings about a particular issue. This budget, even as amended by Amendment "K", represents 95% of the work, the very good work, of the Appropriations Committee, particularly the Senator from Hancock, Senator Goldthwait; the Senator from Somerset, Senator Mills; and the Senator from Penobscot, Senator Cathcart. The unfortunate reality was that that budget, as it came out of committee, was simply, in my view, not going to get 24 votes out of this body. It was not going to pass. I believe there were members on both sides of the aisles that felt that they could not support the budget as it came out of committee. While unanimous in committee, while a consensus document, it only could go so far. Sometimes there are issues that simply cannot be addressed in a committee. The big sticking points of this budget as it came upstairs from the Appropriations Committee were the raising of taxes, the closing of the liquor stores, the disposition of the monies within the Fund for Healthy Maine, the cost of living adjustments and other monies going to nursing facilities. These issues created a problem for many members of the Senate. We just simply could not get the requisite 24 votes that people were looking for. I think at that point it's important for leadership to attempt to bring people together. I commend the President of the Senate, Senator Michaud of Penobscot, for reaching out a hand across the aisles after having talked with members of the Democratic caucus and for us to begin, just today and throughout the day, with no guarantee that we were going to be able to find common ground, to have conversations and to work on a common document which did not emerge until this

evening. The ultimate power of the legislature is not vested in our committees. They are here to serve the Senate and the other body. They are not to exist for their own sake. They do incredibly important work. This Appropriations Committee did incredibly important work to get us to the point where we could find the common ground on those big issues that still divided us. That's what we did here. I am proud to be a part of Senate Amendment "K". I believe that the Appropriations Committee has served the Senate well, particularly with the Senator from Hancock, Senator Goldthwait's leadership. She deserves a lot of credit in a very, very demanding and difficult position. The power sharing arrangement here is very difficult for all of us in many ways. There is no majority. Every single person is important and I regret the feelings expressed by the Senator from Hancock. I regret that she has to feel them because it is unfortunate the way that she perceives this has arisen. But she ought to be proud of the work that the Appropriations Committee did in bringing us to this point. All of us ought to be proud to have had an Appropriations Committee that worked for us in fashioning a budget which identified the primary issues of difference so that we, in this situation, could identify them and work them through. Senate Amendment "K" represents the best of that effort. I encourage you to please vote against indefinite postponement. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Cathcart.

Senator **CATHCART:** Thank you, Mr. President. Men and women of the Senate. I rise to say that I plan to vote for the indefinite postponement of Senate Amendment "K". I do that out of a sense of honor and a sense of duty to the other 12 members of the Appropriations Committee who worked long and hard in an atmosphere of openness, respect and trust to come up with a compromise committee budget that we thought we could all live with. As I said yesterday, when we were voting in Committee on that budget, this was not a budget that made me happy. In some ways Senate Amendment "K" would make me happier. There are things in it I like much better. But I feel a real sense of pride in the work that we did and the way that we were able to work together in not just a bi-partisan but a tri-partisan way on the Appropriations Committee. I want to honor that work by my vote tonight. I also hope that we can keep that sense of trust and respect that we have had, that we will not lose it because of this process that we were not included in today and that we can go on to work together as well as we have done to pass the Part II Budget and complete our work. Thank you, Mr. President.

The Chair ordered a Division.

On motion by Senator **GOLDTHWAIT** of Hancock, supported by a Division of at least one-fifth of the members present and voting, a Roll Call was ordered.

The Doorkeepers secured the Chamber.

The Secretary opened the vote.
