Senator **BURNS:** Thank you, Mr. President. Ladies and gentlemen of the Senate, once again it's my pleasure to be able to speak to you about some of our nominees that you have in front of you this morning, two of whom are with us today. As you've heard me say for the last two years, on behalf of the Judiciary Committee, how impressed we are with the nominations that have come forward from this Administration. All of these candidates have been exceptional, some really extraordinary, and I think my colleagues, Senator Volk and Senator Johnson, will agree with me when I say that today is no exception. In front of us today we have the nomination of Deborah Cashman of Bath. Deborah Cashman has been involved as a trial attorney for over 20 years. She worked in the District Attorney's Office in Androscoggin County from 1998 to 2010 and the District Attorney's Office in Sagadahoc and Lincoln Counties from 2010 and 2012 and then the Attorney General's Homicide Unit from 2012 until present time. During that time, depending on who you listen to, she prosecuted between 27 and 30 homicide cases, some of the most difficult cases that this state has to deal with. Pretty remarkable history for Attorney Cashman. She has a lot of experience that she brought to the committee; experience in guardian ad litem, which is a very important to our family courts. A lot of her prosecutorial experience is in sexual abuse and sexual exploitation and a lot of expertise in handling vulnerable witnesses, both children and adults. She had rave reviews from all those that came in to speak to our committee about her and her experience in front of the bar. Remarkable testimony from her supervisors, especially in the Attorney General's Office, talking about her supervisor, Lisa Marchese, or Attorney General Mills. She made a very incredible presentation to the committee and I think everybody in the committee was very, very impressed with her demeanor and her presentation, her experience and what she has to offer the state of Maine, should we clear this appointment as a District Court Judge. There was only one issue that drew a little bit of concern for me; Ms. Cashman has practiced in 13 of our 17 Superior Courts. The only ones that she missed was Belfast, Dover-Foxcroft, and Machias. I understand that's going to be rectified. With that, I have great pleasure, on behalf of the committee, to recommend this nomination to you.

Dear Honorable Members of the 127<sup>th</sup> Legislature:

Under the authority vested in me by Article IV, Part Third, Section 2 of the Constitution of the State of Maine, I am hereby vetoing LD 1467, "An Act Regarding Maine Spirits."

While I support the modernization of sales practices and data utilization as originally proposed, this bill was amended during the Committee process. As amended, the bill directs the Bureau of Alcoholic Beverages and Lottery Operations to provide upfront funding to businesses to mitigate their costs. I do not believe this is necessary.

The original bill was designed to increase business for our business partners, and the State has recently taken significant steps to improve the profitability for liquor resellers along with all agency liquor stores in Maine. We have seen powerful results. The State has invested significantly in our liquor business, and the retail community has reaped the financial benefits. At a time when the State seeks to further assist these businesses by adopting this bill, an additional request for funds from the State is a step too far.

For these reasons I return this bill unsigned and vetoed. I strongly urge the Legislature to sustain it.

Senator **BURNS:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I appreciate this opportunity to say a few words about my friend, Bob Carter. A true friend is irreplaceable. We all have many friends as we go through life. Imagine what it would be like without them. However, some friends we hold very dear and special. Bob Carter was one of those special friends to me. We began our friendship over 40 years ago when he, as a young Game Warden, and me, as a young State Trooper, were stationed in Washington County together. We soon found a lot in common. We both loved our work, our families, our wives, and our Lord. We worked together, hunted and fished together, double dated with our wives, Donna and Joan, attended church together, visited dying friends together, laughed, argued, and prayed together. Keeping good friendships can be a lot of fun, but it also takes a lot of patience and effort. Like good marriages, you have to work at it. Bob Carter had the personality that almost everyone liked, even those he summoned and arrested for fish and game violations seemed to like him. That was a trick that I never learned. Let me give you an example. A few years ago my wife and I had an opportunity to stay at the so-called Carriage House Motel at the Pittston Farm back in the North Maine woods during bird hunting season. The walls between the rooms were extremely thin. There were several hunters in the next room and they were talking about the old days. After their long day of hunting, they were a little bit loud and a little bit tipsy. One was talking about the time that Warden Carter had arrested him for some fish and game violations. The others were, of course, trying to match his story. The final analysis, after they were all said and done, they all agreed that Warden Carter was a fair and a great Game Warden. Can you imagine that?

In the early 1980's Bob and his wife, Joan, bought Helen's Restaurant, which you heard about, in Machias and eventually built the Machias Motor Inn and other businesses in the community. They were very good business people because they always treated their employees, their customers, and their community extremely well. Bob was also a dealer, collector, and authority on old Winchester rifles. He was known from Maine to Florida and parts beyond for his knowledge of old Winchesters and his advice was sought by dealers and collectors from all over the country. Bob and Joan's most important accomplishment was their two children, Robert Wade Carter and Kristyne Carter Currier, their daughter-in-law and their son-in-law, and their nine

grandchildren. Bob, first and foremost, was a family man. Bob's life contributed much to this state, his community, his family, and his church. Bob, like myself, had a personal relationship with his Lord and Savior Jesus Christ. His faith was manifested in every aspect of his life. One of the last things that Bob said to me in the days before his cancer took his life was, "Keep praying, Dave." Yes, I'll miss my friend, Bob, but I have great comfort that we'll join together again in heaven. Because of family circumstances this weekend, only one of the family members was able to come down and join us today, but his son-in-law, Jeff Currier, is here with us today. Mr. President, he is a regional district forest ranger. I would ask that when the Senate adjourns today it do so in memory of Bob Carter. I thank you very much, Mr. President and my colleagues.
