Second, how do we boost employment for Maine veterans, Maine people in recovery from addiction, and Maine people who are leaving the correctional system? The answer, Mr. President, is embodied in Margo Walsh, the founder and CEO of Maine Works LLC. Maine Works is a temporary employment agency that specializes in finding industrial construction employment for veterans, individuals in recovery from substance abuse, and those reentering the job market after being incarcerated. As MaineBiz magazine said in a feature article in 2014, "Hers is no ordinary employment service. She hires workers who others typically won't, veterans reentering the workforce, immigrants, recovering drug or alcohol abusers, and those with previous non-violent convictions, and gives them a chance to rebuild their

lives." Ms. Walsh has put workers in jobs with companies like Cianbro, Shaw Brothers, PC Construction, and other well-known members of the Associated General Contractors of America. The inspiration for Maine Works grew directly out of Ms. Walsh's extensive professional experience in human resources with Fortune 500 companies as well as her personal experience in recovery. In addition, she has tapped into local resources such as the Portland Chapter of SCORE, a non-profit that offers advice and mentoring to entrepreneur and she has worked with local lenders to capitalize her operations. Her company now has about six permanent employees and up to 75 temporary workers, depending on the seasonal demands in industrial construction. Revenues in 2015 were \$1.6 million. For all of these reasons, Ms. Walsh was just named the United States Small Business Administration 2016 Maine Small Business Person of the Year. Mr. President, Margo Walsh and Maine Works is a win, win, win story and I'm proud to represent her in the Maine Senate. Thank you, Mr. President.
