**THE PRESIDENT:** The Chair would like to interrupt proceedings at this time to take a moment to recognize our Legislative Memorial Scholarship award winners. The Chair recognizes the Senator from Sagadahoc, Senator Mayo.

Senator **MAYO:** Thank you, Madame President, ladies and gentlemen of the Senate, distinguished guests, and we have a number of them with us today. We, as members of this body, many times wonder what we have done for the state each day. I would remind you that a couple of months ago, I think we did something rather memorable. On the occasion of the most recent Legislative Scholarship Auction, we raised in excess of \$18,000 to offer scholarships to deserving students, one from each county, all of whom will receive a \$1,000 scholarship. I was talking with one of the recipients today, a student at Bowden, who is majoring in math. She indicated that she was going to use this \$1,000 to purchase textbooks in the fall semester because her textbooks run in excess of \$100 each. It could be used for housing, it could be used for transportation, or it could be used to assist with tuition. That decision is up to the individual student.

We're happy to have these seven students and their parents with us today. We will have them, individually, come down front when their name is called by Madame President, and their Senator would be asked to come forward and there will be a picture taking. When the event is done here in the Senate, they have been invited to the House and a ceremony there, then move on to the museum for a luncheon. Any of the Senators who have recipients are also invited to join us in the atrium of the museum at around 11:30. With that, I will turn back to the good President of the Senate.

**THE PRESIDENT:** The Chair will call the names individually of our recipients and the Senator's names. Would they please come forward and receive their award. We have awards for someone from each county, but today we have seven of those recipients with us.

Kasi Carson of Androscoggin County, attending Colby College, with Senator Neria Douglass; Scott Porter of Aroostook County, attending the University of Maine in Orono, with Senator John Martin; Samuel Foster of Kennebec County, attending Unity College, with President Beverly Daggett; Katie Fuller of Oxford County, attending Colby College, with Senator Bruce Bryant; Megan Dow of Piscataquis County, attending the University of Maine at Fort Kent and is a student of the Senator from Aroostook, Senator Martin, with Senator Paul Davis, Sr.; Courtney Reichert of Sagadahoc County, attending Bowdoin College, with Senator Arthur Mayo, III; Jamie Sturtevant of York County, attending York County Community College, with Senator Kenneth Lemont.

Senator **YOUNGBLOOD:** Thank you, Madame President, ladies and gentlemen of the Senate. I won't take but just a second of your time. This is a good bill, it was passed unanimously by the Utilities Committee. This was about access. About five years ago, the legislature said that interstate and intrastate fees need to be brought closer together; they were completely out of balance. A great deal of progress has been made in doing that. A deadline of May 31, 2003 was set to do that. The Public Utilities Commission had not done enough to move the smaller, rural telephone companies of Maine into that arena. Verizon made a big step, very early on. A lot of work needed to be done in order to meet that May 31<sup>st</sup> deadline. Rate shock would have had to happen. There would have been substantial increases in excess of 50%.

The amendment to this gives the Public Utilities Commission another two years in order to implement this, until May 31, 2005. To let the PUC know the attitude of the committee, the committee voted to send a letter to them saying that this is important to the people of Maine. The equalization of interstate and intrastate fees is important. Get on with it. Don't do, as you've done this time, and drag your feet, come back here in May 2005 and say that you need another extension. That letter encourages the PUC to get on with that, to do this equalization process. It is important to all of the people of the State of Maine. I thank you for the opportunity, Madame President, to put that on the record.

**THE PRESIDENT:** The Chair recognizes the Senator from Lincoln, Senator Hall.

Senator **HALL:** Thank you, Madame President, ladies and gentlemen of the Senate. May I first thank the good Senator from Penobscot, Senator Youngblood, for his remarks about this bill and for the work that he put in on creating a consensus on this and moving it forward.

With your indulgence, Madame President, I would just briefly read the letter from the committee to the Public Utilities Commission for the record. It reads as follows: 'Dear Chairman Welch: The purpose of this letter is to convey to the commission the intent of the Utilities and Energy Committee with regard to the committee amendment to L.D. 265. This amendment changes current law by giving discretion to the commission to decide whether to reduce instate toll access rates to be equal to or less than the interstate toll access rates. It does require, however, that the commission ensure that the instate access rates meet the interstate access rates as of January 1, 2003.

The amendment gives discretion to the commission to determine the schedule for achieving this result before May 2005. The committee expects that, in exercising this discretion, the commission shall commence proceedings, as soon as possible, to develop appropriate phase-in schedules which ensure fairness to all customers without causing rate shock. Thank you for your attention and cooperation.' It is signed by the committee chairs.

Thank you, Madame President, for listening to that and I appreciate the opportunity to have read that into the record. I hope that the Senate will now pass this without further concern. Thank you.
