**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Rand.

Senator **RAND:** Thank you, Mr. President and men and women of the Senate. I hope that you will reject the motion that is before us, Ought Not to Pass, so that we can go on to pass this piece of legislation. This bill has certainly generated far more interest and lobbying than anyone would have thought about a month ago. I have to tell you, I was disappointed when the committee voted it out Ought Not to Pass. But after a debate on the floor of the other body, which did see its way clear to pass this bill, I would encourage us to do the same. I've listened to the people working against this bill and I still haven't heard one good reason to vote against it. But I can think of a lot of reasons to support it. Opponents of the bill have said that there is no need for this legislation, but clearly if you have watched the video that was distributed, there is a need for this bill. To see handlers beating these magnificent animals with their hooks and primitive tools, beating them until, at some point in time, the animal strikes back and rampages. Then the police are called in to shoot the animal. They are actually well-prepared to do this. I watched the video, disgusted as police officers pumped bullet after bullet into the animal that had rampaged. Worst yet, in the hearing for this bill, when asked, nobody from the circus industry could tell us that our children would be safe from the elephants that were putting on a show. None of them could say it was, in fact, safe. There are approximately 280 elephants performing in circuses and traveling shows throughout this country. About 240 of them were taken from the wild. These were the babies taken from their mothers and brought here to do tricks for us. When that happens, an elephant is tied down and beaten to teach it who is in charge, who is the dominant master. Worst yet, the women who rides these animals don't like to sit on their backs because the hair is wiry. So to get rid of the hair, some circuses will chain the elephant and use a blow torch to remove the hair so that the women riding the elephant won't run her nylons. I have seen this on the video. This is clearly not filmed in a foreign country. These people are speaking very clear English. It was not filmed years ago. The representative from Ringling Circus didn't even believe the video existed. In fact, he told Representative Muse that it was nonsense until Representative Muse invited him to watch the tape and then his only reply was "those aren't Ringling elephants." I would

have to reply to that, so what? Does it make it okay? The fact that these abuses happen and the sad fact that these elephants are getting old, just like us, and as they get old they get a little more temperamental and they don't like being pushed around and poked. How many times do you suppose I could poke any of you before you finally got fed up and pushed back? The other reason Ringling and others want this bill killed is because, according to them, bringing the elephants here teaches our children what elephants are like. I've never seen an elephant in a jungle, but I don't think for one minute that any of them parade around in the wild wearing tutus and headdresses or are standing on their head or balancing on one foot. We were fortunate last week to have a visit from a woman named Carol Buckley. Carol worked in the circus for over 15 years as an elephant trainer. She owned her own elephant. She talked about abusing it and how the industry taught them to be dominant over the animal. If it didn't perform the way she wanted it, she must bring it out behind the big tent and beat it. If she didn't, she was taught that it would become a wild animal and very dangerous. She talked about elephants being hosed down with water and then subjected to electricity to shock them to show them who was boss. Carol Buckley finally decided that this was wrong, and after negotiating with International Paper in Tennessee, they gave her 2,000 acres and she opened the country's first elephant sanctuary. She has 7 elephants there now and has room and plans for holding as many as 100. Her facility is exactly like Ringling's retirement facility in that people are not allowed in there. But that is where the similarity ends. Ringling has twice as many elephants at their facility in an area smaller than a football field. Ringling elephants are all brought into a barn at night and chained with 3 or 4 ankles chained so that they can't move. They stand all night in their own urine and feces. At the elephant sanctuary the elephants have over 200 acres to roam freely as they chose and they are never chained. They have heated barns with automatic floor cleaning systems. They are allowed to live as elephants. This is why Mrs. Buckley doesn't allow people to interact with them. This is not a PETA bill, this is not some bill brought forward by some animal rights activist group. It is a bill that makes sense, that a 7 year old girl brought to her dad because she witnessed first hand elephants whose ankles were bleeding from chains and she didn't like it. I can't imagine that any of you do either. If we could stop all of the beatings with bull hooks to teach the elephants who was in charge and if we could invent nylons that didn't run because of the elephant's hair so the circus would stop using a blow torch to remove the hair, if we could do all of that, we would still have the basic problem which is the fact that these animals are just simply too big to safely and humanely transport from town to town to town. That, in and of itself, is abuse and we need to stop it. The Shriners say they need the circus for their fundraising event. We should note that they have also stated that none of the money generated from the circus goes to the Shriner's Hospital, it all stays here in Maine. There are over 35 circuses that have no elephants. Ringling Brothers themselves have opened a new branch of their circus with small, domesticated animals only. Almost all of these shows have indicated that they would be more than willing to come to Maine and work for the Shriners or whoever wanted to see them. L.D. 628 would prohibit elephant rides as well as the use of elephants in displays that require the animal to perform tricks. This bill would apply to circuses, carnivals, parades, petting zoos, and

traveling exhibits that remain at one location and stay for fewer than 60 days. Animal acts featuring elephants are dangerous to the public. Since 1990, captive elephants have been responsible for at least 50 deaths and hundreds of injuries worldwide. Due to the inherent dangers involved, elephant handling is rated as the deadliest occupation in the U.S. Department of Labor and the American Zoo and Aquarium Association has advised its member zoos to discontinue elephant rides. I think that just the very fact of the size and nature of these beasts that it is cruel treatment to chain them and not allow them to roam. I have to say that as a very strong Democrat, it pains me to admit that my favorite creature on this planet is an elephant. That is the truth. I hope that you join me in refusing to vote for the Ought Not to Pass report so that we can go on and pass this legislation. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Nutting.

Senator **NUTTING:** Thank you, Mr. President. Ladies and gentlemen of the Senate. I hope that you will vote, as we did just a few minutes ago, to support the pending motion to support the majority Ought Not to Pass report. I, too, saw a video taken of a situation in Florida, I believe, 9 years ago. But I want to bring the discussion, the debate, to this state, the State of Maine. How elephants, in fact how all circus animals, are treated are regulated by two levels of government. The federal and at the state level. I distributed something about the Federal Animal Welfare Act that's been on the books now for years. The federal government has veterinarians that go around inspecting circuses without notice and do so regularly. But also, in our work session, I asked the head of the Animal Welfare Department in Maine if the Maine Animal Welfare Department had ever received any complaints as far as the way elephants were treated at circuses. The answer I received back was that yes, they had. Immediately a state veterinarian was sent out to investigate the situation. They've only had two complaints and both times a state veterinarian went out and didn't find anything. But my point is that this industry and these animals are protected by two levels of government, two different levels of veterinarians to check on their care. Now if you want to vote for something, I would suggest that you wait because in a couple of weeks, I firmly believe, the Agriculture, Conservation and Forestry Committee is going to be reporting out a new bill to restructure and improve further Maine's animal welfare system, to make response time even faster, to set even stronger rules about how animals are cared for in Maine. To me, ladies and gentlemen of the Senate, that is what we should be voting for, not this bill. It also was pointed out by the Circus Fans of America, many of whose Maine members showed up at the public hearing, spoke about their enjoyment of taking their children and grandchildren to the circus. But they pointed out to the committee that elephants have been domesticated for years and years. This is nothing new. So I urge you to vote for the pending motion. This industry is already regulated and in a few weeks, I believe, we're going to have before us a bill to strengthen our animal welfare system in Maine and improve it some more. I would suggest that that's where we need to put our efforts. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Aroostook, Senator Kneeland.

Senator **KNEELAND:** Thank you, Mr. President. Mr. President, men and women of the Senate. This bill had many hours in our hearing and a well debated work session with a 9 to 3 Ought Not to Pass report. This bill will not protect one elephant. Nor will this bill change the practices of some. L.D. 628 is not intended as a remedy for anything. This bill does not address animal care and handling or separation involvement or safety. It is an outright ban. Circus elephants live longer and happier lives than their zoo counterparts. They are more successful at reproduction and are more superior in physical and mental conditions. It is not uncommon for a retired circus elephant to live into their 70's. That's even older than I. As the committee heard in testimony from animal experts, circus trainers and caretakers of circus elephants, they are usually very well cared for and it has been found they even become part of the family when these people take care of these elephants. So I ask you to please vote for the pending motion. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Lincoln, Senator Kilkelly.

Senator **KILKELLY:** Thank you, Mr. President, men and women of the Senate. I also rise to urge you today to continue with your previous vote to support the Ought Not to Pass on this particular bill. It would be easy for us to pass this bill and say that we were solving a problem. My concern, as a member of the Agriculture, Conservation and Forestry Committee for the last 7 years, is that if we were to continue along this path of creating legislation around, not only a particular species of animal but also particular activities of that species of animal, we could end up probably tripling the volumes of legislation we currently have in order to accommodate what? And that's really the question. We do have laws on the book about animal abuse. One of the things that is interesting, as we heard from the previous speakers, was talk about public safety and that one of the reasons we needed to do this was for public safety. I ask you to overlay. Instead of elephants, lets talk about horses. Having had horses for many years, Senator Small and I actually were in the same horse 4-H Club many years ago. Horses are very unpredictable. Horses are very large. Horses participate in parades. They can be incredibly dangerous. I'm sure most people that have been around horses for any length of time will show you a variety of scars and bumps and bruises that can, in fact, support that they are, in fact, dangerous and unpredictable animals. They are also beautiful animals and they are majestic animals. In the riding stable I went to when I was a kid there was a sign that said "there's something about the outside of a horse that does good things to the inside of a person." That's exactly the way I feel about horses. My horses, when I had horses, were brought in every night. They were tied in stalls. Often it was a straight stall. That meant that they stood there tied all night long and they did, in fact, make a mess in that stall. Every morning I went out and cleaned that stall. I don't think that was abusive, I don't think that was cruel. They came in to be cared for and to be fed and that was an appropriate thing to do. So we can take all these circumstances and we can say that with elephants it's not safe, it's not okay, it's something we ought to stop. But where's that going to stop. Are we next going to say it's not really safe to have a large hitch of horses in a parade because, in fact, those horses are unpredictable and if one of them gets stung by a bee and you happen to be standing in the wrong place, you could be hurt. You

could be killed. Your children could be hurt. Your children could be killed. That's one of the things that we do when we get up every morning. We go out and say "what are the risks that I'm willing to take? Am I willing to get on a horse and go riding it? Am I willing to walk up to an elephant?" I rode an elephant once. I rode it in India. It was an amazing experience. The person who trained that elephant had been training elephants his whole life and he had gotten his skills from his father and his grandfather, who had also trained elephants. This isn't something new. We need to be very careful about the laws that we make. We need to be judicious in how we look at our roles as legislators and what is it that we need to legislate. We need good laws on animal abuse. We need to not tolerate the abuse of animals, not just elephants, not just horses, not just dogs and cats, but all animals. We have that in place now. There's a handout on the desk from the three Senate members of the Agriculture, Conservation and Forestry Committee. We are working diligently to strengthen those laws and those laws are good and appropriate. So I would just urge you to continue with your previous vote for Ought Not to Pass, allow our committee to continue to do the work it's doing on behalf of all animals and for the safety of all people in the state. I urge you to continue with that vote so we can move on to other business. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator McAlevey.

Senator **MC ALEVEY:** Thank you, Mr. President. Men and women of the Senate. I've looked at this issue from both sides. I've heard the industry. I've heard the advocates. It's my understanding that the ASPCA just filed a suit in federal court against Ringling Brothers alleging abuse to elephants. These are tools used by an industry. Most people who run good businesses are not going to abuse their tools. They are going to keep them in good working order. Just as we have good people and bad people, I'm sure there are abuses throughout that industry and I'm sure there are examples of people who take care of their animals as they should. But I think elephants are unique. When I first heard the bill I laughed at it. I thought this was a joke. I started looking at it and reading some of the literature on both sides. To me elephants are unique. They live 70 years. They're huge. There aren't that many in the United States. I, by nature, do not like regulating business. I think it has something to do with my political background. However, I submit to you that if these animals were living in our wilds in Maine, which obviously is an improbability, and they were suffering the ailments and abuse from the public that they suffer from the industry, we would have them on our endangered species list in a heartbeat. Thank you.
