**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Bromley.

Senator **BROMLEY**: Thank you, Madame President and colleagues in the Senate. Before you get to vote no, which means yes, on this nomination I want to put a few remarks on the record about the nominee and also about what is asked of the nominee.

John G. Richardson, the nominee for the Commissioner of the Department of Economic and Community Development, is particularly and uniquely qualified for this position. He possesses probably the singular most important quality for this position, one that actually is all too rare. The committee recognized it immediately, embraced it unanimously, and that is the belief that the best years of Maine's economy are ahead of us. I say that, and I'm going to say that again because it's so important, this nominee and many members of us in this Chamber believe that the best years of Maine's economy are ahead of us. That qualifies him, puts him head and shoulders above many who would seek this position.

In addition to that, the committee heard about a belief and an interest in doing more of what works and less of what doesn't. That is a unique approach to work and we are going to appreciate that. As our economy is flux, the nominee himself has recreated himself more than a couple of times. An accountant at first; a lawyer; politician; representative of the people of his community; Chair of the Business, Research and Economic Development Committee; Presiding Officer in the other Body; and now the soon to be Commissioner of Economic and Community Development. The committee appreciates the breadth of knowledge, the experience, and particularly the high regard the nominee hold for the legislature. He's known for his skill in negotiating, not an unimportant skill in all we have before us.

Briefly, the task before him is to help lead us, the legislature and the people of Maine, in a path towards economic development and a robust economy. It's a tough job. We all have part and parcel of that job and he has the full support, the unanimous support, of the committee. I'm sure you are going to join me in voting no to overturn the unanimous recommendation of the committee. Thank you, Madame President and colleagues.

**THE PRESIDENT**: The Chair recognizes the Senator from York, Senator Courtney.

Senator **COURTNEY**: Thank you, Madame President, men and women of the Senate. I would like to concur with our Chair and I'd just like to maybe go on the record just to let people know the respect that I've gained for the Speaker and the way that he raised the tone and the conduct of this legislature. I, for one, appreciated that. I believe that he's going to be able to take this new position and build it and merge the departments in a non-partisan basis so we, and all the people of Maine, can benefit. I'm looking forward to working with him in that endeavor. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Washington, Senator Raye.

Senator **RAYE:** Thank you, Madame President, men and women of the Senate. It is my pleasure to rise this morning to recognize an extraordinary Maine citizen, Mr. Morrill Worcester of Harrington. Each Christmas for 15 years Mr. Worcester has worked hard to honor American's fallen soldiers and departed veterans by traveling to Arlington, Virginia and, with the help of hundreds of volunteers, decorating the graves of 5,000 veterans at Arlington National Cemetery with Maine balsam wreathes. That's 5,000 graves each and every year. He's done it with a minimum of recognition all these years until finally this year the press here in Maine and across the country keyed in on the remarkable devotion and expression of patriotism and appreciation for our veterans shown by Mr. Worcester. This past Christmas the program expanded and Wreathes Across America placed nearly 8,000 wreathes on graves in 230 veteran's cemeteries and monuments in all 50 states and Puerto Rico.

That happened because of the singular devotion of Morrill Worcester, who has inspired hundreds of volunteers across this country, including Jimmy and Hope Prout of Bluebird Trucking who have donated the services of their trucking company for 15 years to get these wreathes down to Washington D.C., including the Maine Civil Air Patrol units, local VFW and American Legion Posts, military units, Congressional staffers, school children, Scout troops, and others across this nation to honor America's veterans. It is entire appropriate that we pause today to recognize and express our heartfelt appreciation to Mr. Worcester for his selfless generosity and his hard work in memory and in tribute to the brave men and women who have served this nation. I am delighted that Morrill and his wife, Karen, are here in the Chamber today and it is my pleasure to present them with the Sentiment.

**THE PRESIDENT:** The Chair recognizes the Senator from Hancock, Senator Damon.

Senator **DAMON:** Thank you, Madame President, ladies and gentlemen of the Senate. I, too, want to rise to lend my thanks to Morrill Worcester and his wife, Karen. I had the great opportunity this past December to be a small part of the effort that they have put forth with regards to the wreathes and recognizing the veterans of this country who have given their final expression. As we left the facility in Harrington with the truck jammed packed full of wreathes bound for Arlington Cemetery in Washington and all of the fire trucks and the apparatus from the little town of Harrington were leading the way to be replaced by the fire facilities and the apparatus from the little town of Milbridge, then later Steuben, then Gouldsboro, and later Ellsworth. Each and every mile of the way there were people standing on the side of the road, thanking in silent tribute, with their waves or standing with their flags, thanking Morrill and his wife, Karen, for this truly great expression. These thanks continued all the way on their trip from Harrington, Maine to Arlington Cemetery in Virginia. It is an extraordinary devotion and extraordinary sentiment that the Worcester's do with regards to these wreathes, but that is only a very small part of what they do for their community of Harrington, their community of Columbia Falls, their community of Downeast Maine, of Washington County, and their community of all the greater Maine. In addition to doing as we are recognizing with them today, they also have taken in children, children who have not been able to be provided with the family setting that all children should be able to be provided with and they have given of their means, of their time, and of their love to help make this world a better place, child by child and wreath by wreath. Thank you, Madame President.

**THE PRESIDENT:** The Chair recognizes the Senator from Aroostook, Senator Martin.

Senator **MARTIN:** Thank you, Madame President and members of the Senate. By coincidence, I was in Washington the day that the wreathes were placed at Arlington. The next morning when I returned to Maine on a flight into Portland half the plane was full with individuals who had paid their own way to help place the wreathes at Arlington. I had bought the Washington Post and the New York Times and on the front page of both of them were the pictures of the laying of the wreathes. The newspapers went up and down the aisles as I passed it on to them. They were really amazed by the fact that they had gotten as much publicity which,

in my opinion, was so well deserved. WHEREAS, the Members of the One Hundred and Twenty-second Maine Legislature enacted limitations to ensure responsible and sensible governmental expenditures; and

WHEREAS, the people of the State of Maine have placed their trust in elected officials; and

WHEREAS, we, the Members of the One Hundred and Twenty-third Maine Legislature, honor the solemn trust the people of the State of Maine have bestowed upon us; and

WHEREAS, the Attorney General of Maine has opined that a joint rules change requiring a 2/3 majority to override the spending limitations would likely be found unconstitutional, if reviewed by the Maine Supreme Judicial Court; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-third Legislature of the State of Maine now assembled in the First Regular Session, reaffirm our commitment to remain under the spending cap on governmental expenditures as enacted by the One Hundred and Twenty-second Maine Legislature; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Honorable John Elias Baldacci, Governor of the State of Maine.

**READ.**

**THE PRESIDENT:** The Chair recognizes the Senator from Hancock, Senator Rosen.

Senator **ROSEN:** Thank you, Madame President and members of the Senate. We are about to take action on a Joint Resolution. As we look ahead, we see another item to follow. We have been through an exchange and a conversation these last few days and weeks as to a mechanism that we all could agree upon that would allow us to place in the Joint Rules of this session, the session of the 123<sup>rd</sup>, a mechanism that would make a statement to the public and would make a clear policy imposed upon ourselves. There

was a unanimous agreement from all the members of the Joint Rules Committee on a particular approach. That came to this Chamber and this Chamber agreed with a unanimous vote, once again, to send that amendment to our Joint Rules to the other Chamber. We are now presented with a version from the other end of the hall that refers to an opinion from the Attorney General and that we are being asked by the other end of the hall to concur, based upon a letter coming back from our Attorney General. I will be supporting the proposal that is in front of us, but it is an interesting, and I think unfortunate, set of circumstances that we have watched a unanimous agreement from the Joint Rules Committee, a unanimous posture from this Chamber, about to be reversed and replaced by another position because we are told that a potential opinion from one of our Constitutional Officers is directing us to do it in this particular fashion. I think it does not really address the spirit and the desire that we were all trying to achieve here. It is something, but much less than what we had.

**THE PRESIDENT:** The Chair recognizes the Senator from Aroostook, Senator Martin.

Senator **MARTIN:** Thank you, Madame President and members of the Senate. I agree with most of the comments of the good Senator from Hancock, Senator Rosen. It is and was something that we did in the Rules Committee, really trying to reach consensus. We thought we had it, but until the members of the legislature and the people of Maine abolish one Body and create a unicameral legislature we will always be stuck with a bicameral system. I wanted you to know that I actually, in my past, has sponsored legislation which created a unicameral, which passed the Maine House but died in this Body. I'm as frustrated as you are because we thought we had something. I can only say that between the good Senator, actually all 5 of us, on the Rules Committee, we have devoted, I want to say, 24 hours to this issue trying to get to where we thought we were. Unfortunately, that did not happen. As much as I hate to, I guess at this point we have no ability to do anything different. I believe, however, that it sets the spirit of what it is we wanted. It clearly does that and it clearly says that it is our desire, our intent, and our commitment to accomplish that goal. I guess it's different in the sense that it's not an order, maybe it's a pledge to each other and to all of us that what we are committed to is to do what we said we would do. For that, I guess, I'm happy that at least we are getting that.

On motion by Senator **WESTON** of Waldo, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Turner.

Senator **TURNER:** Thank you, Madame President and ladies and gentlemen of the Senate. I'm not an attorney. What I know about the Constitution is from my own reading and interpretation. I think that thing that troubles me most about this is that I believe strongly that we are co-equal branch of government, that the legislature can operate on a rule that it decides. I don't think it's the purview of the courts, quite frankly. I don't agree with the opinion rendered by the Attorney General in this matter for those in the other Body. I'm trying to figure out how to deal with the spirit that the Senator from Aroostook, Senator Martin, refers to

and at the same time have distaste for what we have seen proceed here. Thank you, Madame President.
