H.P. 1327

#### **JOINT RESOLUTION TO RECOGNIZE THE 145TH ANNIVERSARY OF THE CITY OF AUBURN**

WHEREAS, the City of Auburn, on the Androscoggin River in Androscoggin County, was incorporated as a town in 1842 and became a city 26 years later on February 22, 1869; and

WHEREAS, in 1917 the City of Auburn was the first municipality in the State to adopt a council-manager form of government and was the birthplace of the first shoe factory in Maine, an industry vital to the growth of the State, at one point during the peak of the shoemaking industry providing 75% of the world's shoes; and

WHEREAS, Vestigia Nulla Retrorsum, the motto of the city translated from the Latin as "No Steps Backward," exemplifies the resilience of its citizens and businesses, which have overcome

and endured harsh challenges over the years, such as the New Auburn Fire, a conflagration that occurred in 1933, in which 249 buildings were destroyed, leaving 2,000 people homeless; and

WHEREAS, the City of Auburn also recovered from the devastating flood of 1936, which left streets submerged and homes and businesses flooded and caused the loss of 2 spans of the South Bridge, which required the building of a new bridge; and

WHEREAS, the City of Auburn was challenged in the 1950s as the shoe industry began a rapid decline, resulting in the city's changing into a vital regional service center, with investments in infrastructure, public and private partnerships and sound economic development opportunities through its multiple modes of transportation and prudent use of economic attractions to the city; and

WHEREAS, the City of Auburn was recognized in 1967 as an All-America City and it remains a proud city that has emphasized growth, family values and industry as it has adapted to the many changes through the years; and

WHEREAS, the City of Auburn has been embraced by a community of diverse residents from around the world who are committed to making their community successful; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-sixth Legislature now assembled in the Second Regular Session, on behalf of the people we represent, take this opportunity to acknowledge the City of Auburn's residents and businesses for their commitment and growth and commend them for their active role in improving the quality of life in the city and making the City of Auburn an economically effervescent and welcoming community; and be it further

RESOLVED: That We, the Members of the One Hundred and Twenty-sixth Legislature, celebrate the 145th Anniversary of the City of Auburn and recognize its important role as a vital part of Maine's history and progress; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Auburn City Manager, Auburn City Council and Mayor of the City of Auburn for display and preservation for the residents of the City.

**THE PRESIDENT:** The Chair recognizes the Senator from Franklin, Senator Saviello.

Senator **SAVIELLO:** Thank you Mr. President. Ladies and gentlemen of the Senate, I first met Bob in 2002 when he was the editor of the Franklin Journal. I asked him in 2004 if he would endorse me in that campaign. His comment to me was, "I like both you and Roger Lambert the same amount, so I can't endorse either one of you." I couldn't understand why he didn't like me better, but that was Bob. Later he gave me a special thumbs up in one of his editorials for, as I'm known down here, bucking the system and didn't vote the way I was supposed to, according to some people. He really thanked me for doing the right thing. Now Bob is a newspaper writer and his wife, Vicki, hated headlines that ended in question marks. They would often talk about those. Well, apparently, Bob, being the true newspaper man that he was, when he proposed to Vicki he gave her a headline and it asked, "Will you marry me" and asked her what he thought of that headline. In 2004, or soon after that, Bob retired. I said, "Why?" He said, "It's just time. I'm done. I'm moving to Mt. Vernon. I'm just going to enjoy the rest of my life." Okay, so in 2008 I'm campaigning and one of the places I'm told to stop in Mt. Vernon is a local restaurant called the Post Office Café. I'd heard a lot about it. I'd heard that it was a great place to eat. I should tell

you, you should go there. Behold, when I walk in the door, who was there but Bob Wallack. I looked at him and I said, "What are you doing here?" "Well, I like cooking, it's fun." Soon after that he bought the restaurant. He opened it to local musicians and artists to showcase their work. He opened it for political discussion and sometimes I considered it my political office in Mt. Vernon. When Bob was trying to convince his wife, Vicki, to buy the Café he said half the people he covered in the newspaper business were angry at him at some sort of point he'd made. He wanted to do something to make everybody happy. He pushed food, comping more bowls of soup when they were empty. It was not just the food he doled out but the conversation that made people special. One fellow left his note of remembrance at the celebration of Bob's life. "Bob was a man that I knew only from my visits to the Café. Mt. Vernon, to me, was the Café. I did not know him well, but my visits were not as often as I would have liked, but he remembered me. For a boy of 12, this was very important, just to be remembered by an adult." Bob's talents didn't stop there because I went to a fundraiser for the Mt. Vernon Fire Department and this band was playing. In walked Bob. I said, "What are you doing here again? It was really great for you to come and support this thing." He said, "No, I'm the drummer." It appears that this band came down to his café one day in a fit because they'd lost their drummer. He said, "Well, I play drums." So he did. Bob was a mentor to many. He loved working with young people, more recently at the Café, and served as a mentor on many subjects. This is an important one. When a young man asked Bob if he had a shot of getting a beautiful co-worker to go out with him Bob's reply was, "You can't make the sale if you don't make the call." Bob was optimistic, politically incorrect. That's why he and I got along. He did not have a Facebook account. He understood why he didn't. He was the happiest when the Café was full of babies and beautiful women. A true man. He also treated everybody's grandmother as his own. One woman wrote, "I miss Bob so much. He called me Nana. He was so kind." One of the ones that made me smile at his remembrance is that at Christmas time this year, just before his diagnosis, he was hanging up Christmas wreaths with one of his helpers and he said, in his Bob way, "Just think of this, a Jew hanging up Christmas wreaths." Two weeks before he got his cancer diagnosis he told his wife they were the luckiest people he knew. In honor of his role as a mentor in the journalism world, the New England Newspaper and Press Association last month established the Bob Wallack Community Journalism Award to encourage young people to go into the newspaper business. I know that when Bob came stumbling and bumbling to the Pearly Gates he looked up at Saint Peter and said, "Life, what a ride." Right now I wouldn't be surprised if he is the editor of the Heavenly News, cook for God's kitchen, or playing the drums for the Angel's Heart Band, but he'd be doing something like that. In closing, I want you to think about some of the things that I was told. In honor of his role as a mentor in the kitchen, there are so many young people, including his daughters, who understood the secret of good chicken soup and everything tastes better with butter and bacon. He will be missed. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Oxford, Senator Patrick.

Senator **PATRICK:** Thank you Mr. President. Ladies and gentlemen of the Senate, colleagues and friends, here we go again. L.D. 1230, An Act To Improve Access to Oral Health Care. I would ask you to vote against the Indefinite Postponement. The Indefinite Postponement of this amendment, ladies and gentlemen, is contrary to what the idea of the bill was supposed to be. The bill, in its final form that was in the House for quite a while, that was passed by this Body, was amended by the House through the great work of Representative Sirocki and working with the Governor's Office. They got the bill into a posture, supposedly, where the Chief Executive was going to sign the bill. The bill, once it left here, is watered down a lot more than when it left here, but it was watered down in a manner that the hygienists, as I would characterize, having a small win. If we vote against Indefinite Postponement we can move on to finally passing some form of the bill that was through the sponsor and the idea behind the bill, that we would be actually agreeing with the House and all the good work that other Body did to get this bill in a position that I think is worthwhile. I would ask you to follow my light and vote against Indefinite Postponement of House "B". Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Washington, Senator Burns.

Senator **BURNS:** Thank you Mr. President. Men and women of the Senate, I, too, would echo what Senator Patrick just said and ask you to vote against this Indefinite Postponement. This bill, as was just said, has gone through many iterations in the last two years in order to get to the posture that it's in right now. To do this, to accept this Indefinite Postponement that's being proposed right now, would in essence ruin the bill, put it back to a place where many of you didn't agree with it in the posture that it originally was in. As I said, it has made many changes. The training has been changed. The requirements, the oversight. All the criteria that people wanted to see in this bill in order to make it something that was safe and practical and working and valuable to the rural parts of this state, especially, are in place now and ready to be acted upon. To support this motion that is on the floor right now would take that all away and waste a lot of good opportunity and a lot of good work that's gone into this to bring this forward. This is something that's going to help rural Maine. Please don't set it aside now. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Cushing.

Senator **CUSHING:** Thank you Mr. President. Ladies and gentlemen of the Senate, I rise now in support of the current motion before us. I do so, Mr. President, as a member of the committee who had oversight of this bill when it originally came to us last session. There was probably more testimony on this issue than even the marijuana issue. I think, Mr. President, that we heard the passion of people on both sides. I think that the individuals in the state of Maine who are involved in this, both on the dental side and the hygienist side, truly care about the oral healthcare needs in the state. The proponents of the bill worked diligently with the second floor to find something that would be a solution that would pass. I respect that. However, in this case, they can have their cake and eat it too. I believe there would be an amendment offered by the Senator from Kennebec that would address not only the language in the House Amendment but would also correct some technical changes that were left out in the House Amendment that had been agreed to in discussions with the second floor. Also, when it comes to the issue of oversight, Mr. President, I will reserve most of my comments in the event that we are successful in moving forward a Senate Amendment. In regards to my posture on this, I ask you to think about whether, at the end of the day when the dust settles, do we, as elected officials, particularly in the upper Body, have the responsibility to assure that the standards and the protocols that we pass in policy, into legislation, are appropriately balanced for the care and the safety of the citizens of Maine. I believe that the good Senator from Kennebec listened and may present measures that will assure that accreditation and oversight by the Legislature will be maintained during this transitional process. With that, I ask that you support this in the good spirit of moving the policy forward. Thank you, Mr. President.

On motion by Senator **PATRICK** of Oxford, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

**THE PRESIDENT:** The Chair recognizes the Senator from Oxford, Senator Patrick.

Senator **PATRICK**: Thank you Mr. President. Ladies and gentlemen of the Senate, colleagues in the Senate, I would like to just try to put this another way. A vote for Indefinite Postponement is a vote, basically, for the dentist to drive the bus. A vote for Indefinite Postponement is more a vote of the hygienist, who we passed the bill to drive the bus. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Penobscot, Senator Cushing.

Senator **CUSHING**: Thank you Mr. President. Ladies and gentlemen of the Senate, I have great respect for my good colleague from Oxford. He is a fair and balanced chair. In this case, I think there's been a misunderstanding. The language that may be proposed, and I realize we should not talk about issues not before the Body, but the language we're talking about Indefinitely Postponing could present itself in incorporation in a future amendment. Thank you, Mr. President.

**THE PRESIDENT**: The Chair recognizes the Senator from Kennebec, Senator Lachowicz.

Senator **LACHOWICZ**: Thank you Mr. President. I wasn't going to get up and speak because I'm not supposed to speak about a motion that's not before the Body yet, but I did want to thank the good Senator from Penobscot for pointing out that I may, in fact, have something to do after this. I just think that we should be mindful and understand that people have worked very hard to bring this forward and to work in a bi-partisan manner and with people with lots of competing interests. I thank this Body and the President for the opportunity to speak. Thank you very much.
