**JOINT RESOLUTION  
PROCLAIMING APRIL AS FINANCIAL LITERACY MONTH**

WHEREAS, according to recent statistics, the average American credit card debt is \$15,611, the average mortgage debt is \$155,192 and the average student loan debt is \$32,264; and

WHEREAS, the United States consumer debt in January of this year was \$3.328 trillion and, of this, \$2.44 trillion was nonrevolving debt and \$887.9 billion was credit card debt; and

WHEREAS, a household debt crisis occurs when a family starts falling behind on monthly payments, and any sudden loss of income, or increase in costs, can cause a household debt crisis; and

WHEREAS, approximately 13% of Americans do not have health insurance, which increases financial hardship for everyone; and

WHEREAS, one of the biggest reasons for debt is medical expenses, which cause half of all bankruptcies in the United States; and

WHEREAS, foreclosure filings for 2013, including notices of default, scheduled auctions and bank repossessions, were reported on 1.36 million properties; and

WHEREAS, financial education, which makes our State more financially literate, is important to improve the financial capability of Maine residents, from kindergarten to college and beyond; and

WHEREAS, financial education efforts are a key element in preventing future debt and financial difficulties and in developing in our citizens a better understanding of basic personal and business financial matters; and

WHEREAS, the Finance Authority of Maine offers a variety of statewide initiatives and education workshops and programs to the public and to schools on financial literacy and is committed to helping people manage their money; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-seventh Legislature now assembled in the First Regular Session, on behalf of the people we represent, urge the residents of the State to become more financially literate, and, in order to raise public awareness about the need for increased financial literacy education, we support naming April as Financial Literacy Month.

Senator **BRAKEY** of Androscoggin moved the Senate **ACCEPT** the Minority **OUGHT NOT TO PASS** Report, in **NON-CONCURRENCE**.

On motion by Senator **HASKELL** of Cumberland, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

**THE PRESIDENT PRO TEMPORE:** The Chair recognizes the Senator from Cumberland, Senator Haskell.

Senator **HASKELL:** Thank you very much, Mr. President. Ladies and gentlemen of the Senate, I rise on this bill because I believe this is a very important bill for transparency and sunshine. This is a bill, and I know not everybody has the opportunity as I do to have your folder right in front of you, but let me tell you what it is that this bill does. This bill, and the report, the Ought to Pass Report, would have three very specific positions within the Department of Health and Human Services become confirmable by this Body. That would be the Center for Disease Control and Prevention's Director, the Superintendent of the Dorothea Dix Psychiatric Center, and the Superintendent of the Riverview Psychiatric Center. These are critical positions. These are positions which have public facing elements to them in very strong ways. These are organizations and facilities within the Department of Health and Human Services that affect people's lives almost every day; their lives, their health, and their safety. I will tell you, in the list of appointments that are confirmable within the State government there is a wide variety. Most of your committees have more than one. Health and Human Services, which has about 40% of the State's budget, if I remember from my budget times, somewhere in that neighborhood, has one confirmable appointment for that large a department and that

diverse department. Within Ag, Conservation and Forestry there were eight confirmable positions or boards. Criminal Justice, there are six. Education, there are eight either boards or individuals. Energy, four. Environmental, three. Insurance, five. LCRED has 17 confirmable positions, and some of those are multiples for the boards. State and Local, three. Transportation, three. VLA, four. I could go on. Some of these positions are positions like the Mid-Coast Regional Development Authority, the Northeast Interstate Dairy Compact, the Passenger Rail Authority, the Quality of Place Counsel, the Superintendent of the Bureau of Consumer Credit Protection. I think protecting people's lives are as important as protecting their credit. The Superintendent of the Bureau of Banking, Washington County Development Authority Board of Trustees, the Commission on Indigent Legal Services, the Gambling Control Board, Harness Racing Commission, the Inland Fisheries and Wildlife Advisory Council. I want to tell you that I think that the Director of the Maine CDC and the Superintendents of the two psychiatric centers in the state of Maine rise to a level where oversight and public services are so important that the public ought to be able to weigh in. If the public can weigh in on our judges who are confirmed certainly the public weighing in on these important public services would be of value. I believe this is a timely, appropriate, and good government piece of legislation that would have these positions come before the committee of jurisdiction for review and I would urge you to vote against the pending motion. Thank you, Mr. President.

Members of the Senate, I rise today to speak in support of L.D. 80, a Resolution Proposing an Amendment to the Constitution of Maine to Lower the Age Requirement to Run for Legislative Office. I'd like to note that the vast majority, 11 members of the State and Local Government Committee, voted that this bill Ought to Pass and the Minority Report had two members on it. For proponents of this Resolution, I hear a lot of talk about what Maine's young people cannot do. I think inherent in this argument is the human error overgeneralization. Famed journalist Dorothy Thompson once remarked, "Age is not measured by years. Nature does not equally distribute energy. Some people are born old and tired while others are going strong at 70." In short, age is just a number. While some argue about what Maine's young people cannot do, let me begin with something our young people can do. At the age of 18 you can represent your nation on the battlefields of Afghanistan, but you still are ineligible to represent your community in the halls of Augusta. Why, when you are old enough to fight and die for your country, are you not considered old enough to participate in the crafting of State policy? This bill proposes an amendment to the State Constitution lowering the age to run for State House and State Senate to 18 years of age and 21 years of age respectively.

To understand why this is a reasonable change it is worthwhile to examine the history behind the current laws establishment. The Constitution of the State of Maine currently states that you must be 21 years of age to run for the State House of Representatives and 25 years of age to run for the State Senate. Why was 21 set as the minimum age to run for office? Well, if you look to history the answer becomes obvious. There was nothing magical about the age of 21. It was simply the age you became eligible to vote. Our State Constitution was adopted in the context of the United States Constitution and the U.S. Constitution established that a citizen became eligible to vote at the age of 21. It would be a little absurd to elect someone to office who's not even eligible to cast a vote for him or herself, so setting the age to run for office on par with eligibility to vote made

In 1971, however, we ratified the 26<sup>th</sup> Amendment to the United States Constitution, which lowered the voting age from 21 to 18, but, unlike many states, here in Maine we have never yet updated our age of eligibility to hold Legislative office, aligning it with the new eligibility to vote. Fourteen states, including neighboring New Hampshire and Massachusetts, allow citizens to run for their lower Legislative Chamber at the age of 18. A full 23 states, so nearly half of the United States, allow their citizens to run for the Upper Legislative Chamber by the time they're 21 years of age. I will note that despite this fact that you can run for Legislative office in the Upper Chamber at 21 years of age in nearly half of the states in our nation, that doesn't necessarily mean that that is a common occurrence. At the age of 26, I'm the youngest person in the country to hold office in an Upper Legislative Chamber. Just because you are making this change does not necessarily mean that it's going to happen in many cases.

Some say there is no guarantee an individual possesses the wisdom and maturity at the age of 18 to hold office. To that I respond that there is no guarantee that someone at any age possesses the wisdom and maturity to hold office. Certainly this is not a blanket rule. Just as we can all think of individuals under the age of 21 who do possess what it takes to serve diligently, I'm sure we can also think of individuals ranging in age from young to old, over the age of 21, who do not. We do not impose any test of character on these individuals except the requirement that the voters be the judge of all candidates who seek to represent them. I will point out that there are three members of this Body elected under the age of 30. While I'm too modest to sing my own praises, I will suggest that at least the other two can count themselves among the most diligent and thoughtful members of this Body, and I do not think anyone in this Body would contest that. Especially in a state that is so proud of its veterans, I believe it is time to recognize that if you are old enough to represent us on the battlefield you are old enough to represent us in Augusta. Thank you very much for the time and I hope that this Body will reject the motion of Ought Not to Pass and pass this Resolution. Thank you very much.

**THE PRESIDENT PRO TEMPORE:** The Chair recognizes the Senator from Aroostook, Senator Willette.

Senator **WILLETTE:** Thank you, Mr. President. I didn't have any prepared speeches or testimony to speak on this, but I do have a little bit of family experience in younger people running for office. As most of you know, my son, the Honorable Alex Willette, I can't imagine if Alex were 18, 19, or 20, telling him or feeling that I could talk him out of running for office just because of his age. I want to impress on people, if we do pass this, this doesn't mean that we're going to have a flood of 18 year old kids running for office. I think the process and the job that comes with holding office will weed out the field. I couldn't imagine, you know, my son at that age basically limiting himself for wanting to support the people of his district. Just to give you a quick rundown of some of his achievements. He was the youngest member of the 125<sup>th</sup> Legislature. The youngest member to hold a Leadership position at the age of 23. That was the youngest in the country at the time. He's also the youngest ever male member to be elected to as committee member to serve on the RNC, only to be one upped by Maine's own Ashley Ryan, who's the youngest member ever to hold a committee member seat on the RNC. The good Senator Brakey brings up a really good point. For me as a combat

veteran, talking about our young kids, 18 years you're able to go fight for your country. I can't imagine someone going to fight for their country, or serve for their country, maybe get out when they are 20, and then feel the need to represent their constituents and not be able to. I don't think that we should all be scared just because we're going to lower this age to 18. There are some very level-headed and mature 18 year olds out there that can bring a fresh new vision to this Body and the Body down the hall. I will be voting with my good friend, Senator Brakey, on this motion.

Senator **VALENTINO:** Thank you, Mr. President. Men and women of the Senate, I just rise today to kind of comment on some of the comments that I've heard about the military coming back home and being able to serve on that. I like to be consistent in some of my votes and I would say that if you refer to page 10 of your Senate Calendar today on L.D. 1219, I was a co-sponsor of this bill, "An Act to Allow Active Members and Veterans of the Armed Forces Who Are At Least 18 Years of Age and Under 21 Years of Age to Consume Alcohol at Eligible Veterans' Organization Posts and American Legion Halls." The entire committee voted unanimously not to allow people who had gone to war to drink when they came home and this Body just let this pass under the hammer. I do not feel there is any consistency in this. You're saying that, yes, you should be able to come home and run for Senate, but you can't go and have a beer, and I think they should. I just wanted to point your attention to how you're saying one thing and voting another. Me included, all of us.

I just want you to think about a few things before we vote on this bill. First, seniors between the age of 65 and 74 overwhelmingly own their homes in Maine with homeownership of 81%. We also know seniors reach a point where maintaining a home is no longer feasible. In fact, the percentage of homeownership among seniors between the ages of 75 and 84 drops by ten points from the former age bracket. On the other hand, young persons making the commitment to own their home is on the decline. While nationwide home buyers' median age was 32 years old, here in Maine the median age of home buyers in 2013 was 43 years old. Student loan debt has increased from \$241 billion to \$1.1 trillion in just 11 years nationwide. Five point nine million, or 35%, of the 16.8 million households in the country pay more than \$250 per month in student loans. This bill represents an opportunity to get out in front of this issue. It represents an opportunity to bring together industry leaders in banking, real estate, finances, education, and so on who recognize the complex issue of student loan debt and its impact on home buying as one that must be addressed sooner rather than later. Senator **JOHNSON:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I'd like to point out that when this bill was heard there were a number of people who testified in support and there was no one who testified against it. In particular, I'd like to share with you the testimony of B.J. Allen Company, Philip Silverman, I believe you have the green sheets on your desk which is a copy of his testimony. I will share a few of his thoughts from Mr. Silverman. He said he's a regional manager from Phantom Fireworks here today to testify in favor of L.D. 302, An Act to Encourage Responsible Consumer Fireworks Use." He went on to say that at the outset he was proud to let you know that both of their stores in Maine, particularly their Scarborough location, are among the very highest performing locations of theirs in the country and that Phantom Fireworks spends a great deal of time and resources to educate their customers on the proper way to use consumer fireworks. "In recent years, we have made an effort to expand our safety education to include a Respect Your Neighbor campaign," he said. The purpose of that was to make their customers aware of the impact that using consumer fireworks could have in their communities. One of the major points that they emphasize is being courteous to your neighbors by letting them know when you plan to have a show. He said, "We also encourage people to make any neighbors with livestock aware of the time they plan to use consumer fireworks." The last topic they stress with their customers is to make sure that they clean up after themselves by properly disposing of all the debris.

In the 126<sup>th</sup> Maine Legislature the committee considered several bills addressing the impact of consumer fireworks on livestock and they had never encountered a similar issue in any of the other states where they operate. It was an educational experience. After listening to the committee's exhaustive discussions on the issue, they came away convinced that the approach set forth in L.D. 302 is the soundest among all the options presented; specifically, rather than imposing a large arbitrary buffer around certain properties, it gives law enforcement discretion to assess on a case-by-case basis whether an individual's use of consumer fireworks is unreasonable under the circumstances. This sort of fact specific approach, they believe, can capture the problems being faced by Maine livestock owners as well as a variety of other situations where fireworks may be misused.

I will remind you that this is the testimony of a fireworks retail vendor in support of L.D. 302 in which they urge, for those reasons, the passage and support of L.D. 302. This is something which we've heard from a lot of people in the state of Maine coming in that affects their own lives, their own enjoyment of what

is so great about Maine; why we want people coming here. From my own constituents, I've heard the people who use to rent their camps to people that are now saying, "Well, I'm not sure I want to come back. I came here to enjoy a peaceful lake and watch the loons and what I got was fireworks to my left and to my right and people that didn't respect my right to enjoy what I came here for, at least part of the time." We heard, when the testimony was delivered on this bill, L.D. 302, for Criminal Justice and Public Safety, a gentleman, who is not one of my constituents but who has a camp in my district, who is a veteran and is affected by the fireworks there. His PTSD that it triggers is a serious problem for him. He no longer enjoys going there. I think we ought to respect that.

I urge your support for L.D. 302 precisely because it does as Mr. Silverman said, allows for a fact based assessment on a case-by-case basis by law enforcement whether someone is being unreasonable. There is no arbitrary definition of what is acceptable in using fireworks. It's the same sort of standard that we expect law enforcement officers to exercise every day in dealing with complaints in neighborhoods and cities and in rural Maine. I think we should give them that same ability to make those reasonable decisions to protect the interests and the rights of neighbors of people who are using fireworks when someone is not respecting their rights. For that reason, I urge your vote of No on the pending motion. Let's do that and Enact 302. Thank you.

Senator **GERZOFSKY:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I stand today in opposition to the current motion. On motion by Senator **LIBBY** of Androscoggin, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Libby.

Senator **LIBBY:** Thank you, Mr. President. Men and women of the Senate, I rise today in opposition to the pending motion. The Minority Report, this legislation will help low income school districts and their property taxpayers over the next few years by blunting the State mandated increase in local education costs over the next three years. For several years it was the State's policy to provide a waiver from penalty for school districts that didn't meet their minimum local share of education spending. The rationale for this, as we all know the State has not met its commitment to fund schools at 55%. This waiver that was in place recognized that if the State wasn't meeting its required share that local districts that weren't meeting their required share

by the same percentage wouldn't be penalized. This was a practical policy, recognizing that despite the EPS formulas numerous accommodations for variety among school districts and their property taxpayers, and would recognize that the local share calculation wasn't perfect and that limited exceptions can and should be made for school districts in unique and difficult situations. The 126<sup>th</sup> Legislature eliminated this waiver through a three year phase out. Most districts are now in the second year of that phase out and are very close to meeting 100% of their local minimum required share, but for the current upcoming year many municipalities will see a severe spike in their property tax rates caused by this final year of the phase out.

My local budget was recently presented and it's calling for a \$1.2 million increase to Lewiston taxpayers to meet the final year of the phase out required by the State. A \$1.2 million increase this year is a 6.5% increase in our school budget alone. To give you a sense of how we've dealt with that locally, we've had to make severe cuts to the city side of the budget. We've made cuts to personnel, cuts to road funding. Municipal revenue sharing cuts over the last year haven't helped. Increased State unfunded mandates haven't helped either. Going forward, if nothing changes, the average Lewiston property taxpayer, that is the average family that owns a \$150,000 home, is going to be required to pitch in an extra \$220 just for this year's increase in education spending.

The Minority Report recognizes that school districts have made significant progress in meeting the minimum local share of education funding in the second and third year of the phase out. This legislation provides an additional three years to get over that final hump. This bill actually would only affect a very limited number of school districts. It would help districts of Auburn, Augusta, Biddeford, Lewiston, Waterville, RSU 9, RSU 17, RSU 33. Given this limited number to which this piece of legislation would apply, and given the severe property tax increases that residents, the elderly, and young families are going to have to absorb this year, I'd say that this legislation is a fairly practical policy. It's a humane policy. It allows those districts that are going to see a huge spike in their property tax increase this year to have a little bit of breathing room. I thank you, Mr. President and members of the Senate for your time this morning, this afternoon. I would ask you to vote against the current motion.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Millett.

Senator **MILLETT:** Thank you, Mr. President. Ladies and gentlemen of the Senate, this bill seeks to extend the phase in by two more years. It disrupts the momentum districts have achieved in their efforts to reach the required local share. If we go backwards now we may never catch up. Our school boards, our superintendents, our principals, our teachers, and a supermajority of the Education Committee opposed this bill. In 2013 we passed legislation that assured all districts, over a reasonable three year period, would be investing the minimum required amount for adequate education for our students. There was considerable discussion leading to this decision. The Education Committee recognizes that, as currently proposed in the budget, the mill rate is projected to increase substantially and, as such, the Committee, as a whole, supports additional State funding to minimize the increase in the mill rate, although to varying levels. We are working hard to get the State investment to its required level and our districts need to be encouraged to do

so as well. It's the right thing to do for public education. It's the right thing to do for our children.

At the request of Senator **LANGLEY** of Hancock, Reports **READ**.

**THE PRESIDENT:** The Chair recognizes the Senator from Hancock, Senator Langley.

Senator **LANGLEY:** Thank you, Mr. President. Men and women of the Senate, my question I would ask is sort of rhetorical in nature. Why would we continue to have a formula that would adequately fund education in our schools if we're not going to use that formula? We have that in place and there are some schools that continually have underfunded. We recognize the implications of that back in the 126<sup>th</sup> when Representative Maker put in her bill and put in a three year phase out, or phase in, of this proposal, a phase out of the waiver. Folks have known about that and my guess is that in two more years you would see folks back here looking to extend this into perpetuity. I would ask that you support the Majority of the Education Committee and vote on the Ought Not to Pass. Thank you very much.

**THE PRESIDENT:** The pending question before the Senate is the motion by the Senator from Hancock, Senator Langley to Accept the Majority Ought Not to Pass Report. A Roll Call has been ordered. Is the Senate ready for the question?

On motion by Senator **DILL** of Penobscot, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Dill.

Senator **DILL:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I have been a member of the Board of Directors for UTC, which is the United Technology Center, which is the local CTE, which is the Career and Technical Education School in Bangor, for the past 19 years and Chair for the past 5 years. One of our biggest challenges at UTC in the most recent years has been trying to align our calendars to have no more than five days not in common, which is what the law states. We have seven sending schools. What this means is that when you have a regional CTE the neighboring high schools send their students to this if they so desire. In the case of UTC, we have Brewer, Old Town, Orono, Hampden, Hermon, Bangor, and Central. Those are our seven major sending schools, but we also have John Bapst and Bangor Christian, which only send a couple of students to us each year. Technically, we have nine but we look at seven as the major players. The way the calendar works is the sending schools must put their calendars together and try to make sure, again, that there is no more than five days out of alignment. If you have maybe three sending schools or four sending schools this may not be too difficult because the law says, again, five days out of alignment. It may not be as difficult if you have only got three or four sending schools, but when you have six, seven, or more this becomes quite a task. Although we try hard to accomplish this requirement, we have succeeded in getting down to maybe seven or eight days each year out of alignment. Now admittedly, we can request a waiver from the Department of Education and to date the DOE has honored that request. However, the concern is that at some point the DOE is not going to honor that request and the penalty is severe. The penalty is 100% of your State subsidy will not be given to all of the sending schools. If you're out of whack, that's 100% of your allotment from the State that can be held back until you become in alignment.

As we move forward what is happening, the new testing systems, Smarter Balances, come into play and we have two to three months of time that will be allotted to testing. Over that period of time, in this case, the seven sending schools may not line up very well when they choose to actually do their testing. That exacerbates our problem about trying to align the different dates. I also realize, as a teacher at CTE, it's kind of difficult when a teacher has missing students from class because that student, or those students, may get behind. However, many of

the sending schools do encourage their students to attend. Even as long as the CTE is in session they encourage their students to attend. However, not all school systems are set up to be able to bus their students there so, yes, there can be some missing students.

This bill, what it does is gives us a little more local control with our calendars rather than being dictated by the State. If the State wants to control the calendars than maybe what they need to do is look and have common days; common starting date or maybe certain days that are obligated to in-service training days during the school year. What basically this bill does is changes the calendar as follows: if you have three or fewer sending schools than it's five days. If you have four or five sending schools than it's six days. If you have six or more sending schools than you can be out of alignment by seven days. Seven days, at least for us, is much more approachable and, hopefully, doable than being five days. It seems to be, to me, a fairly innocuous bill, but important nonetheless. Thank you for your attention.

**THE PRESIDENT:** The Chair recognizes the Senator from Hancock, Senator Langley.

Senator **LANGLEY:** Thank you, Mr. President. Men and women of the Senate, I would rise and ask you to support the Majority Ought Not to Pass Report on this. My testimony today and my floor speech comes from spending nearly 30 years in the classroom in a CTE, trying to reach all students and deliver to them quality education. Frankly, this is an adult problem with the calendars. We could go weeks and weeks on end, because of dissimilar calendars, of not having a full classroom of students to teach and we have a requirement of 350 contact hours in the CTE course list. That is 350 hours before people can sit for their welding exams. They have to have 100 clinical hours before you can have CNAs be qualified for their boards to become CNAs.

Frankly, this really is an adult problem, sitting down to work out the schedules. I called the person who probably has the hardest time of all with calendars and schedules, that's Mike Johnson, the Director of PATC, the Portland Arts and Technology Center. Mike Johnson told me last week he has 23 schools, nine separate calendars, to deal with. Frankly, Mr. President, they are going to be within those five days this year. As the adults, here's what they did. He told me, "We aligned our schedules around our vacations. When did we go on Christmas break? Thanksgiving break? Days before April and February vacations. That cleared up five dissimilar days just in that one act." Then they talked about when they were going to have their teacher workshop days. They sat and picked common days for that and another five days were wiped off the calendar. Frankly, some of the benefits of having common days in the district, they have a regional approach to doing professional development. They can send their teachers to other schools. The benefits of having a regional calendar abound. Men and women of the Senate, I would suggest to you that if they can do it and get within five days in Portland with all of the schools that they've got to deal with, a little more work by the adults and the other schools will come into compliance as well. Thank you very much.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Millett.

Senator **MILLETT**: Thank you, Mr. President. Ladies and gentlemen of the Senate, I rise in opposition to this motion. Every year school districts across the state engage in the grueling process of setting school calendars. I can say grueling because I experienced this exercise for over 6 years as a school board member. There are certain things that stand out from one's service on a school board, and certainly budget preparation is notable, but the memory of trying to align the goals of instruction time, professional development time, assessments, school holidays, and regional career or technical schools is equally vivid. It is an unforgiving process which often, if not always, leaves one or more stakeholders unhappy. Current law punishes districts that have more than five dissimilar days in their school calendar, yet each school has its own plan for teacher evaluation, professional development, proficiency based instruction, assessments, and Maine standard professional development. The number of school days differ. First and last days of schools differ. Teacher contracts differ. Punishing districts by withholding State funding for being unable to match up all of these schools is unrealistic and unreasonable. Unfortunately, I'm going to have to disagree with the good Senator. Portland has yet to match the five days and continues to struggle year after year to do so. This bill recognizes the challenge of combining calendars as the number of participating school administrative units increase. It is a practical approach which recognizes the hard work that is going on within the districts and continues to reinforce the importance of consistency. I hope you will join me in opposing this motion.
