THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Dill.

Senator **DILL:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I want to speak briefly on L.D. 889 and request that you vote against the Ought Not to Pass. Ultraviolet light can really do a number on the skin. I'm sure you've all seen people that have skin that looks like leather. You have to soak up a lot of UV light to get to that point. I don't want to get too far into the weeds, but it is time for a very quick science lesson here. So we're going to talk a little bit about ultraviolet light 101. UV light is made up of three bands: A, B, and C. Solar rays are about 95% A, almost 5% B, and very negligible C. Both A and B penetrate our skin and in the past it was thought that B was very much the cause of sunburn. It has since been found and learned that A also penetrates the skin and penetrates the skin much more deeply. When you look at tanning devices, these deliver 5 to 15 times more UV A than the sun does. So you can just think that what the sun can do to your skin, just think of something that's going to give you 5 to 15 times more UV A. Laying in a tanning bed is causing many changes in the skin. The younger the person the more severe the damage may be. Melanoma is the most dangerous form of skin cancer and the second most common cancer in females ages 15 to 29. Reducing exposure to UV radiation is an important way to reduce these rates. Studies printed in the British medical journal have shown that using tanning devices before the age of 35 increases the risk of melanoma by 59%, squamous cell carcinoma by 67%, and basal cell carcinoma by 29%. Reports have also shown that 1 in 6 high school senior girls have used tanning devices, with nearly 56% of them reporting getting a burn from them and almost 17% reported using them 10 or more times. Some kids have even reported using them almost daily. So I think it's time that we put a stop to this for people under the age of 18, which is what this bill would do. It's a serious, serious problem here in the United States. But enough of my science lesson for the day. Please follow my light and ban tanning devices. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Brakey.

Senator **BRAKEY:** Thank you, Mr. President. I rise in support of the Ought Not to Pass motion on L.D. 889. There are several problems with this bill, and I will outline a few of them. This bill, first of all, would prohibit - let's just outline what it does. This bill would prohibit all persons under the age of 18 from tanning at a tanning salon, taking away the rights and responsibilities of parents to make these decisions. So before we vote on this legislation, I think it's first important that we know and understand what current Maine law dictates for minors at tanning salons because it's very restrictive. First, absolutely everyone under the age of 14 is already prohibited from tanning at a tanning salon, so only minors age 14 to 17 are targeted by this legislation. Second, parental permission is already required for minors age 14 to 17. Tanning salons are required to confirm identification for both the minor and the parent with written consent required from the minor's parent. This written consent is only valid for a year and can be revoked at any time. Furthermore, for minors age 14 and

15, their parent must be physically present with them at the salon. So we already have many restrictions in place for minors to guarantee parents have the final say. Beyond violating parental rights and responsibilities, this legislation would have further unintended consequences. Many arguing for this bill are concerned about increased risk of cancer from over exposure to UV rays. First I'll say that concern is valid, if somewhat overstated. I think we've heard from some of the advocates on this. They say that tanning increases the risk of skin cancer by 50%. That's the number we've heard. That sounds like a very big increase, but we have to put that in context to understand what that really means. The rate of skin cancer in the population at large is between 0.2% and 0.3%, so people who tan, if they have a skin cancer rate of 0.5%, that's called a 50% increase. Furthermore, the rise in the rate of skin cancer from tanning is mostly associated with unmonitored and unregulated tanning, not the highly structured environment of a tanning salon where individuals are monitored by professionals and restricted from tanning any longer than what is recommended as safe for their individual factors, including skin tone and hair color. Research in the Journal of the American Academy of Dermatologist's has established that for teens over the age of 16, who can drive, they simply tan more aggressively outdoors or will turn to unregulated and unmonitored home tanning units in friend's basements, apartments, and gyms if they are not permitted to tan in a professional monitored salon with their parent's consent. This simply drives the issue underground and into non-salon sunbeds, which today account for 41% of all tanning. These non-salons sunbeds do not have the exposure controls present in professional tanning facilities. Good luck to us if we try outlawing the use of personally owned sunbeds for minors. They are out there. They exist. We can't stop that. Even better luck to us if we want to try outlawing the single largest source of ultraviolet rays, our sun. Mr. President, not only does this legislation violate parental rights and responsibilities, it would accomplish the very opposite of what those advocating for it intend. This legislation would increase the risk of skin cancer for tanning youth by denying them access to a monitored and controlled environment. On a lot of other issues we talk a lot about harm reduction strategies. I think this legislation for this particular issue would amount to a harm increase strategy. Thank you very much.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Gratwick.

Senator **GRATWICK:** Thank you very much, Mr. President. I wish to speak to four points on this. One is that if you get a skin cancer, melanoma is not the one you want to have. Melanoma, the incidents in the United States is 87,000 people get melanoma; of that 9,000 die. We've heard from the good Senator from Androscoggin that's only a difference between 0.3% and 0.5%. On the other hand, that's also 9,000 people. That's not just a statistic, it's real people, 9,000 people die of this nasty, nasty disease. The second thing is that virtually all professional organizations that have knowledge about this are against skin tanning by kids less than 18. The American Academy of Pediatrics, the American Academy of Dermatology, Pediatric Dermatology, the World Health Organization views sun tanning salons as being contra indicator - black box warning for young people. Third, we make many restrictions on young people because it takes a while for young people's brains to adjust and we restrict smoking. Do kids still smoke? Of course. Is it a good

idea? No. We restrict it as a society. We restrict drinking. We make sure that they wear their seatbelts. They've got to be in car seats when they're young. They can't have tattoos. There are many things that we tell young people in our society that this is what we, your older folks, think is appropriate. Are we interfering with a parent's rights to give their kids alcohol or cigarettes when they're less than 18? Perhaps, but we, as a society, have judged this as an inappropriate way to go. This is no different than that. This is good public health. It's been in this assembly since 2009. I very much hope it will pass this time. If it doesn't, it will be back next year. This has been adopted in 18 other states. In France they ban it totally. Brazil, they ban it. Those are countries where beauty is admired a great deal. Finally, cost. The cost of skin cancer treatment in the United States is \$8 billion a year, of that \$3 billion, that's with a B, goes to melanoma. The surgery you have, at the very minimum, if you have a little pea sized wart, usually dark, but can be light colored, it's never perfect, the usual lesion to have it resected is about 4" to 5" in diameter because it infiltrates like a spider plant under the skin. That's \$3 billion spent for this particular illness. I urge very much for you to follow my light. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Knox, Senator Miramant.

Senator **MIRAMANT:** Thank you, Mr. President. Men and women of the Senate, the paradox beside me and with this bill is that we're talking about the increase of skin cancer and we might as well have the whole story out there. Yes, there is an increase in radiation. Yes, the other increase in skin cancer corresponds exactly with the drug industry's promotion of anti-burn creams. Sun block. As it came out, it told you that now you can sit in the sun. As Senator Dill was talking about, what happens is you block the radiation that allows your skin to tan or burn. You're getting around one of our natural defense systems. When you try to trick the body, we don't do well with it. So we've got 50 years of people laying on the beaches and allowing the worst rays, the most harmful ultraviolet rays, to soak into their skin and, instead of allowing your body to say, "Hey, you've had enough sun," and getting out of it, we're having this big incidence of skin cancer. It just always amazes me that it's more out there, but I know the source. The same people that told you, told our doctors, that Oxycontin was non-addictive and a helpful drug that drove this opioid crisis that we have. They are the same people telling us to lather up and lay in the sun, you won't burn, you're all good. Yet we have this big rise in skin cancer. So if you want to not burn, put some clothes on if you're getting too much sun. Don't trust the sunblock. Stay out of the tanning beds, whether you're 14 or 40. Thanks for listening.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Volk.

Senator **VOLK:** Thank you, Mr. President. Mr. President, ladies and gentlemen of the Senate, I rise in opposition to the pending motion. As we've heard from some of our colleagues, melanoma is the deadliest forms of skin cancer and it is one of the most common types of cancer in young people, especially in young girls. In fact, it is the fourth most common cancer in all individuals age 15 to 29 and the second most common cancer among females age 15 to 29. So we do have to wonder why females would have an elevated amount of skin cancer and I think that

comes to the season that we're in right now, especially in the Northeast and in the northern part of our country. That is prom season. I have actually known girls who have tanned just to go dress shopping. I'm the mother of three girls and the pressures that teens and teens face to look good at all times is really quite dramatic. You know, here in the Northeast, last week we had temperatures in the 40s and, you know, today is a beautiful day, tomorrow promises to be even more gorgeous, and so, you know, these girls turn to indoor tanning. The fact is that we have a lot of other safer alternatives that are now accessible for them to find ways to look good. So, you know, they can go and take advantage of those opportunities. So while keeping all minors out of tanning devices won't eliminate skin cancer or melanoma, it will go a long way towards reducing one of the most commonly diagnosed diseases among young people. Like with lead paint and tobacco, all children deserve protection from substances and devices proven to be hazardous to their health. My goal, as a State Senator, has been to advance legislation that encourages businesses and families to flourish in Maine. This bill may seem unusual for someone who has consistently made economic development a priority, we were talking about that here yesterday, but, as with any legislation, I weigh the pros and cons and I have been convinced that, just as we keep tobacco and other known carcinogens away from juveniles for their own good and the good of society, we need to keep them from tanning facilities also. You know what? Every young life in Maine is precious. We are the oldest state in the country and we simply can't afford to have kids risking their lives in tanning facilities. We can't afford, as a state, to pay for the medical costs associated when those kids, if they do, contract melanoma. So I urge you to oppose the pending motion and follow my light. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Katz.

Senator **KATZ:** Thank you, Mr. President. Men and women of the Senate, 17 year old Susie wants to go to a tanning salon in advance of the Junior Prom. We all agree that Susie should not make that decision for herself. The question is: who ought to make that decision? Should it be Susie's parents or should it be the State? I would suggest, Mr. President, that decision ought to be made by the parents, the same parents, by the way, that can legally, shouldn't but can legally, allow their child to smoke in their own home, can legally allow the child to have a glass of wine in their own home, and the same principle, I would suggest, applies here because it seems to me, Mr. President, that every time we say to a parent, "Don't worry, we'll take care of your child by putting blocks on parental authority," every time we do that it makes it easier for the parents to cede authority over their own children to the State we're going in the wrong direction. I will be voting in favor of the pending motion. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Brakey.

Senator **BRAKEY:** Thank you, Mr. President. I apologize for rising a second time. I just heard it stated a few times that this bill would prohibit young people from using tanning beds. I just wanted to highlight again that is not accurate. This bill prohibits minors from using tanning beds in highly regulated and monitors facilities. It does nothing to prohibit young people from using tanning beds in unregulated and unmonitored environments

where they are at much higher risk of over-using these machines and damaging themselves. I'll just leave it there. Thank you.

THE PRESIDENT: The pending question before the Senate is the motion by the Senator from Androscoggin, Senator Brakey, to Accept the Minority Ought Not to Pass Report. A Roll Call has been ordered. Is the Senate ready for the question?

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Katz.

Senator **KATZ:** Thank you, Mr. President. Mr. President and men and women of the Senate, the goal of this bill is simple. It's to save lives through early detection of lung cancer. What this bill would do, Mr. President, is to apply the same standards that CMS provides for Medicare patients in deciding which patients are going to get screened for potential lung cancer; people through genetic predisposition because of their parents and grandparents, people who have been smokers, and if they fit within these criteria they would have a rather simple and rather inexpensive test for lung cancer. The implications of having the test are significant because the earlier it's caught the better and, obviously, we want to save lives. Just in terms of the public purse, Mr. President, treating lung cancer is extremely expensive. I think we all know that. The fiscal note on this bill, if it passes, it will have to go downstairs and compete with other priorities, but the fiscal note is about \$146,000 a year. I don't know what it costs to treat one case of lung cancer, but I suspect it is far in excess of, just one case, the cost of this bill. I'd suggest this makes sense. It would align Maine with how we deal with this in Medicare and, of course, the federal government will be paying a significant portion of this. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Chipman.

Senator **CHIPMAN:** Thank you, Mr. President. Men and women of the Senate, there was no opposition to this bill at the public hearing in committee. The bill has bi-partisan support and the fact of the matter is that most private insurance companies provide for one screening per year. Medicare patients can get one screening per year. We just think it made sense that MaineCare patients have that one screening per year because early detection does really save lives. I think this bill will save us a lot of money in the long run. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Brakey.

Senator **BRAKEY:** Thank you, Mr. President. I rise in support of the Ought Not to Pass motion for one simple reason. We don't have the money. Yes, it's \$150,000 a year, but right now in Health and Human Services we have wait lists that we are not properly funding. We have services we are already providing that the rates are so low that we need to bring up those rates in order to adequately attract providers. These are some of the spending priorities that we are wrestling with right now. I know that in this Body we often feel comfortable passing something along to the Appropriations Committee knowing it's never going to be funded and just let the Appropriations Committee be the bad guy and say, "No, we can't do it. We can't afford it." I don't like to operate that way. I don't think that that sends clear signals about what our priorities are. In the Health and Human Services Committee my priority is making sure we are paying for our wait lists that currently exist, first of all, and, second of all, bringing up the rates for services that we currently have to what is good enough to

attract providers. We need to do those things before we start adding new services that we're going to start compensating for. I'll leave it at that.

THE PRESIDENT: The Chair recognizes the Senator from Franklin, Senator Saviello.

Senator **SAVIELLO:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I rise, unfortunately, to oppose my good friend, the Senator who just spoke. It's rather concerning to me that we continue to operate in silos because I do understand the comment about the \$150,000 and how much money needs to be set aside that we may or may not have. However, the savings will be significant. Any of you that have suffered through cancer in your family, you know what it costs to treat that and if you can catch it early the savings are phenomenal. We can't book that savings, but it's real. Thank you very much, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Breen.

Senator **BREEN:** Thank you, Mr. President. Men and women of the Senate, I rise simply to remind everyone that when we speak on the floor we speak to the bill and I suggest that we let the Appropriations Committee do its job so that when a bill passes and is moved to the Appropriations Table the process takes place and that in this Body, when we are talking about bills that have a fiscal impact, we make sure we stick to the subject, which is the bill on the table and the report in front of us. Thank you, Mr. President.

THE PRESIDENT: I certainly appreciate the reminder and I will be sure to remind other folks. The Chair recognizes the Senator from Penobscot, Senator Gratwick.

Senator **GRATWICK:** Thank you, Mr. President. Just a very brief reminder that lung cancer is not at all cheap to treat. Anywhere from \$12,000, if you have a very simple thoracotomy to open up and take out something, to multiple hundreds of thousands if it's metastasized. Maine is one of the eleven states that has the highest rates of lung cancer and the rate is anywhere between 68 and 94 per 100,000 people. If we do not pass this we're being penny wise and pound foolish. I look for the larger picture and we'll be saving both lives and money. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Brakey.

Senator **BRAKEY:** Thank you, Mr. President. I'll just say, you know, if every bill that we passed that was supposed to book long term savings and save money down the road, if every bill we passed actually ended up doing that, then I think government would be a lot cheaper than it is right now. I'll leave it at that.

THE PRESIDENT: The Chair recognizes the Senator from Franklin, Senator Saviello.

Senator **SAVIELLO:** Thank you, Mr. President. Mr. President, I put this bill in primarily because of an incident I ran into in the little Town of Phillips a couple of years ago. They were having a fundraiser for a trail that they were developing and they approached me and said, "We have an individual who, fortunately, has some moose meat that he would like to donate to us so that we can sell moose burgers. This would be a great fundraiser where we could advertise, you know, moose meat from the local area of which we could charge \$10 for the hamburger and we could use those funds raised towards the community." So I, being the good diligent Legislator I was, called Inland Fisheries and Wildlife to make sure that it was okay for me to do. I found out no, we could not sell the hamburgers. However, we could sell a Coca-Cola or Pepsi Cola and charge \$12 for that, which would now mean we would donate a moose burger with that Coca-Cola. To me, that borders on the line of ridiculous. Now I know there are concerns about our wildlife being sold off, however I'm sure that if we vote this motion down there might be an opportunity to make sure that only charitable and non-profit organizations can take advantage of this opportunity in our hands. So I'm asking you to vote no on this motion and allow charitable groups to raise money where no one who shoots the moose profits, but the society does. Thank you very much, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Cyrway.

Senator **CYRWAY:** Thank you, Mr. President. Ladies and gentlemen of the Senate, this bill allows fees to be charged for wild game dinners, which was discussed at length and ending up with a 9 Ought Not to Pass and 2 Ought to Pass as Amended vote. The main reason the Inland Fisheries and Wildlife strongly opposed this bill was per Commissioner and the Deputy Commissioner and the Colonel of the Warden Service. They were concerned that this would cross the line for commercializing the sale of our wildlife meat sources. I trust and respect the judgment of the Wildlife Management Resource administration who spoke up and stated donating wildlife meat is already being done legally to non-profit benefit dinners for great causes. This bill comes out and says they are selling and labeling moose meat, deer meat, turkey, or any other wild game. This could even be placed on the menu with dinners priced out. Is that what we really want to do to our heritage wildlife? We do not raise wildlife. Let's respect and continue to manage our precious wildlife, so please let's not commercialize our wildlife meats for dining pleasure. I know squirrel sometimes tastes like chicken but I'm not sure. This could have unintended consequences of hunting for the wrong reasons. Thank you for listening to my serious concerns on this matter. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Franklin, Senator Saviello.

Senator **SAVIELLO:** Thank you, Mr. President. Mr. President, the only thing I'll add is that this is not commercializing the sale of our material because you're not selling it. You're not selling it to the non-profit group. Let me say this, I reemphasize, it's a wink and a nod. It's okay to do this, it's okay to do this but you can't charge for it. So we're not really commercializing it, but yes we are. So let's just put it in law so it's very clear that it can be done. Thank you very much, Mr. President.
