Everything's going up and I'm just speaking for our communities. So, hopefully that we can all do what we can in our positions and help these people out. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from York, Senator Deschambault.

Senator **DESCHAMBAULT**: Thank you. No, I'm not going to sing. I'd like to share something with you, and off the record because it's about us. I got this email, and we all get emails from constituents, some of them thanking us. This one really touched me.

'I am writing as a current resident of Arundel, Maine to say how extremely pleased I am to see in our local paper that the Maine Legislature passed Universal Free School Meals in our public schools!!! As the parents of two students who went to the school in Arundel, we sometimes qualified for the free lunch program. Often my children were too embarrassed to go up to the monitor with the clipboard of 'approved' names and to get the free lunch. Consequently, they went hungry if they forgot to remind me to make a sandwich at 6:30 in the morning. I have always felt that all the students should be able to get free lunch, regardless if they are qualified based on family income. This way they would, hopefully, be no stigma attached to getting a school lunch. Bravo to our current Legislature.'

As an aside, we have the Honorable Joyce Maker, when I was first here that was the rally cry for Joyce Maker to get free school lunch for the kids. So, once in a while we're ending our term here, some of us, but we're ending the 130<sup>th</sup> and bravo, I repeat that, to all of us to do things like this. Thank you very much.

THE PRESIDENT: Seeing no other announcements, the Chair would like to say that I believe we ended sometime early May and haven't been back since then and while we had announcements. conversations that night, I had a pretty good idea we'd be back a final time. This probably is, quite frankly, the last time for the 130<sup>th</sup> Legislature and I have been nervous all morning, into the afternoon, because you never know, obviously, if or when you'll be back. But I have enjoyed myself immensely with all of you in the 130th Legislature. What Senator Cyrway and Senator Deschambault both talked about, you know, times are tough for Maine people and we had an opportunity to do things like universal school meals. We had an opportunity to work with people like Peter Merrill and the Maine State Housing to try and help people with, you know, their oil, their heating assistance. A lot of these issues, obviously, are worldwide and things that we probably can't control right here in this Chamber. But whatever we were able to do to make things better for the people of the state of Maine I know we did it together and I have great, great honor and respect for all of you. Thank you for everything that you've done to try to make this state better and allow me to be a small part of it. I really will cherish our time here over these last couple of years. I really want to thank you. With that, I'm going to adjourn the 130th Legislature in memory and lasting tribute to Gary Bragg, one of the Capitol Police officers downstairs that passed away recently. So, in his honor, I'll adjourn the State Senate in his memory.
