JOINT RESOLUTION MEMORIALIZING THE UNITED STATES CONGRESS AND THE FEDERAL COMMUNICATIONS COMMISSION TO FOREGO IMPOSING A CAP ON FEDERAL UNIVERSAL SERVICE FUND SUPPORT FOR MAINE'S RURAL WIRELESS CARRIERS

WE, your Memorialists, the Members of the One Hundred and Twenty-Third Legislature of the State of Maine now assembled in the First Regular Session, most respectfully present and petition the United States Congress and the Federal Communications Commission as follows:

WHEREAS, the federal Telecommunications Act of 1996 through the establishment of the Federal Universal Service Fund was intended to promote the availability of quality services at just, reasonable and affordable prices, increased access to advanced telecommunications services throughout the Nation and the availability of quality services to all consumers, including those in low-income, rural, insular and high-cost areas, at rates that are reasonably comparable to those charged in urban areas; and

WHEREAS, the intended goals of that legislation have not been met in the State of Maine, and many of Maine's communities have no wireless services or inadequate wireless service; and

WHEREAS, the failure to achieve the goals of improved and high-quality services has, and will continue to have, a direct and substantial negative impact on the health and safety of the people living and working in Maine's rural areas; and

WHEREAS, the failure to achieve this goal of high-quality wireless services at just, reasonable and affordable rates to everyone is a very significant barrier to the economic development of much of rural Maine; and

WHEREAS, there are 2 rural wireless carriers in Maine that have successfully sought certification as eligible telecommunications carriers and have used the federal universal service funding they have received to construct significant additional wireless infrastructure in rural Maine; and

WHEREAS, the Maine Public Utilities Commission has certified that these Maine rural wireless carriers have used the funds received from the federal universal service fund in a manner consistent with all laws and regulations governing the funds; and

WHEREAS, the Federal-State Joint Board on Universal Service has recommended that the Federal Communications Commission impose a cap on funding for competitive eligible telecommunications carriers; and

WHEREAS, this recommended cap would limit Federal Universal Service Fund support for Maine's rural wireless carriers currently receiving these funds; and

WHEREAS, the proposed cap on funding would serve to undercut the purpose and objective of the federal Telecommunications Act of 1996 by impairing the ability of Maine's wireless eligible telecommunications carriers to expand infrastructure into rural Maine so that rural and urban wireless service is equal, as promised by that act; now, therefore, be it

RESOLVED: That We, your Memorialists, on behalf of the people we represent, take this opportunity to request that the Federal Communications Commission reject the cap proposed by the Federal-State Joint Board on Universal Service; and be it further

RESOLVED: That We, your Memorialists, respectfully urge and request that the United States Congress take action to repeal the cap if it is adopted by the Federal Communications Commission; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Honorable Kevin J. Martin, Chairman of the Federal Communications Commission, to the President of the United States Senate, to the Speaker of the United States House of Representatives and to each Member of the Maine Congressional Delegation.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Plowman.

Senator **PLOWMAN:** Thank you, Madame President, men and women of the Senate. I stand to oppose the pending motion.

This bill was brought before us by a legislator who is from Boothbay Harbor and asked to have liquor stores no longer be able to be within 750 feet of a school. Right now it's a 300 foot limit. Upon examination by the Department of Public Safety it was found that the school was even further away than 750 feet from the liquor store, which by the way just became an agency liquor store, for 20 years it had sold beer and wine. When the issue went away, the next thing that happens is we need a study. What this bill asks for is a study to determine marketing practices of agency liquor stores. It asks the Department of Public Safety to just go in and take a look around. It is not a legislative study. I'm not even sure if we can define exactly what they are supposed to do. I know that the Department has a current position that's empty, the position that would be looking at this. You are also asking the Department to bring together two groups of people to find some common ground. I would describe one group as the business industry and the other group as the people who would rather that prohibition still existed in the State of Maine. I don't think that you can bring those two groups together and find common ground. I think this is an imposition on the Department, where they are going to be put in an impossible position of trying to facilitate two very diverse groups in a discussion that probably isn't even in their venue. It's also a department that is struggling to meet all of the other mandates that we've put on them over the years, especially considering that they are now responsible for all of the agency liquor stores, any kind of gambling outside of the racino, and a number of things that just came out of our committee. I would ask you not to support this. It's sort of a feel good thing that actually creates more work and will have very little tangible results. I'm sure that there are other things that the Department of Safety can do with their time. I ask you to vote against this and adopt the Ought Not to Pass. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Marraché.

Senator **MARRACHÉ:** Thank you, Madame President and men and women of the Senate. I stand to ask your support for the pending motion. This bill basically was changed to resolve and asks the Department of Public Safety to look at whether the placement of alcohol and the marketing associated with it was anywhere near other items on the shelves that might be marketed towards those under 21. They wanted to make sure that if you are bringing children or young people into a particular area of the store that they are not also getting unforeseen marketing for spirits as well. This policy, as you can see if you look up the amendment, satisfies the intent of public policy goals of preventing youth access to alcohol and of adequate licensing and enforcement. The Department also started during our hearing that they were willing to take up this study and they were not opposed to it. Thank you.
