Senator **BELLOWS:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I rise to share my congratulations to Jack West of Winthrop, a member of Troop 622, who was awarded the highest distinction of Eagle Scout. I'm a big fan of Jack's and not just because he delivered my Christmas tree last year. When I first met him what I observed was the thoughtfulness and consideration with which he mentored younger boys in the Troop. He's unfailingly thoughtful and considerate and hard working. Jack completed his Eagle project for the Winthrop Area YMCA. The project was to refurbish the home and away dugouts at Maxwell Field in Winthrop and it included repairing damaged and rotting wood on the structures, painting, adding new roofing, building and installing storage cubbies, bat racks, and trash and recycling receptacles. It was approved by the Boy Scouts of America in August 2018 and completed in December. A total of 56 individuals and 241 man-hours were needed to complete the project over 15 scheduled work days. Jack contributed 55 of those hours on his own. The initial project budget was \$1,400 and Jack had to go to area groups to request donations. He raised \$2,268.04 and with the additional funds available he added on to his original plan. Moreover, Jack was receiving financial donations from the Winthrop Lions Club, the Manchester Lions Club, and the Winthrop American Legion Riders, as well as family and friends, the Home Depot, and B.L. Williams Construction in Winthrop. The upgrades to the dugouts were a big hit with coaches and players as baseball season was just completed. I would like to add that another piece of the Eagle Scout distinction is merit badges and Jack has more merit badges than anyone else in the Troop, over 50 merit badges, which also represents dozens and dozens, perhaps hundreds, of hours of service and learning. Jack makes everyone in Winthrop and Manchester proud. We are so glad to honor him today and to recognize his Eagle Scout award. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from York, Senator Foley.

Senator **FOLEY:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I rise in opposition to L.D. 1509. While this bill is well intended it has an unfunded mandate to our local towns and communities with a population of 4,000 or more. It first requires all towns of 4,000 or more to adopt the Maine Unified Building Code whether they've adopted a code or not. These towns used to be exempted from this law if they had not adopted their own building code. It also requires every new construction to be inspected to meet the new standards with the adoption requirement that the International Building Code also be adopted as well as the ventilation and air quality standards. These used to be guidelines and not required but they are now mandated. I've heard from many of my rural town managers who are very concerned with the cost of implementing this, as most of these towns hire out their code enforcement duties to outside agencies and now will be required, for the number of inspections they have to do, to hire their own code enforcement officer. A developer in my area, who is proposing to build 125 low income housing units, contacted me to let me know that adding this mandate on will cost his project, each house, \$15,000 to \$20,000 more, which will raise the cost of the housing from a low \$200,000 to maybe \$250,000 to \$260,000. Certainly not an affordable situation. One of the things it does do, which I really wish it didn't, is it takes away the home rule. It takes away the opportunity for towns to adopt their own rules and to use the guidelines that the building code already establishes. So while I think the bill was intended to be good, it took away a lot of the exemptions for our rural towns and I wish they had allowed the towns to adopt their own rules or at least use the guidelines. So I urge you to follow my light. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Libby.

Senator **LIBBY:** Thank you, Mr. President. Men and women of the Senate, it's my understanding that the exemption for small towns is at 4,000 residents. My understanding is that exemption's been in place for a little while now and that towns of 4,000 residents or fewer can still opt out of the new BEC code. Mr. President, I would ask the Secretary to read the Committee Report.

At the request of Senator **LIBBY** of Androscoggin, Reports **READ.**

THE PRESIDENT: The Chair recognizes the Senator from York, Senator Foley.

Senator **FOLEY:** Thank you, Mr. President. I apologize for rising again. I just wanted to clarify that I do realize that towns under 4,000 are exempted but the exemption used to read in the law that any town that hadn't adopted a building code as of beginning July 1, 2012 was exempted as well. This has been stricken out of the code. So any towns over 4,000 will now have to comply.

THE PRESIDENT: The pending question before the Senate is Acceptance of the Majority Ought to Pass as Amended Report. Is the Senate ready for the question?

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Dill.

Senator **DILL:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I rise today to recognize retiring University of Maine Chancellor James Page. It's nice that I get up here to speak because speaking from the Senate Floor the Chancellor doesn't get a chance to have any rebuttal, at least until I return to work next week, but that probably depends on what I say here today. So I have to be careful. Many of you know Jim. He's been a fixture of the Old Town community for years and I am proud to call him a friend. Jim was also the first University of Maine System Chancellor to be born in Maine, to have been educated in one of the system's Universities. He was born and raised in Caribou and obtained his BA in History from the University of Maine at Fort Kent, then going on to complete his Masters work in philosophy of physics from St. Andrews University in Scotland, and finally he obtained his Ph.D. in the philosophical foundations of mathematics from MIT. You might want to ask him what that is. When Jim took over the system in 2012 it was struggling to recover from the great recession and enrollment was declining. Drawing on his extensive experience in academia and the private sector, Chancellor Page righted the ship. Today the system is in better shape than ever. Latest reports show a budget surplus and system-wide enrollment has increased steadily and Jim's efforts to streamline and improve communication and collaboration between the system's seven campuses has greatly improved the experience of the students from across the system. I'd like to mention just a couple of things that Jim has done. One, he's made it very easy for transfer of

credits between campuses and the community college system. He's put together what is known as The One University and he's held tuition down. I won't list the many other accomplishments of what he's achieved during his time, otherwise we would probably miss lunch. But I want to thank Jim for his determination and leadership. The University of Maine is poised for success in the future. He will definitely be missed. I hope you join me in thanking Chancellor James Page for his service to the state of Maine. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Guerin.

Senator **GUERIN:** Thank you, Mr. President. Ladies and gentlemen of the Senate, it was such a pleasure working with Chancellor Page. He really showed his Maine roots through his practical approach to governing the University System and I always appreciated his openness to listening to ideas and his way of sharing his opinion that was non-threatening and left everyone feeling open to discussing the issues in a clear manner. He was always very respectful of the students and the freedom of speech that should be available to students and the fair balance approach in the classroom to teaching the subjects at hand and no reaching into the political realm but sticking to what the University's goal is in educating our young people. I will surely miss him and wish him well. It was just a pleasure to work with him.

THE PRESIDENT: The Chair recognizes the Senator from Sagadahoc, Senator Vitelli.

Senator **VITELLI:** Thank you, Mr. President. Men and women of the Senate, I, too, rise to give honor to the departing Chancellor Page. I came to know the Chancellor while I was a member of the University of Maine System community over many years and always appreciated his commitment to the system, to its staff, faculty and, most of all, its students. He has truly been a champion of higher education in Maine and on behalf of the Advisory Council and staff of New Ventures Maine, on which Chancellor Page served as an ex officio member, I want to extend their appreciation for his recognition and support of their work preparing adults for education and the workforce, educating students about their finances, and helping aspiring entrepreneurs to launch small businesses throughout the state. Dr. Page has been an inspiring leader and we wish him well wherever the future takes him. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Millett.

Senator **MILLETT:** Thank you, Mr. President. I, too, offer my congratulations and heartfelt thanks to Chancellor Page for his steadfast leadership for our state's University System during some very challenging times and for his ever-present collegiality, good humor, and willingness to hear from all sides. For my prospective, he is leaving the University System stronger and poised to embark on important new initiatives designed to ensure its long-term health and relevancy and critical role in Maine's future prosperity. He and I arrived here in the Legislature together as Senate Chair and as Chancellor and it seems almost fitting that he is departing as I look forward to departing as well. I need to commend him and his administration for the deep work that they did around higher education affordability, retention, and

completion. There was a lot of national pressure to have the Legislature preempt the internal decision making process of the University System and its Board but through their own initiative and foresight a great deal of work was accomplished around college campus transfers between the Maine Community College System and the University of Maine System and enough cannot be said about putting in place tuition freezes at a time when the national average was around 13%. I hope that in the future the Legislature can partner with the University System to continue to hold our tuitions at our public institution. So I wish Chancellor Page all the best as he embarks on his next adventure and I can't wait to see what it is. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Pouliot.

Senator **POULIOT:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I, too, started my service here in 2012, the same time Chancellor Page started, but hopefully unlike Senator Millett I won't be getting done next time around. I first met Chancellor Page at an Educate Maine event. It was when the Legislature's Education Committee was receiving an award from them and he got up to speak and I really was just kind of taken back by his approach, which is really I think a humble, down to earth approach of leadership that is really built upon trust. I think that any of us in this Legislature could say that probably the thing that we value the most is the ability to trust the people that we're working with. I think that we spend a lot of time trying to build relationships with each other so that when we're making decisions we can make those decisions based upon a trust for the other person that we're working with and Chancellor Page certainly is a person, a leader, that I could always trust the information that he was sharing with us and his forthrightness helped to make decisions easier in this Body. I'll never forget attending a New England Board of Higher Education meeting in Boston. Chancellor Page was there, kind of on the sidelines, and there were a number of individuals operating on very high levels within post-secondary institutions who were commending the University of Maine System and, in particular, Chancellor Page for his leadership and spearheading the work, along with the Board of Trustees, to allow for students to more easily share credits among institutions. For any of you who follow post-secondary education, you'll see clearly that there exists, unfortunately, a lot of turf wars between different institutions at time. You know, this credit is worthy over there but over here it isn't. I think Chancellor Page and the Board, to their credit, did a lot of work to break down some of those barriers to help students get credit for the learning that they did which, ultimately, helps them complete college on time and for less money. So I think those types of strategic changes that were made within the System under the Chancellor's leadership has done a lot to make college more affordable but also to increase completion rates to help us meet some of our goals that we have. Just last year I had a constituent who actually came in to the Legislature and was in the Senate Office. It just so happened that Chancellor Page had a meeting right next door at the same time with our Leadership. I was finishing up with this constituent and Chancellor Page was on his way out and I stopped him to ask if he would mind speaking with my constituent and of course, in typical Jim Page fashion, he said 'Absolutely not, I'd be happy to speak with her.' We sat down for quite some time and after he departed my constituent said to me 'I never thought that I'd be able to speak with the person that is in

charge of the System about this issue that we're having with the University of Maine System.' I think it just really goes to speak to his approachability. In fact, this same constituent actually just left me a voice mail this morning as a follow up. I'm continuing to work on this issue. I have no doubt that the new leadership and also the System will continue to endeavor to meet the needs of those who we serve. So it's a sad day that we're losing the leadership of Jim Page in the University of Maine System. I'm confident that the new Chancellor has big shoes to fill, that he will fill well. But I certainly hope that Jim will continue to come around and see us. We really enjoy having him and, again, it's just been really an honor to work with you, Jim. I wish you the best of luck in retirement and hopefully get some time to enjoy some of this beautiful Maine weather. It looks like you're getting done just in time. Thank you, Mr. President.

Senator **KEIM:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I also want to take a moment to honor retiring Chancellor Page. In his final State of the University System Address I took note of his strong statement advocating that Maine needs a bold, focused, comprehensive, bi-partisan, and long-term economic development plan with education opportunity at its core. Chancellor Page went further to state that this plan must be long-term because success takes more time than a Legislative session or even an Administration's tenure and for that reason alone it must be bi-partisan. I thought when I was reading those words of his that it was meaningful and wise advice and that Dr. Page has led the University of Maine with just that kind of balanced and thoughtful approach, with an eye towards changes that will create long-term success, and he has set the University up to keep going well even as he leaves. I'm honored that I could call Jim a friend and his legacy is one of which he should be proud and I know that we are all agreeing that he will be greatly missed. So congratulations, Chancellor Page, on a job well done.

Senator **HERBIG:** Thank you, Mr. President. Chancellor Page, it has been a pleasure. We have done some really good work over the years. I firmly believe that the students of Maine, our children, our grandchildren, and our future workforce are better off because of your tremendous contributions. It has been a joy to work with you. You have such an incredible sense of humor and way about you that have made the process better off for all of us. So just thank you so much. You will be greatly missed and best of luck in your next chapter.
