It is my pleasure to be standing before you today to commemorate the fine collection of young men and their outstanding accomplishments this last fall, bringing home the Maine High School 8-Man Soccer State Championship. Capping off a perfect 18-0 season, the boys from Carrabec took down a very formidable foe team from Millinocket in a narrow and hotly contested match, with a lone goal being served in by Christopher Caruso being the deciding score. This win made for the second state soccer championship of the school's history, following in the footsteps of the 2004 Class C State Champion squad. Placing a special emphasis on winning the time of possession battle over individual player, this group of boys used a method of attack somewhat unique to those teams that they face, executing it to a tee, and it's showcased in the very timely fashion of the championship faceoff that demanded that exact style of play. Coach Paul Vicneire was quoted after the game as saying "I've coached 26 years, and this is absolutely the hardest working team I've ever had". That's some pretty high praise for somebody in and around the game that long. I'm certainly inclined to take his word for it. Thank you, gentlemen, for being here today, and please accept my immense congratulations, along with my sincere gratitude for the manner in which you have represented my area with your fierce commitment to each other, embodying the spirit of the way you play the game. Thank you very much.

Senator **BRENNER:** Thank you, Mr. President. I just want to say a few words about this bill so that we're all clear on what we're voting on. So, this bill will divert food waste from landfills within the state of Maine. Currently 40% of municipal waste in this state is food waste. So, if passed, starting in 2026, a person would be considered a food waste generator when the average amount of food waste generated weekly by them is two or more tons, and that that food waste generator is located within 20 miles of an organic recycler with available capacity. It ramps up so that in 2028, a food waste generator would be considered a person that generates one or more tons of food waste per week and is located within 25 miles of an organic recycler with available capacity. Simply put, this policy will direct that food waste produced at an industrial or commercial scale may not be disposed of in an incineration facility or solid waste landfill, and it must to the maximum extent practicable reduce the volume of food waste it generates and separate and arrange for the donation of excess edible food and manage the remaining food waste that generates through agricultural use, composting, or anaerobic digestion at the point of generation, at a different location or by transferring the food waste to an organic recycler for management. This amendment also makes changes to the state's food recovery hierarchy and clarifies that the state waste disposal reduction goals are as follows. First, we want to reduce the volume of surplus food waste generated at the source point of generation. We want to donate the surplus of excess edible food to food banks, soup kitchens, shelters, and other entities and

rescue organizations, and similar groups where surplus food can be used to feed hungry people in the state of Maine. Diversion of food scraps and waste for agricultural use, for animal feed, including -- and also for utilization of waste oils for rendering and fuel conversion, creation of nutrient-rich soil amendments through compost of food scraps, the composting or anaerobic digestion of food waste, and finally, the last part of that hierarchy is the land disposal or incineration of food waste scraps. Currently, nine states - Connecticut, Massachusetts, New Jersey, New York, Oregon, Rhode Island, Vermont, and Washington - have passed some form of food waste reduction and recycling laws. These laws have been incredibly successful at reducing food waste, addressing food insecurity, and developing and expanding organic recycling businesses and programs. For instance, Vermont's law, which is nearly identical to this one, has increased food donations and reduced the amount of food that is landfilled. In 2012, Vermont enacted this law, which implemented a phased-in food waste disposal ban much like what we're considering today. The law was phased in over a period of eight years and became applicable to all Vermonters in July of 2020. This law does not go that far. This law does not affect residential food waste producers. In 2015, donations increased by 30% in Vermont - food donations, that is. This rose to 40% in 2016, and the Vermont Food Bank noted that the law helped provide roughly 40,000 meals in 2016. A significant portion of these new donations are fresh produce and other perishables which were otherwise being landfilled. The law also significantly reduced the amount of food being landfilled in the state. A recent report from the University of Vermont found that 71% of all food waste generated in Vermont is being diverted now for disposal -- from disposal. Similarly, in 2021, the Maryland Legislature passed a food waste reduction and recycling law. Currently, the law prohibits anyone who generates at least two tons of food waste per week from disposing the material in a landfill or incinerator. Beginning in '24, the prohibition will apply to those who generate at least one ton of waste per week. It's phased in much like what we're proposing here today. Even though this law is still in its infancy in Maryland, it has helped spur economic investment into Maryland's existing food waste recycling services. And what I want to remind everybody is - and we talk about this a lot in the ENR committee - is that waste in the State of Maine is considered a commodity. Food waste would function much in the same way if this law were to be passed, spurring economic development of businesses that would be involved in composting and recycling of food waste. I urge you all to support LD 1009. Thank you.

Senator **STWEART:** Thank you, Mr. President, Ladies and Gentlemen of the Senate. In Caucus this morning, we worked through what the amended version of this bill which started off as a concept draft and then morphed into it looks like five different -- or a five-part bill. And there were some questions around what it is that this legislation is seeking to do. And so, if maybe the sponsor or the committee -- different members could explain that I think that would be helpful for the benefit of just purely educating the Body here. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Hancock, Senator Grohoski.

Senator **GROHOSKI:** Thank you, Mr. President. Thank you for the question, Senator. I would point out, though I am not a fan of concept drafts, the concept draft actually had four pretty elaborate

parts to it and so this bill actually puts those four points into full language. I just did not have time to draft it before the deadline, as you all know how that is with the Revisor's Office, but it actually just has two major parts. The first has the Public Utilities Commission looking at grid enhancing technologies. These are technologies that are cost effective and actually save us from having to build additional transmission lines or upgrade substations. There are things like dynamic line ratings, that's a way that you can actually allow more load to go across a transmission line based on temperature. So, all the lines are rated the same around the world, but we obviously have a unique climate here compared to other places, and so dynamic line ratings let us move more electricity across the same line, which reduces the need to build transmission lines, which is something that could be quite controversial. So, that's the first part of the bill, allows the Public Utilities Commission to look at these grid enhancing technologies that are being used elsewhere in the country and around the world. They can then ask the utilities, you know, why aren't you using these, suggest that they use them, look at these technologies and rate cases to determine if the utilities are actually making the most prudent decisions on behalf of the ratepayers or if it would be better to employ some of these technologies. That's the first part of the bill. The second part of the bill builds on a very bipartisan law that we passed last year called the Beneficial Electrification Policy Act. That law basically allows Efficiency Maine Trust in conjunction with the Public Utilities Commission as well as the Governor's Energy Office to look at additional opportunities to invest in different efficiency technologies to actually reduce rates. So, the more that we are doing things like putting heat pumps on the grid, the more use we have of the current grid, the less cost it is per kilowatt hour because the infrastructure is the same. That's what that bill did; this bill is adding a section where they can look at beneficial load in terms of commercial and industrial applications. So, this is really important because there are places where our grid is well built but not well utilized, unfortunately, and especially because of different closures we've had in mills. So, it's asking Efficiency Maine to look at whether or not there should be additional incentives, whether we should use economic development tools like the Dirigo Program in order to have more development by high using commercial or industrial operations to locate in these areas. That way, we can better utilize the grid that we have without going to places that are going to require major upgrades. So, it's not my most concise description of the bill, but this bill, in my mind, has a lot of value to ratepayers. It is more intelligently using the grid that we have rather than just investing without a good strategy about location and modern technologies. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Sagadahoc, Senator Vitelli.

Senator **VITELLI:** Thank you, Mr. President. Women and men of the Senate, I rise today in celebration of Women's History Month. This celebration began as a week designated by President Jimmy Carter in 1980, and then in 1987 Congress declared March Women's History Month. During the coming days of March, I've asked each of the women Senators in this body to join me in introducing an individual who has made significant contributions to our state so that collectively we can celebrate our shared history. I'd like to begin by introducing Florence Brooks Whitehouse, an early and forceful leader of the struggle to win the vote for women in Maine. Born into a prosperous Augusta family in 1869, Florence spent summers on Squirrel Island, a community off Boothbay, not far from where I live today. After studying for a time in Boston, she took an extended trip to Europe, parts of Africa and the Holy Lands, spending an entire winter in Egypt before returning in 1894 to marry Robert Treat Whitehouse, whom she had likely met on Squirrel Island. The couple moved to Portland, a bustling city of 40,000 where over the next couple of years they collaborated on writing, directing, and acting in plays. Robert pursued his legal career, becoming the US Attorney for Maine in 1905. Florence became the mother of three sons, and with the encouragement of her husband continued to write, publishing several novels based on her travels in Egypt. There were active in other civic and cultural groups as well. It was likely at one of these 'current topics' lectures given by a Mrs. Morrill that Florence may have taken up the call to action on women's suffrage as she listened in disagreement to arguments as to why women didn't want the vote, wouldn't use it if they had it, were really too busy running their households and besides were too frail for the rough and tumble of politics anyway. Her own views were decidedly more egalitarian and on the side of women's suffrage. In addition to being a writer, she was a forceful and cogent speaker; after one debate local press claimed that she closed the debate by quote "reading the cleverest and best prepared suffrage speech that has been given in this city for many years." In ensuing years, she would go on to write newsletters and pamphlets and spoke widely on behalf of suffrage in Maine and around the country. From 1911 through until the signing of the 19<sup>th</sup> Amendment in Maine, Florence played an active, visible role in promoting women's suffrage, joining the Board of the Maine Women's Suffrage Association, the affiliate of the national organization. The push to get the vote for women, through both state legislatures and nationally, took years. Organizing local chapters, spreading the word and engaging others to pressure the Maine legislature year after year was arduous, made especially challenging in our rural small town state. Yet they – and Florence – persisted. In March, 2015 – sorry, this should say 1915. Got ahead of myself. After the

Senate overwhelmingly voted to send the suffrage referendum to the voters, Florence and her allies filled the House gallery to watch that vote. It failed by 10 votes – this was the 12<sup>th</sup> time suffrage was defeated in the Maine Legislature. It would take another 5 years of struggle both in Maine and at the national level before the vote was won. There were major schisms that occurred within the suffrage movement; WWI came and drew attention and resources away. Florence joined the Red Cross, but she never gave up. When Maine finally ratified what was called the Susan B Anthony amendment, granting women the right to vote, Florence Brooks Whitehouse stood behind then Governor Milliken as he signed the document. We all owe a debt of gratitude to Florence, her leadership and tenacity, in helping secure the vote for us. I leave you with the words of Florence as she testified in front of the Maine Judiciary committee. Quote, "I have no quarrel with you, but henceforth, this you must know: the world is mine, and yours. The pulsing strength and passion and heart of it. The work I set my hand to, women's work. Because I set my hand to it." For more on Florence's life and work in the suffrage movement in Maine, I recommend reading the book *Voting Down the Rose*, by our very own Anne Gass. Thank you, Mr. President.
