Dear President Jackson and Speaker Talbot Ross:

Please accept this letter as the report of the findings of the Joint Standing Committee on Innovation, Development, Economic Advancement and Business from its review and evaluation of the Department of Professional and Financial Regulation under the State Government Evaluation Act, Title 3, Maine Revised Statutes, chapter 35.

Pursuant to the requirements of the Act, the committee notified the Department of Professional and Financial Regulation by letter of its intent to review the department on April 28, 2023. The Department of Professional and Financial Regulation submitted its program evaluation report by November 1, 2023 and presented the report to the committee on January 30, 2024. The committee held a work session on February 27, 2024.

The committee has reviewed the report and finds the Department of Professional and Financial Regulation is operating within its statutory authority. Additionally, after assessing the Department's recommendations to address emerging issues pertaining to the Commissioner's authority in times of public health emergencies and the need for a formally established Deputy Commissioner position, the committee has voted to report out legislation this session pursuant to 3 MRSA §955(4) to consider implementation of those recommendations.

Senator **KEIM:** Thank you, Mr. President. Although February 3rd has passed, I appreciate this Body's indulgence in allowing me to bring attention to this emerging clinical problem - topical steroid withdrawal. TSW, also known as topical steroid addiction or red skin syndrome, is a debilitating condition that can arise, as you heard, from the use of topical steroids to treat skin disease, but it can also arise from the steroid use in individuals with no prior skin condition. I had never heard of TSW until a constituent, who is actually here with us today, brought this to me and now I understand this condition is preventable and definitely not well understood. Many patients report dismissal by dermatology healthcare professionals, driving them to seek help from unregulated online sources. In describing TSW, Dr. Olivia Friedman of Chicago said its symptoms can completely upend lives, often forcing patients to become bedridden, thus impacting entire families financially and psychologically. Because TSW usage is pervasive worldwide and is not well understood or treated, rigorous research and broader public and practitioner awareness is needed to stop this preventable condition. I thank you for allowing me to highlight this with our Body today. Thank you for your indulgence in having it on the calendar for a while as we waited for my constituent to be here with us. Thank you.

Senator **HARRINGTON:** Thank you, Mr. President. Please join me in voting down this motion. I initially co-sponsored this legislation; I was interested in learning more about it. The more we learned, there are plenty of pilot projects throughout the country, we know everything we need to know about this project, and we certainly don't need to study something we can already access data on and certainly shouldn't do it on the backs of Maine ratepayers. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Hancock, Senator Grohoski.

Senator **GROHOSKI:** Thank you very much, Mr. President. I originally had a lot of concerns with this legislation. It is not one that I would've been willing to co-sponsor in its original form. However, I think it has progressed into a really smart initiative for the State of Maine. There is a lot of federal money available and, in fact, if you maximize all the federal tax credits, it is actually you can develop hydrogen at a negative cost, which would definitely be in the interest of ratepayers. One of the reasons that I have become a supporter of this legislation and think it's very important for Maine positioning ourselves in a global economy is that hydrogen is recognized as one of the only ways to decarbonize the maritime sector, and that's clearly a very important part of the State of Maine's history, it's very important in my district and, in fact, the Maine Maritime Academy is working very hard to make global partnerships so that our students can be part of that future workforce, which I think will include hydrogen. So, I think doing a very limited project, up to 20 megawatts, is prudent for the State to start to understand how we can be leaders in this sector because it is where the world is headed. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Brakey.

Senator **BRAKEY:** Thank you, Mr. President. I rise in support of the underlying legislation and opposed to the pending Ought Not to Pass Report in front of us, though with much respect to Senator Grohoski, who does great work on the Taxation Committee. But as the sponsor of this legislation, LD 1873, An Act to Provide Heating Relief with Tax-free Home Energy Savings Accounts, I have this to say. It's no surprise that winter comes to Maine every single year. As a northern state, we deal with that as we're shoveling out our driveways every year and trying to heat our homes. But rather than reacting from crisis to crisis with only short-term relief, as was done at the outset of the 131st Legislature with the passage of LD 3, I believe we should consider how we help Maine families prepare for future winters, by empowering them to utilize their own money, tax free, for their home energy needs. And that is exactly what this legislation aims to achieve. Originally, I proposed this bill to establish home energy savings accounts that would function similar to federal health savings accounts, but supportive members of the committee saw fit to instead recommend a direct income tax deduction for home energy needs. I'm happy for their collaboration and completely support this method for delivering tax relief for the home energy needs of Maine people. Should we reject the pending motion, however, and accept Committee Amendment "A" I do believe this legislation should include eligibility as is included in the underlying bill, not only for electricity expenses but also nonelectric heating and home weatherization. If we were to get to that point, I would be happy to offer a floor amendment. Individuals could claim a deduction on their taxes for up to \$2500 in annual energy expenses. To spare you from doing the math, the maximum annual tax savings would range from \$145 to \$178.75 for an individual, depending on the tax bracket they find themselves in. Now, recognizing the ever-increasing electricity and fuel rates, and the fact that Maine's harsh winters require frequent home weatherization measures, this is a commonsense solution that will empower Maine people to plan and save and utilize their own funds for the long term. Our first resort in helping Maine people should not be taking their money and sending it back to them, but empowering them to use their own resources to address their own family's needs. Thank you for your time and consideration. I hope you will join me in voting no on the pending motion so we can move on to the Ought to Pass as Amended by Committee Amendment "A" report. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from



Hancock, Senator Grohoski.

Senator **GROHOSKI**: Thank you, Mr. President, and Colleagues in the Senate. I want to thank the Senator from Androscoggin for sharing a description of what this bill does. It does provide an income tax deduction up to \$2500 for electricity used. And I really appreciate what the Senator is trying to do here because I know that our constituents are working through hard times with their energy budgets. However, I don't think that the solution is properly tailored, and it comes at a great expense to the State. It requires three new positions, auditor positions in Maine Revenue Services and, as the Senator pointed out, the maximum annual benefit is \$178. It affects around 400,000 income tax filers, so not even a majority of the people that we represent would benefit from this. And additionally, it will cost us \$50 million a year to provide what is a benefit but not a very large benefit for households. It is not really the purview of the Taxation Committee, it is more the purview of the Appropriations Committee or the Energy Committee, to recommend how we might help folks through general fund appropriations with energy costs, but I would just remind members, and especially if your constituents are asking, that we do have some great programs. We have the heat program, the LIAP program, Efficiency Maine Trust also has weatherization programs because we all know that the cheapest energy used is the energy that we don't use at all. So, I would really rather spend \$50 million every year weatherizing folks' homes so that they're not spending this money whatsoever. There's also Maine State Housing has a low-income weatherization program. And to the point about empowering people to save for those difficult times, we also have some fantastic programs through the Cash Maine system, including the Rainy-Day Savings program and the Family Development Accounts program. So, there are a lot of opportunities. I would recommend that instead of adding a new feature to our income tax filing that deviates from the federal tax system that we actually invest in these programs that are working and are targeted to Maine people that most need the help. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Sagadahoc, Senator Vitelli.

Senator **VITELLI**: Thank you, Mr. President, Men and Women of the Senate. I'd just like to take a moment to amplify a little bit what the Senator from Hancock spoke about. There are clearly needs for people to be able to pay unexpected energy expenses, whether that's electricity or home heating oil. We've heard that there are some programs already in existence to help do that, and I just want to let you know a little bit more about one of them, the Rainy-Day Savings Account program, which I'll be honest, I helped start. It's a matched savings program that is designed as its title is, rainy day, to enable people to save their money for unexpected expenses that could include if their furnace fails or if they suddenly get a larger electric bill, they can use their savings for this. Eligibility for the rainy-day savings program is based on annual household income, so it's very targeted. Your income must be at or below \$30,120 for one person or \$40,880 for two people. It's based on the 200% of poverty guidelines. Accountholders typically save between \$20 and \$100 a month, for a maximum savings of \$400, which is then matched one to one. These are tax-free savings accounts, they're matched one to one, so they can withdraw that money after a certain period of time to use for these unanticipated expenses. In addition to this sort of

small savings account, there is the family development account, which is a program that was actually created in part by this Legislature that enables people to save for more tangible assets like first-time homebuyer, paying for an education, or starting a small business. These accounts are matched four to one and can include savings up to \$1,000. To participate in that, the savers also need to participate in a financial education class, and if they're using their savings to purchase a home, they have to participate in a home buyers education class. So, these are specifically targeted to people who have low incomes, who want to start saving their own money for unexpected expenses or for assets that can help build their assets going forward. These programs have been around for at least ten years, if not longer. They've been proven to work. They're administered currently by the New Ventures Maine organization, and they bring together both private and public funds to help fund the match and they are indeed intended to help people to empower people to save their own money and to plan for their futures in a more secure and financially stable way. So, I suggest we let people know about these programs and ask that you join me in voting down this basically unnecessary and expensive effort.

Ladies and gentlemen of the Senate, this is Women's History Month, so today is my turn and I'm doing something a little different that I hope you all find interesting. I think much of the history of women is lost in the day to day care of family and children and their home and getting food on the table. So, I am celebrating our great-great-grandmothers, our grandmothers, my mother who is 99 and still lives on her own, and sharing some of the history that was - is important to my mother. When she got the Boston Cane last year for the town of Kenduskeg they had a party for her and asked her to do a speech, which at 98 I think it's pretty impressive that you're still doing speeches. Maybe I'll be still on the Senate Floor. In part of my mother's speech includes some piece about me and I was going to take that out but she, and I talked to her about it last night, and she said that that was such an important part of her life. She wanted me to keep it in. So, I'm going to read my mother's history speech to give a little view of a regular Maine woman who grew up in rural America and is like us. We're a citizen's legislature. She's just a regular citizen who did her best as a woman and a Mom. Her name is Kathleen Smith. 'I was born in Bradford, Maine on August 1, 1924. The third of three daughters, followed by two sisters and a brother. We were Helen, Hilda, Kathleen, Evelyn, Gertrude who lived only three weeks, and Elwin. Our parents were Franz and Lizzie Ross Hurd. We lived in a nice two story house on a large dairy farm on the Pond Road. We attended school in Bradford Corner and rode to school in a horse drawn wagon and in the winter in a horse drawn sleigh. We had friends on the road, Fern Strout and the Rozelles; Barbara, Virginia, and Lloyd. We hung May baskets on the first day of May. We helped with the haying, raking with a one horse rake and riding the horse to pitch the hay into the elevated lofts in the barn. When I was 14 years old, we moved to a farm which my folks owned on Outer Broadway in Bangor. There I attended 8<sup>th</sup> grade at the Sherburne School on Pushaw Road and then on to Bangor High for four years. I graduated with second honors. My parents transported us to high school, there was no bus.' I'm just going to insert a little part here. They were very poor at this time because of the coming to the time of the Depression and my grandmother made their dresses out of the grain sacks that had the printing on them, which we've all heard about. But it was pretty hard for the girls to go to school at Bangor High were there was a lot of city kids who had real clothes, you know. 'I was attending Maine School of Commerce, also known as Husson College, when World War II started. I quit school and went into defense work. There was a training site in Bangor and then I was transferred to Houlton Air Force Base where I worked in Aircraft Repair, resetting spark plugs for planes returning from the battles in World War II for repair and maintenance. After about a year in Houlton, we were transferred to Presque Isle Airbase. My sister, Helen, was married. Her husband was serving overseas in the Army. They had a baby boy, Orville Tuttle Bradford III. We called him Tuttie. Hilda and I were working in Houlton. Evelyn and

We dated for about a year and then we were married in September. After 11 years of marriage, we were blessed with a daughter and named her Stacey Kay Smith. She is now Senator Stacey Guerin, the biggest and best blessing of my life, along with her husband, Joseph, and their five sons; Gabriel, Peter, Andrew, Caleb, and Jesse, and their families. When Stacey was 11 years old, I went back to work at Better Homes on Harlow Street. I left there for a job as office manager and bookkeeper at Lane Plumbing and Heating for my friend, Maynard Lane. When he decided to close the business and become a full-time evangelists, I worked at Hartt Transportation and then retired. During retirement I took a part-time job at Sam's Club and am now working,' and she still is, 'part-time at my family's business, R.M. Flagg in Veazie. Living in Kenduskeag, I was involved in many things. At Kenduskeag Union Church I was the Sunday School superintendent.' I'll add, she had the highest percentage in attendance for children attending Sunday school in any town in the state of Maine. 'I always made candied apples for Halloween.' She had over 100 children who would come to get candied apples every year. 'I served 17 years on the School Board and was a member of the Grange. Many thanks to my Lord, Jesus Christ; to my family; and to all of you here today for a lifetime of blessings.' That's my Mom.
