Dear President Jackson and Speaker Talbot Ross:

Please accept this letter as the report of the Joint Standing Committee on Veterans and Legal Affairs from its review and evaluation of the Department of Administrative and Financial Services, Office of Cannabis Policy under the State Government Evaluation Act, Title 3 Maine Revised Statutes, chapter 35. The committee unanimously finds that the Office of Cannabis Policy is operating within its statutory authority.

The committee encourages the Office of Cannabis Policy to continue working to promote the health and well-being of the people of the State and advance policies that protect public health and safety, emphasizing the health and well-being of minors, as priority considerations in performing all duties; ensure that the administration and enforcement of the laws, rules and regulations of the Cannabis Legalization Act and the Maine Medical Use of Cannabis Act are consistent, predictable and equitable; ensure that qualifying patients maintain access to high-quality, effective and affordable cannabis for medical use; and develop good-faith

partnerships between the Office of Cannabis Policy and the stakeholders who participate in and benefit from this emerging manufacturing industry, as set forth in pending legislation to be reported out of committee.

Given the newness of the agency, the industry and the changing landscape of federal cannabis policy, the committee may schedule a follow-up review with the Office of Cannabis Policy in the 133rd Legislature to evaluate the progress of the agency in meeting the recommendations of this committee report. The committee will provide the agency with written notification of its intent to conduct a follow-up review by May 1, 2027. The follow-up review may consist of written progress reports, public hearings with the agency and the committee, or briefings with stakeholders and the committee.

Senator **STEWART:** Thank you, Mr. President, Ladies and Gentlemen of the Senate. This is a bill that thankfully received unanimous passage out of the Judiciary Committee earlier this year, and we certainly appreciate the work that they did on this bill. Unfortunately, when it got down to the Governor's desk, it was then noticed that there was an issue that was flagged by the Maine Prosecutors' Association which accidentally -- what we've

accidentally done is have two conflicting paragraphs. And so, Shira Burns, who is the executive director there, just writes; as written, subsection three and four conflict with each other. Subsection three talks about the court having exclusive jurisdiction and subsection four talks about the juvenile court having exclusive jurisdiction, and since these subsections are added into Title 17-A, Section 10, which is referencing adult court jurisdiction, they then would conflict with one another. So, the two sections should've been combined to reference the juvenile court having exclusive jurisdiction when a juvenile crime is committed within the boundaries of a military installation, and so, effectively, that is what this floor amendment does here that would hopefully address that concern and then end up in the same posture shortly back on the Governor's desk and awaiting signature. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Carney.

Senator **CARNEY:** Thank you, President Jackson. Members of the Senate, I rise today to celebrate another famous Maine woman in conjunction with Women's History Month. Last week our colleague from Cumberland, Senator Brenner, began her remarks quoting a historian who said 'Well-behaved women seldom make history.' That statement was true of Martha Ballard and it's also true of the Honorable Lois Galgay Reckitt. Lois Reckitt served in the 128<sup>th</sup> through the 131<sup>st</sup> Legislature, until she passed away in October last year of colon cancer. She was a tenacious fighter for justice in Maine, the U.S., and the world right up until her passing. She was also a loving wife to Lyn, a wonderful grandmother, and a devoted aunt. Lois worked on a broad range of issues to promote women's rights and the rights of other disadvantaged people throughout her lifetime, including helping to found the Maine Women's Lobby in 1978. Lois Reckitt was a board member of the National Organization for Women for 15 years and served in the leadership role as the elected National Executive Vice President from 1984 to 1987. In the 1980s, she was a co-founder of the Human Rights Campaign Fund and Lois was inducted into the Maine Women's Hall of Fame in 1998. For 36 years, Lois was executive director of the Family Crisis Services in Cumberland County. She was at the forefront of

efforts to stop domestic violence and help survivors, lobbying for stronger laws and more enforcement in Maine before she even considered running for the Legislature. She also worked to help police, prosecutors, and judges better understand domestic violence and the harm it caused. Her long-time friend, retired judge Michael Cantara, said 'Her approach rested on the belief that people want to do what is right and just, and that most people will respond better to a victim's needs if that person has knowledge of the dynamics of domestic violence.' For decades, Lois fought to pass the Equal Rights Amendment in Maine. Even when those efforts fell short, she fought on. She was rightfully proud of her many Legislative accomplishments, including protecting those who are sex trafficked from prosecution while holding the sex traffickers responsible, legislation that actually went into effect just a few days before she passed away. If you ever spent time with Lois, you would note that this biography so far is much too tame to capture her essence, what made her special during her life and what will keep her memory alive, so I'm going to recite a few of these other aspects of Lois. She had a very eclectic career path, including working as a marine biologist and also as a swim instructor. She was arrested twice for civil disobedience in the 1980s. One time she protested apartheid at the South African embassy in Washington, D.C., and the other time she was arrested in front of the White House for protesting the Reagan administration's inadequate response to the AIDS epidemic. She tells a story about having 'the odd distinction of being the first woman in the U.S. arrested by police using those Playtex rubber gloves' which they used, and again this is quoting Lois, 'reached down my pants to see if I was carrying who knows what.' Lois was a die-hard Boston Red Sox fan, holding season tickets for decades. She was also invited to speak at a national conference on ending sexual exploitation in October, just a few weeks before she passed away. Lois gave her presentation from the Maine Medical Center Emergency room as her health condition worsened. In appreciation, the National Center on Sexual Exploitation gave her one final award, the Dignity Defense Award, which I think is so appropriate. Lois was definitely an arm twister, as those in this Chamber likely experienced when she, I know that Senator Moore knows what I'm going to say, when she whipped votes for the Equal Rights Amendment or when she persuaded nearly every lawmaker in this building to join the Irish American State Legislators Caucus, that was several years ago. Lois also used her sharp sense of humor to make a point. Her t-shirt collection in the Maine State Achieves includes a shirt that reads '1984 George Orwell for President.' I was waiting for some laughs. She's also famous for launching the Judiciary Committee's work on data privacy by informing us that she's the only person on the face of the Earth who routinely read social media terms of use and privacy disclosures in their entirety. I'll close my remarks on this famous Maine woman by noting Lois' willingness to show her vulnerability in order to raise awareness and compassion. During the course of her work in this building, Lois shared her experiences as a child survivor of incest, as a woman and lesbian being subjected to discrimination, and as a person with Multiple Sclerosis and colon cancer, all in the course of advocating for important legislation. Lois once stated that the three loves of her life were the women's right movement, the lesbian rights movement, and the movement to end violence against women. 'I have lived an interesting life,' she said, and I think that is true. Thank you.
