again a disturbed man with easy access to guns has squinted  
through the sight of a weapon, aimed, squeezed a trigger, and  
taken out his depraved anger, pain, and frustration on innocents,  
pure souls. Students and teachers, brothers and sisters, mothers  
and fathers, cut down in an instant by the power of hatred and  
technology. We are guilty, O God. We are guilty of inaction. We  
are guilty of complacency. We are guilty of allowing ourselves to  
be paralyzed by politics. The blood of our children cries out from  
the ground. The blood of police officers cut down in the line of  
duty flows through our streets. I do no appeal to You, O God, on  
this terrible morning to change us. We can only do that  
ourselves. Our enemies do not come only from far away places.  
The monsters we fear live among us. May those in this room,  
who have the power to make a change, find the courage to seek  
a pathway to sanity and to hope. May we hold ourselves and our  
leaders accountable, and only then will our prayers be worthy of  
an answer. Amen.

WHEREAS, the National Multiple Sclerosis Society has been committed for more than 70 years to a world free of multiple sclerosis, and the society raises public knowledge about and insight into the disease; and

WHEREAS, since 1946 the National Multiple Sclerosis Society has been a driving force in multiple sclerosis research, pursuing prevention, treatments and a cure, and has invested more than \$900,000,000 in groundbreaking research; and

WHEREAS, funds raised through the National Multiple Sclerosis Society include \$42,100,000 in funding for 380 research projects at medical centers, universities and other institutions throughout the United States and abroad, leading to many breakthroughs in the treatment of multiple sclerosis; and

WHEREAS, stopping the progress of multiple sclerosis, restoring what has been lost and ending multiple sclerosis forever is the mission of the National Multiple Sclerosis Society and one that all should support; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-eighth Legislature now assembled in the Second Regular Session, on behalf of the people we represent, take this opportunity to recognize February 22, 2018 as Multiple Sclerosis Awareness Day, to recognize the importance of finding the cause and cure of multiple sclerosis and to express our appreciation for the dedication that the National Multiple Sclerosis Society - Greater New England Chapter has shown towards creating a world free of multiple sclerosis; and be it further

**THE PRESIDENT:** The Chair recognizes the Senator from Aroostook, Senator Carpenter.

Senator **CARPENTER:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I rise to oppose my friend from Androscoggin County, Senator Mason. I will briefly explain why. This bill is a matter of simple fairness, nothing else. I don't believe any of us were here when the original cascade was enacted into law for the Oxford Casino. Now I want to emphasize, this is only to do with the Oxford Casino, and the Oxford Casino does not oppose this bill. The Oxford cascade says 4% of the proceeds go to two Indian tribes, Native American tribes, Penobscot Nation and Passamaquoddy Tribes, 2% to each. This bill simply does one thing. It redistributes that 4%. It doesn't add to the 4%. It simple says all four federally recognized tribes in Maine, and there are four of them, all four of them will get 1%. So the net effect of this will be to take money away from the Penobscot Nation and the Passamaquoddy Tribe. I don't deny

that. But it will give that money that you are taking away to my two tribes, which are every bit as deserving of this money as the other two tribes. I wish it were not so. I wish we had more money that we could give from this cascade. We opted not to open up the cascade, and I think that is the fear of some of the opponents of this bill, that is if you pass this piece of legislation that you will be opening up the cascade. It does not. I will say it again, it does not affect the Hollywood Slots Casino in Bangor because their cascade does not include the same, or any percentage, with the native tribes. This simple takes the existing 4% and redistributes that money to all four tribes. It is a matter of simple fairness. Mr. President, I request the roll be taken, it will be taken with the yeas and the nays.

On motion by Senator **CARPENTER** of Aroostook, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Mason.

Senator **MASON:** Thank you, Mr. President. Mr. President, ladies and gentlemen of the Senate, I would like to thank my colleague from Aroostook for stating his points on the bill and why he is opposed, and while he is right on the description of the bill and what that would do and the fact that Oxford Casino does not oppose it, there are two reasons that I stand with my original vote in committee. First of all, when you start to open up the cascade for either casino I think you start to run into a lot of dangers. I think people might start to run to the casino cascade to fund different projects, whatever they may be. The second is that the tribes could not come to an agreement and fluctuated on their responses towards what this bill was all about. So with no agreement among the tribes, I don't know that we should move forward something like this at this time. So I urge the Body to join me on the Ought Not to Pass motion. Thank you.

Off Record Remarks

Senator **CARSON** of Cumberland was granted unanimous consent to address the Senate on the Record.

Senator **CARSON**: Thank you, Mr. President. Ladies and gentlemen of the Senate, I rise today to speak in memory of the students and faculty who lost their lives in Parkland, Florida on February 14<sup>th</sup>, and in honor of those students from the Marjory Stoneman Douglas High School who are carrying the torch for their fallen students and friends for the cause of safer schools and a safer society. Today it was an honor and a privilege for me to lead the pledge here in this Body, standing with you all. I also want you to know that I feel very lucky to be here today because 49 years ago today I was wounded, shot, on a hilltop on the border between Vietnam and Laos while serving in the Marines. I want to come back briefly at the end, and I will do my best to be brief, to speak about the Parkland shooting, but I just want to tell you a little bit about that day. I had trained, as some of you know, in the Marines, having dropped out of college and enlisted. I went to Parris Island. I went Camp Lejeune, and I was trained in Quantico. So it was a full year in training with the Marine Corp before I landed in Vietnam to take command of a platoon of Marine soldiers in Northwest Vietnam where we were fighting directly with the North Vietnamese soldiers. There was a time,

ladies and gentlemen, when I could assemble, disassemble, and then assemble an M-14, an M-16, an M-79 Grenade Launcher, all in utter darkness because that was something we might have to do. All of that training never prepared me for the noise, the chaos, the utter mayhem of combat when I got to Vietnam in October of 1968.

I want to read you briefly from an essay penned by a radiologist, Dr. Heather Sher, from *The Atlantic Monthly* of February 22<sup>nd</sup>. 'What I saw treating the victims from Parkland should change the debate on guns. As I opened the CT scan last week to read the next case, I was baffled. The history simply read 'gunshot wound.' I have been a radiologist in one of the busiest trauma centers in the United States for 13 years, and have diagnosed thousands of handgun injuries to the brain, lung, liver, spleen, bowel, and other vital organs. In a typical handgun injury, which I diagnose almost daily, a bullet leaves a laceration through an organ such as the liver. To a radiologist it appears as a linear, thin, gray bullet track through the organ. There may be bleeding, and some bullet fragments. I was looking at a CT scan of one of the mass-shooting victims from Marjory Stoneman Douglas High School, who had been brought to the trauma center during my call shift. The organ looked like an overripe melon smashed by a sledgehammer, and was bleeding extensively. How could a gunshot wound have caused this much damage? The reaction in the emergency room was the same. One of the trauma surgeons opened a young victim in the operating room, and found only shreds of an organ that had been hit by a bullet from an AR-15, a semiautomatic rifle that delivers a devastatingly lethal, high velocity bullet to the victim. Nothing was left to repair, and utterly, devastatingly, nothing could be done to fix the problem. The injury was fatal.'

I was hit by a bullet from a similar rifle, or weapon. I never saw the man who shot me. I presume it was an AK-47 in the hands of the North Vietnamese soldier. It was a sickening thud, and then there was blood everywhere, and I didn't realize at first that I was the one who had been hit. A corpsman, Navy Corpsman, to whom I owe my life, materialized out of nowhere, very, very quickly, applied a battle dressing, applied a tourniquet, stopped the bleeding, and I stayed awake. I stayed conscious. He wanted to give me morphine because he was anticipating I would go into shock and perhaps lose consciousness, and I said, 'You can't do that. I have got to get our guys out of here.' It's a longer story, but I was the only seasoned, at that point, combat veteran who could get the squad that had been ambushed back into our perimeter, to some measure of safety. So I called in artillery, something I had been trained to do but I had never actually done before, to walk the artillery right up to where we were, and then have it leap over us. We escaped with some casualties for sure. I got back to the perimeter. That corpsman stayed up with me all night, and he said, 'Lieutenant, you are going back to the world,' and I will confess to you that I was ready. I was ready to go home. I got great care in the hospital ship sanctuary, ten days, another two weeks at the Guam Naval Hospital, and another four months at Bethesda Naval Hospital. Fought little over 5 months for a single gunshot wound from an assault-style weapon, and I am really lucky to be standing here with you all today. I tell you this story because I think it is important that when we deal with the issue of gun violence and school shootings, we try not to do it from a political 'what's right according to this group, what's not right according to that group', but based on some acknowledgement and recognition of that fact that these are guns, these are weapons, that are designed for

military purposes. They are designed not for hunting, but for killing and, in fact, for killing human beings and down the road, I doubt very much it will happen this year, but down the road we need to say, or whoever is standing in this Chamber needs to say, these kinds of weapons have no place in our civilized society. Thank you, Mr. President.
