The following Joint Resolution:

H.P. 1392

JOINT RESOLUTION MEMORIALIZING THE PRESIDENT OF THE UNITED STATES AND THE CONGRESS OF THE UNITED STATES TO IMPROVE THE PROCESS USED TO NEGOTIATE AND APPROVE INTERNATIONAL TRADE AGREEMENTS

WE, your Memorialists, the Members of the One Hundred and Twenty-fifth Legislature of the State of Maine now assembled in the Second Regular Session, most respectfully present and petition the President of the United States and the Congress of the United States as follows:

WHEREAS, the State of Maine strongly supports international trade when fair rules of trade are in place and seeks to be an active participant in the global economy in order to encourage meaningful transparency, appropriately acknowledge the vital role of state sovereignty and afford more meaningful congressional review and acceptance; and

WHEREAS, the State of Maine seeks to maximize the benefits and minimize any negative effects of international trade; and

WHEREAS, existing trade agreements have effects that extend significantly beyond the bounds of traditional trade matters, such as tariffs and quotas, and can undermine Maine's regulatory authority and constitutionally guaranteed authority to protect the public health, safety and welfare; and

WHEREAS, a succession of federal trade negotiators from both political parties over the years has failed to operate in a transparent manner and failed to meaningfully consult with states on the far-reaching impact of trade agreements on state and local laws, even when binding the State of Maine to the terms of these agreements; and

WHEREAS, existing trade agreements have not done enough to ensure a level playing field for Maine workers and businesses or to include meaningful human rights, labor and environmental standards, which hurts Maine businesses, workers and communities; and

WHEREAS, the negative effect of existing trade agreements on Maine's regulatory authority and constitutionally guaranteed authority to protect the public health, safety and welfare has occurred in part because United States trade policy has been formulated and implemented in a process that lacks transparency, fails to properly recognize the principles of state sovereignty and lacks any meaningful opportunity for congressional review and acceptance; and

WHEREAS, the United States Trade Representative is currently negotiating the terms of a proposed Trans-Pacific Partnership Agreement, which will have a significant effect upon the citizens and commerce of the State of Maine; and

WHEREAS, there is a current opportunity for improving the process by which significant foreign trade policy agreements such as the Trans-Pacific Partnership Agreement are negotiated; now, therefore, be it

RESOLVED: That We, your Memorialists, respectfully urge and request the President of the United States and the Congress of the United States to improve the process by which United States trade agreements are developed and implemented in order to encourage meaningful transparency and appropriately acknowledge the vital role of state sovereignty and afford more meaningful opportunity for congressional review and acceptance; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Honorable Barack H. Obama, President of the United States, to the President of the Senate of the United States, to the Speaker of the House of Representatives of the United States, to Ambassador Ron Kirk, United States Trade Representative and to each Member of the Maine Congressional Delegation.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Washington, Senator Raye.

Senator **RAYE:** Thank you Mr. President. I rise briefly to commend the sponsors for this Joint Resolution. For four years I had the pleasure to serve as a Senate Republican on the Citizen Trade Policy Commission. Throughout that time we, as a commission, struggled with the federal process for negotiating

improving international trade agreements. They literally are done under a shroud of secrecy, which is very troubling and has had some very negative consequences for Maine businesses and Maine workers in years past. Sadly, administrations of both political parties over the years have failed to aggressively protect our business and worker interests in the negotiation of federal trade agreements. As a state that is very susceptible, given the fact that we are literally surrounded on three sides by Canada, we've very familiar in Maine with the impact of international trade agreements. I believe that this call, putting the Maine Legislature on record in support of transparency and respect for state sovereignty is extraordinarily important. I just wanted to rise, as a former member of the Citizen Trade Policy Commission, to congratulate the current members for bringing this forward. I think it is critically important.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Oxford, Senator Patrick.

Senator **PATRICK:** Thank you Mr. President. Ladies and gentlemen of the Senate, colleagues and friends, I, too, rise in support of this Joint Resolution. Having had the ability to actually co-sponsor the bill that brought the Citizen Trade Policy into fruition and to vote for it and to be the founding House Chair of the Citizen Trade Policy Commission, this Resolution bring forth the knowledge and understanding that we aren't where we want to be yet as far as international trade goes. We have become a nationally recognized organization. As a matter of fact, just the other day Japan got a hold of our Senate Chair and House Chair and came to visit Maine to find out what the Citizen Trade Policy Commission is all about. In many instances, other states across the nation have emulated our Citizen Trade Policy Commission so that their states would have the ability the same as Maine does and that we might have a voice for Maine businesses to protect them against unfair labor agreements in that. Like it says, Maine is in favor of international trade. We just want to make sure that there is fair labor and environmental standards and that we are on a fair and level playing field. I'm really pleased and proud that Maine is one of the leaders as far as a state goes on international trade. Thank you.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Cumberland, Senator Brannigan.

Senator **BRANNIGAN:** Thank you Mr. President. Men and women of the Senate, this is about cell phones and other types of insurance that you can buy when you buy your tablet or your cell phone. Those of you who have your computer right there handy, you might want to Google cell phone insurance. That might help me in my decision to ask you to defeat this bill. The people who are behind this kind of insurance came here last year, not the last Legislature. They came here last year, highly represented, and they came to our committee and they wanted the salespeople that you see and go to when you buy a cell phone, and remember, these little cell phones are not all the things now. You have the tablets and all the things they sell in these stores, to sell insurance. They asked us if we could have these salesmen and women, the salespeople, sell insurance without the regular license to sell insurance. We, unfortunately, didn't look at it as carefully as we might have. Otherwise, we would have to find what you're about to find in your search. It came and we passed it. We unanimously, I think, just gave it a go. They are back this year. This is the same group. This makes me angry. They could have done it last year or they could have come back next year. They came back in the same Legislative session. "We would like these people not to be adjusters." These are adjusters that handle your problem when you come in. They would not be under the Bureau of Insurance. They will be under a person who is under the Bureau of Insurance, somebody who has an adjuster's license. Twenty-five of them to each person. That is what we are being asked to do now, to absolve these people of needing to be licensed, prepared properly, or whatever. The reason you are Googling these folks is because they have a terrible record, from what we can see. The one who has the worst record has been bought up by another one who doesn't have a great record. You buy a little cell phone. Recently I checked around. They want \$6, \$7, or \$8 a month. I understand what you will get is, their big selling point, that they will get it to you right away. You need it so much that they'll get it to you. You drop it in the toilet today, they'll get you out of the toilet tomorrow, but you have to pay \$50 more and it'll be reconditioned. It will be a used one that's been made perfect, of course. I just think that we ought to give these people a little more time to get their act together, that makes it look as if they

are doing their job, that the Better Business Bureau's aren't after them all the time, and then maybe, all of you that come back next year, look at this and say, "Ya, maybe or no, they ought to have more oversight." I ask you to vote against this Ought to Pass motion and thank you very much.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Somerset, Senator Whittemore.

Senator **WHITTEMORE:** Thank you Mr. President. Ladies and gentlemen of the Senate, this bill supports business and will allow processing of device claims more efficiently and help reduce costs. Clerical activities do not make decisions in regards to device claims. This will allow people who are in a clerical position to perhaps do some key punching to get the claim ready for those licensed individuals that are going to make the claim process. That's all this bill does. I suggest that you support this bill. It supports business and will make it a lot more efficient in processing cell phone claims. Thank you.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Cumberland, Senator Brannigan.

Senator **BRANNIGAN:** Thank you Mr. President. With this, as I've said, one person will oversee these groups of 25. We believe that that is quite possible that that person will be located out of the country. There is no reason that won't happen, given what is going on here. I think this will be a loss of jobs for people in the United States, even though it's more efficient to send it across the pond or to some other place. Not in the United States. That seems to be, to us, a possibility. Again, I ask you to vote Ought Not to Pass. Thank you, Mr. President.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Cumberland, Senator Dill.

Senator **DILL:** Thank you Mr. President. May I ask a question through the Chair?

THE PRESIDENT PRO TEM: The Senator may pose her question.

Senator **DILL:** Thank you Mr. President. My question is: the proponents of this bill, the businesses, are they the actual phone companies themselves or are they a separate insurance company?

THE PRESIDENT PRO TEM: The Senator from Cumberland, Senator Dill poses a question through the Chair to anyone who may wish to answer. The Chair recognizes the Senator from Cumberland, Senator Brannigan.

Senator **BRANNIGAN:** Thank you Mr. President. I believe they are specialized groups of people that are making money by having you pay \$6, \$7, or a lot more on your phone every month. I believe that is their job. That's their business. Thank you, Mr. President.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Androscoggin, Senator Snowe-Mello.

Senator **SNOWE-MELLO:** Thank you Mr. President. I'd like to address some of these questions that have been brought up. First of all, Asurion is a company which is a leader in the technology protection. It acts as a program administrator for both underwriting and claims. Asurion has 80 million subscribers worldwide, with offices in the United States, England, Canada, and Southeast Asia. When individuals have difficulties with electronic devices they have purchased, they file a claim with Asurion. Claims are adjusted in real time and a replacement device is sent directly to the customer, who receives it often within 24 hours of the claim. Asurion replaces or sends out approximately 25,000 phones per day. If a request is made before 9 p.m. Central Time, the individual will have a phone the next day. Most claims are adjusted within two to three minutes. By large, the only reason claims are not paid is fraud, intentional destruction, or not being insured at the time of the loss. This legislation is narrowly tailored to address the adjusting side of the electronic insurance device legislation which was passed last year. This bill provides that the individuals who are employees of the license adjusting firm collect claim information from claimants and enter the information into an automatic claims adjudication system without needing to be licensed as an adjuster. However, such employees are required to be under the supervision of a licensed individual. This legislation will work to the benefit of consumers by allowing new electronic devices to get into their hands as quickly as possible. It reduces adjusting costs, which in turn avoids additional costs which otherwise would be reflected in the premium. I urge you to pass this legislation. Thank you.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Cumberland, Senator Bartlett.

Senator **BARTLETT:** Thank you Mr. President. I'd like to thank the Senator from Cumberland for suggesting that I do a little research online during the speeches. The first thing that does pop up if you Google cell phone insurance is lots of advice from consumer groups telling you not to buy it. Consumer Reports advises against buying cell phone insurance. Most consumer groups in states around the country advise against it. You have a warrantee when you buy your cell phone, so if anything goes wrong with it that should be covered by that warrantee. By and large, these policies are selling you something to provide nothing. They sign you up for this coverage. It sounds really great. If you ever try to use it, you find out that your problem isn't covered. This is a huge waste of money. It misleads consumers when it is being offered. I would strongly encourage you to oppose this bill and stand up for the consumers of the state of Maine. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Franklin, Senator Saviello.

Senator **SAVIELLO:** Thank you Mr. President. I guess I'm a little confused. First of all, I have to tell you I resemble this remark. Sadly, when I had my truck accident, my phone drowned. Within probably less than 24 hours it was replaced. As I sit here and read the bill, we're not debating whether you should buy this insurance. All we're debating is whether there is a clerical efficiency put in place. I appreciate all the comments. I, too, did go online and did read it. It suggested that, perhaps, I wasted my money when I bought that insurance, but the fact I had the phone within 24 hours tells me it was a good investment. I'm one of

those guys that will probably lose this phone that I have in my pocket in the next year of so. Thank you, Mr. President.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Aroostook, Senator Jackson.

Senator **JACKSON:** Thank you Mr. President. Ladies and gentlemen of the Senate, I would just say to my good friend, Senator Saviello of Franklin, I'd be careful because, if you used it once, I think you can only use one time in a year. Don't lose it for a while because that happened to me.

At the request of Senator **SNOWE-MELLO** of Androscoggin, Reports **READ.**

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Cumberland, Senator Dill.

Senator **DILL:** Thank you Mr. President. Men and women of the Senate, what concerns me about this bill is that it is, by virtue of its arriving here on our desk for consideration, deemed an Emergency. Here we have a company that, according to the research, has made \$3.8 billion in revenue, over \$98 million in profit, using its resources and influence to basically manipulate the legislative process and get ahead of the needs of ordinary Maine people. If you think it's incredibly important, that it is an emergency, that we deregulate these massive companies so that they can make more money, then go ahead and vote for the bill. I'm going to be voting opposed because I feel that it's not an emergency. What's critical is that we do everything we can to protect Maine consumers at a time when every penny makes a difference. Thank you.

THE PRESIDENT PRO TEM: The pending question before the Senate is the motion by the Senator from Somerset, Senator Whittemore to Accept the Majority Ought to Pass as Amended Report. A Roll Call has been ordered. Is the Senate ready for the question?

The Doorkeepers secured the Chamber.

The Secretary opened the vote.
